### **CCCE Listening Session Update**



- Small group discussions intended to inform the development of CCCE Concept Plan.
- Three sessions: San Joaquin Valley (Clovis/Fresno), Inland Empire (Riverside), Coachella Valley (Palm Desert).
- Discussion themes include (1) capacities to support clinical research, (2) workforce education and training needs, and (3) resources to support patient/community outreach, education and engagement.
- 53 participants including: health care providers, elected officials, community-based organizations and patient advocates.



### **CCCE Listening Sessions Selected Themes**



- Clinical sites have partnerships with CIRM-funded academic centers and research experience.
- Providers and patient advocates want to be part of the "CIRM experience."
- CBOs and elected officials emphasize the need to build relationships and trust (relational engagement not transactional or paternalistic).
- Create opportunities for innovative communications using non-traditional messengers (e.g., draw on younger generations in CIRM training programs).



### Roadmap to Access and Affordability



Why are we doing this?

Proposition 14 charges the ICOC, based on recommendations from the AAWG, with developing policies and programs to make treatments and cures arising from CIRM research available and affordable.

The roadmap will include a strategy for gathering data and information to support reimbursement, a plan to engage policymakers and regulators and the development of novel healthcare delivery models through the Alpha Clinics and Community Care Centers of Excellence.



### Proposed Revision of PSP from RFP to RFA



#### Rationale:

- Feasibility and flexibility in awarding and financing Provider Agreements.
- Establish and utilize a review process for AAWG-recommended programs based on existing Grants Working Group model.
- AAWG Review Process in Alignment with Grants Working Group.



### **Proposed Revision to PSP Concept**



#### Minor revisions:

A few additional edits have been included in the concept document that represent the change from RFP to RFA.

- Minor edits to definitional terms.
- Clarity on award amount and duration of funding through the program.
- California operating license, operating location and demonstration of solvency.
- Removal of unnecessary operational information intended for RFA.
