THE OTHER THING, AND IT'S SOMETHING THAT
WE REALLY HAVEN'T DONE BEFORE, AND I'M NOT
SUGGESTING WE NECESSARILY ESTABLISH IT RIGHT HERE
AND NOW, ALTHOUGH IT MIGHT BE GOOD AS WE GO FORWARD,
IS TO THINK ABOUT WHAT IN THE CORPORATE WORLD WE
WOULD CALL A LONG-RANGE PLAN. THAT IS, THE PROPOSED
EXPENDITURE OF MONEY NOT JUST FOR THE NEXT YEAR, BUT
OVER, LET'S SAY, A THREE-YEAR TIME HORIZON LOOKING
FORWARD, SO WE KIND OF HAVE A SENSE OF HOW WE'RE
GOING TO BE SPENDING MONEY.
I RAISE THAT, AGAIN, BECAUSE IT RELATES TO
THESE VARIOUS BUCKETS, I'LL CALL THEM, OF MONEY THAT
ARE TO BE UTILIZED UNDER PROPOSITION 14. SO I JUST
THINK IN TERMS OF FISCAL DISCIPLINE, THERE'S MAYBE A
LITTLE BIT MORE THAT COULD BE ADDED TO WHAT WE HAVE
ON PAPER HERE.
I'M GLAD GEORGE ASKED THE QUESTION THAT HE
ASKED. SO THEN I HAVE A QUESTION THAT BASICALLY
FOLLOWS ON THAT. SO MARIA HAS TEN REPORTS, AS I
UNDERSTAND IT. TEN REPORTS ARE AN AWFUL LOT OF
REPORTS IN MY EXPERIENCE. SIX REPORTS IS A GOOD
NUMBER, AND GOOD BY MEANING KIND OF AT THE TOP,
MAYBE SEVEN AT THE ABSOLUTE. BUT TO HAVE TEN IS A
LOT OF PEOPLE TO MANAGE.
SO I NOTE THAT. I'M NOT SURE THAT SO
