INFRASTRUCTURE







Cell and gene therapy trials are becoming more demanding on patients and require additional support beyond routine costs for patients and their families.

New Patient Assistance Programs have emerged to address bottlenecks associated with gene therapy/gene-edited trials.

The objective is to launch a Patient Support Program (PSP) to provide logistical and financial support to patients seeking to enroll in clinical trials. The overall aim is to improve access and retention in clinical trials with an emphasis on financially-eligible underserved populations.

- 1. Patient Intake and Navigation:** Call center capable of addressing inquiries and referring patients to CIRM-funded programs and clinical sites.
- 2. Assessing Patient/Family Financial Eligibility:** Work with CIRM, sponsors, and clinical trial sites to determine eligibility.
- 3. Facilitate Support Services:** Support patient access to travel, childcare, meals, or other trial-associated expenses. Optimally, without the patient incurring out-of-pocket costs.
- 4. Maintain Accounting Systems:** Maintain systems sufficient to document costs and ensure appropriate use of CIRM funds.

FINANCIAL SUPPORT

- Cover out-of-pocket costs
 - Provide logistical support
 - Expand services based on program evaluation

- How does the CIRM PSP align with norms for patient support and reimbursement?
 - Are there guidelines for the timing of disclosure of patient support programs (e.g. during consent, after enrollment)?
 - Should the level of services available through a PSP be available to all patients in the clinical trial?
 - How important are patient support services for ensuring equity and inclusion in clinical research?
 - Are there critical needs in CGT trials that are not addressed under the current framework?
