**Agenda Item # 5: Chairman's Report.**

Chairman Klein gave a brief report, covering the following:

Today is another historic day for Prop 71, California Institute for Regenerative Medicine, Medical Research funding in the US, and the world, with the pricing today of the \$250 million in California's Stem Cell Research and Cures Bonds. Two related items to note are:

- The Rockefeller Institute study on funding for Stem Cell Research - \$3 billion from other states
- Texas – Governor Perry Seeks \$3 billion for Cancer Stem Cell Research

California finances the entire portfolio of stem cell research – this brings together all of the patient advocacy groups, all of the patient families, and aligns the research agenda with a higher probability of success based upon the broad opportunities available across the portfolio

Recombinant DNA was the last great pioneering breakthrough generated from biomedical research. Dr. Paul Berg, an alternate to this board, received a Nobel Prize for Recombinant DNA, and California was home to the birth of this field's first patient applications of this brilliant area of medical science.

Recombinant DNA is our California legacy and inspiration; stem cell research is California's biomedical future. Millions of lives were saved from Recombinant DNA research and for millions more that are suffering from chronic disease and injury has the potential to be reduced with the hope of lives saved after many years of dedicated work that this organization and the people of California have launched with Prop 71.

There's a special message from our new President, Dr. Alan Trounson, from Australia, expressing his great appreciation for the tremendous communications with and work by the board and the Interim President.

Special thanks from all of us for the tremendous job of Dr. Richard Murphy in preparing the organization for the next level of development and implementation of our mission.

We will hear an announcement as we advance through the program of additions to the scientific staff. The excitement of our program is contagious. There are a number of other scientific hires in progress.
