- 2 DESCRIPTION? IF NOT, WHAT IS OUR PROCESS OF DOING SO?
- 3 ARE WE LOOKING FOR SPACE IN LABS IN GRANT FUNDING
- 4 MANAGEMENT, EXPERTISE IN DRIVING A RESULTS-ORIENTED
- 5 MISSION, EXPERIENCE WITH COLLABORATIONS AMONG ACADEMIA
- 6 AND INDUSTRY OR BETWEEN RECIPIENTS OF A MULTITUDE OF
- 7 FUNDING AGENCIES, CIRM, NIH, PRIVATE SECTOR, ETC? WHERE
- 8 DOES THE PROP 71 REQUIREMENT FOR STRATEGIC PLANNING FIT
- 9 IN?
- 10 NO. 3, I WONDER OF THIS PROCESS ISN'T
- 11 PREMATURE. INPUT TO DATE, FOR EXAMPLE, AT THE IRVINE
- 12 NATIONAL ACADEMY MEETING, SUGGESTS THAT THERE ARE A WIDE
- 13 VARIETY OF APPROACHES WE COULD TAKE THROUGH THE FUNDING
- 14 PROGRAMS FROM HEAVY RELIANCE ON RO1S, ALA NIH, TO A
- 15 MANHATTAN PROJECT, EMPHASIZING OUTCOMES. OUR DECISIONS
- 16 ON THAT APPROACH WOULD INFORM THE SKILL SET WE NEED TO
- 17 ASSIST US.
- 18 ALSO, UNTIL WE HAVE COMPLETED OUR DEVELOPMENT
- 19 OF CONFLICT OF INTEREST AND ETHICS STANDARDS, HOW DO WE
- 20 RESPOND TO CHARGES THAT OUR SEARCH MAY BE TAINTED?
- 21 FINALLY, WE SHOULD BE SURE THAT WE ARE NOT
- 22 PLACING UNDUE RELIANCE ON AN OUTSIDE ENTITY, A SEARCH
- 23 FIRM, FOR EXAMPLE, TO DO OUR JOB FOR US JUST BECAUSE OUR
- 24 OWN PROCESS IS UNWIELDY. WITH A BIT MORE TIME, THE ICOC
- 25 WILL REFINE ITS SYSTEMS FOR DOING BUSINESS. MY

- 1 EXPERIENCE WITH SEARCH FIRMS, INCLUDING SOME BEFORE US
- NOW, IS THAT THE RESULT IS HEAVILY INFLUENCED BY THE
- 3 QUALITY OF THE INPUT.
- 4 I LOOK FORWARD TO THE COMMITTEE RECOMMENDATIONS
- 5 AND HOPE TO PARTICIPATE DIRECTLY NEXT TIME.
- 6 CHAIRMAN KLEIN: OKAY. IN ORDER TO PROVIDE
- 7 SOME INITIAL RESPONSE TO JOAN'S COMMENTS, WE HAVE
- 8 IDENTIFIED EARLIER THAT WE CAN OPEN ANY LOCATION TO THE
- 9 CONFERENCE CALL AS LONG AS THE PARTY ON THE CONFERENCE
- 10 CALL IS GOING TO MAKE THAT SITE A PUBLIC SITE. SO IF
- 11 SOMEONE IS PREPARED TO OPEN THEIR HOME TO THE PUBLIC,
- 12 THAT CAN BECOME A PUBLIC SITE. WE CERTAINLY WOULD LIKE
- 13 TO ACCOMMODATE JOAN. WE WERE NOT AWARE SHE WAS NOT ABLE
- 14 TO ATTEND AT THE SAN FRANCISCO SITE. THE SECOND --
- DR. PIZZO: JUST WHAT IS THE LENGTH OF TIME OR

- 20 DR. PIZZO: THAT'S IMPORTANT. SO THAT MEANS
- 21 THAT AS WE'RE SITTING AT THESE CALLS, SO THAT WHENEVER
- YOU ARE DOING THE REGULAR POSTING, WE NEED TO BE ABLE TO
- 23 POST OURS AS WELL. SO OPERATIONALLY THAT'S GOING TO BE A
- 24 KEY ISSUE, WHICH MEANS THAT WE REALLY NEED TO KNOW IF
- 25 THERE'S A DIFFICULTY BEFORE TEN DAYS IF WE'RE GOING TO BE

- 2 CHAIRMAN KLEIN: THAT'S CORRECT. AND WE HAVE
- 3 TO BE ABLE TO CONFIRM TECHNICAL CAPACITY AT EACH OF THE

- 17 DR. HENDERSON: DOES THIS HAVE TO BE WITHIN THE
- 18 STATE OF CALIFORNIA, I PRESUME?
- 19 CHAIRMAN KLEIN: THAT IS A CORRECT STATEMENT.
- MR. HARRISON: ONE COMMENT ABOUT THAT. THE
- 21 ATTORNEY GENERAL'S OFFICE TAKES THE POSITION THAT AS LONG
- 22 AS THE SITE IS ACCESSIBLE TO THE PUBLIC, A MEMBER COULD
- 23 PARTICIPATE FROM OUT OF STATE AS WELL.
- 24 CHAIRMAN KLEIN: OH, THEY DID. THAT'S A
- 25 CLARIFICATION?

- 1 MR. HARRISON: THAT'S A CLARIFICATION.
- 2 CHAIRMAN KLEIN: OKAY. NOW, ONE OF OUR
- 3 CONSTRAINTS HAS BEEN IN TRYING TO IDENTIFY ADDITIONAL
- 4 SITES IS THIS ISSUE OF THE ATTORNEY GENERAL SAYING WE
- 5 NEEDED TO ACCOMMODATE 50 PERSONS. IS THAT JUST AN
- 6 INITIAL ESTIMATE TO BE CONSERVATIVE, OR IS THAT AN ACTUAL
- 7 RULE?
- 8 MR. HARRISON: I'M NOT AWARE OF A REQUIREMENT
- 9 THAT YOU NEED A CAPACITY FOR 50 PEOPLE. IT DOES HAVE TO
- 10 BE ADA ACCESSIBLE, AND IT DOES HAVE TO BE NOTICED TEN
- 11 DAYS IN ADVANCE. AND THE CONCEPT IS THAT WE'RE TRYING TO
- 12 PROVIDE FACILITIES THAT CAN ACCOMMODATE THE PUBLIC
- 13 DEPENDING ON THE LEVEL OF INTEREST. SO FOR THE INITIAL
- 14 TELECONFERENCE MEETINGS, WE THOUGHT IT WOULD BE PRUDENT
- 15 TO HAVE THEM ALL CONVENE IN VERY EASILY ACCESSIBLE PUBLIC
- 16 BUILDINGS IN ORDER TO ACCOMMODATE THE PUBLIC.
- 17 CHAIRMAN KLEIN: ALL RIGHT. SO THAT IS VERY
- 18 HELPFUL, AND PLEASE REALIZE AS WELL THAT WE NEED EACH
- 19 SITE TO BE A SITE WHERE WE CAN OVERNIGHT MATERIALS TO
- 20 MAKE CERTAIN WE HAVE MATERIALS FOR THE PUBLIC PRESENT AT
- 21 EACH SITE. SO LOGISTICS ARE IMPORTANT, AND IT'S
- 22 IMPORTANT TO HAVE SUFFICIENT NOTICE.
- TO ANSWER ONE OF JOAN'S QUESTIONS, THE BOARD IS
- 24 LOOKING AT EXECUTIVE SEARCH PROPOSALS THAT DO CALL OUT
- 25 FOR THE EXECUTIVE SEARCH FIRMS TO PARTICIPATE IN HELPING

- 1 US CONFIRM THE JOB DESCRIPTIONS AND THE CRITERIA. AND
- 2 AFTER DISCUSSION OF THE SEARCH FIRMS THEMSELVES, BEFORE
- 3 WE GO INTO EXECUTIVE SESSION, IT WAS MY INTENT TO DISCUSS
- 4 A PROCESS FOR INTEGRATING THE PRESIDENTIAL SEARCH
- 5 COMMITTEE IN THE SELECTION PROCESS SO THAT THE SEARCH
- 6 COMMITTEE IS AN INTEGRAL PART OF THE JOB DESCRIPTION
- 7 APPROVALS AND THE CRITERIA THAT ARE GOING TO DRIVE THE
- 8 LOCATION AND IDENTIFICATION OF THIS INDIVIDUAL.
- 9 MS. LANSING: BOB, CAN I JUST BEFORE -- THIS IS
- 10 SHERRY LANSING AGAIN. JUST FOR THE PUBLIC RECORD, JUST
- 11 BECAUSE I KNOW THIS, JUST STATE THAT I THINK THIS IS
- 12 GREAT, THAT WE'RE MAKING THIS ACCOMMODATION IN THE
- 13 TELECONFERENCE CALLS. AND I ALSO THINK IT'S GREAT THAT
- 14 WE'RE MAKING IT IN THE ICOC MEETING, BUT I ALSO WANT TO
- 15 JUST ADD A CAVEAT, THAT I DON'T THINK WE SHOULD TAKE, YOU
- 16 KNOW, TAKE THAT LIGHTLY. BY THAT I MEAN WE SHOULD ALL
- 17 MAKE EVERY POSSIBLE EFFORT TO GET TO THE ICOC MEETINGS
- 18 BECAUSE IF EVERYBODY TAKES THIS AS A KIND OF RULE, THAT
- 19 THEY CAN CALL FROM THEIR HOUSE OR THEY CAN CALL FROM
- THEIR OFFICE, WE WON'T HAVE THE INTERACTION IN PERSON
- 21 THAT I THINK WILL PRODUCE THE BEST DECISIONS. SO I THINK
- 22 WE SHOULD NOT AS A RULE, BUT JUST AS A BEST PRACTICE SAY
- 23 THAT ONLY WHEN IT'S IMPOSSIBLE TO ATTEND THE ICOC
- 24 MEETINGS WILL WE RESORT TO THIS, YOU KNOW, OPPORTUNITY
- 25 THAT'S OPEN TO US TO PARTICIPATE.

- DR. PIZZO: I AGREE WITH, SHERRY. JUST ONE
- 2 MAYBE FRIENDLY MODIFIER. I THINK THAT IT'S ABSOLUTELY --
- 3 THIS IS PHIL PIZZO SPEAKING -- FOR THE ICOC MEETINGS PER
- 4 SE. I THINK FOR THE CONFERENCE CALLS, A SLIGHT
- 5 MODIFICATION OF THAT MAY BE APPROPRIATE JUST BECAUSE OF
- 6 THE CHALLENGE.
- 7 MS. LANSING: I AGREE WITH THAT FOR THE
- 8 CONFERENCE CALLS. I TOTALLY AGREE. I'M JUST TALKING
- 9 ABOUT FOR THE ICOC MEETINGS.
- 10 DR. HENDERSON: BRIAN HENDERSON HERE. I THINK
- 11 WE OUGHT TO FURTHER, YOU KNOW, SORT OF MAKE SURE THAT WE
- 12 ALWAYS HAVE A PHYSICAL QUORUM PRESENT AT ANY OF THE OPEN
- 13 MEETINGS AND SO THAT THIS CAN NEVER HAPPEN THAT TOO MANY
- 14 OF US ARE BY PHONE TO PARTICIPATE. I THINK THAT WOULD BE
- 15 NOT A GOOD IDEA.
- 16 CHAIRMAN KLEIN: OKAY. POINTS WELL TAKEN. I
- 17 WOULD LIKE TO ANNOUNCE THAT PHYLLIS PRECIADO HAS JOINED
- 18 THE STANFORD SITE. THANK HER FOR MAKING THIS SIGNIFICANT
- 19 TRIP FROM FRESNO. AND I BELIEVE THAT WE ARE NOW ON-LINE
- 20 WITH UC SAN FRANCISCO; IS THAT CORRECT?
- DR. KESSLER: THAT'S CORRECT.
- 22 CHAIRMAN KLEIN: WHO IS PRESENT AT UC SAN
- 23 FRANCISCO?

- 13 COMMITTEE KNOW, WE HAVE RECEIVED FIVE PROPOSALS FROM
- 14 EXECUTIVE SEARCH FIRMS THAT HAVE BEEN DISTRIBUTED TO
- 15 BOARD MEMBERS, AND THEY HAVE BEEN MADE AVAILABLE TO THE
- 16 PUBLIC ON THE WEBSITE AND AT EACH OF OUR CONFERENCE
- 17 SITES.
- 18 IN ADDITION TO POSTING ON OUR WEBSITE, WE SENT
- 19 THIS REQUEST FOR PROPOSALS TO APPROXIMATELY 20 DIFFERENT
- 20 FIRMS TO ENSURE WE WOULD HAVE A RANGE OF PROPOSALS. THE
- 21 FIVE FOLLOWING SEARCH FIRMS ARE REPRESENTED: A. T.
- 22 KEARNEY, SPENCER STUART, ISAACSON, MILLER, KINCANNON &
- 23 REED, AND CALIBER ASSOCIATES.
- I'D LIKE TO OPEN DISCUSSION AMONG THE MEMBERS
- 25 OF THE COMMITTEE ABOUT THE SEARCH FIRM PROPOSALS. COULD

- 1 THE COMMITTEE MEMBERS ADDRESS AT LEAST THE FOLLOWING
- 2 ISSUES ON THE APPLICATIONS, ALTHOUGH NOT NECESSARILY ON
- 3 EACH APPLICATION: RELEVANT EXPERIENCE, THE FIRM'S
- 4 UNDERSTANDING OF THE TASK AT HAND, THE TIMETABLE, AND THE
- 5 PRICING STRUCTURE, ALONG WITH ANY OTHER RELEVANT CONTRACT
- 6 PROVISIONS THEY WOULD LIKE TO HIGHLIGHT.
- 7 I WOULD LIKE TO ALSO INDICATE THAT FOR PUBLIC
- 8 COMMENT, WHEN WE GET TO PUBLIC COMMENT ON THIS ITEM, AS
- 9 WELL AS OTHER ITEMS ON THE AGENDA, IT WILL BE LIMITED TO
- 10 THREE MINUTES FOR EACH MEMBER OF THE PUBLIC.
- 11 AS I SAID A LITTLE EARLIER, WHEN WE ADDRESS
- 12 THE -- AFTER WE'VE ADDRESSED THE SEARCH FIRMS, I WOULD
- 13 LIKE TO TALK ABOUT A TIMETABLE AND A PROCESS. AS AN
- 14 INDEPENDENT SUBPART OF THIS DISCUSSION, THIS PORTION WILL
- 15 COME AFTER SELECTING THE EXECUTIVE SEARCH FIRM, BUT AS A
- 16 PART OF THE PUBLIC MEETING. AND THAT PROCESS WILL
- 17 DISCUSS A CONCEPT OR A PLAN UNDER WHICH THE PRESIDENTIAL
- 18 SEARCH COMMITTEE COULD BE INTEGRATED INTO THE TIME PATH
- 19 LAID OUT IN THE EXECUTIVE SEARCH FIRM PROPOSALS BECAUSE

- 21 COMMITTEE. AND IT IS VERY IMPORTANT THAT THAT EXPERTISE
- 22 BE EMPLOYED IN A DIRECT INVOLVEMENT IN THE SEARCH FOR THE
- 23 PRESIDENT.
- I'D LIKE TO OPEN FOR COMMENTS FROM THE BOARD,
- 25 AND I'D LIKE TO START BY ASKING ARE THERE COMMENTS FROM

- 1 THE BOARD MEMBERS AT THE BURNHAM INSTITUTE?
- DR. NOVA: YES. THIS IS TINA NOVA AT THE
- 3 BURNHAM IN SAN DIEGO. I DO APPRECIATE THE FACT THAT WE
- 4 ARE ASKING THE SEARCH FIRMS TO HELP US WITH THE
- 5 DEFINITION AND THE JOB DESCRIPTION FOR THIS POSITION. MY
- 6 ONLY PROBLEM, BOB, IS THAT SOME OF THESE SEARCH FIRMS ARE
- 7 VERY FOCUSED IN AN ACADEMIC SEARCH; FOR EXAMPLE, A
- 8 PRESIDENT OF A UNIVERSITY, WHERE OTHER SEARCH FIRMS HAVE
- 9 DONE MORE LIKE BIOTECH AND PHARMACEUTICAL EXECUTIVES. A
- 10 FEW OF THE SEARCH FIRMS KIND OF CROSS OVER.
- I GUESS WITHOUT -- I JUST DON'T HAVE A REALLY
- 12 GOOD HANDLE RIGHT NOW ON THE TYPE OF PERSON WE'RE
- 13 THINKING ABOUT. AND SO THAT'S WHY I'M HAVING A LITTLE
- 14 PROBLEM IN SORT OF COMING UP WITH SAYING THAT ONE SEARCH
- 15 FIRM MAY BE BETTER THAN ANOTHER. DO WE HAVE A LITTLE BIT
- 16 MORE DEFINITION ON WHAT WE THINK THIS PERSON SHOULD LOOK
- 17 LIKE?
- 18 CHAIRMAN KLEIN: WE DO. AND LET ME DO THIS.
- 19 LET ME PULL OUT A COPY OF THE RELEVANT SECTIONS OF THE
- 20 INITIATIVE, THE JOB DESCRIPTION, AND JUST READ THAT FOR
- THE BENEFIT OF THE PUBLIC AS WELL.
- DR. NOVA: THAT WOULD BE VERY HELPFUL. THANK
- 23 YOU.
- 24 CHAIRMAN KLEIN: OKAY. THE PRESIDENT'S PRIMARY
- 25 RESPONSIBILITIES ARE TO SERVE AS THE CHIEF EXECUTIVE OF

- 1 THE INSTITUTE, TO RECRUIT THE HIGHEST SCIENTIFIC AND
- 2 MEDICAL TALENT IN THE UNITED STATES TO SERVE THE
- 3 INSTITUTE ON ITS WORKING GROUPS. THE PRESIDENT IS A
- 4 MEMBER OF EACH OF THE WORKING GROUPS. TO DIRECT THE
- 5 INSTITUTE STAFF AND PARTICIPATE IN THE PROCESS OF
- 6 SUPPORTING ALL WORKING GROUP REQUIREMENTS, TO DEVELOP
- 7 RECOMMENDATIONS ON GRANTS, LOANS, FACILITIES, AND
- 8 STANDARDS, AS WELL AS TO DIRECT AND SUPPORT THE ICOC
- 9 PROCESS OF EVALUATING AND ACTING ON THOSE
- 10 RECOMMENDATIONS. THE IMPLEMENTATION OF ALL DECISIONS ON
- 11 THESE AND GENERAL MATTERS OF THE ICOC, TO HIRE, DIRECT,
- AND MANAGE STAFF OF THE INSTITUTE, TO DEVELOP THE BUDGETS
- AND COST CONTROL PROGRAMS OF THE INSTITUTE, TO MANAGE
- 14 COMPLIANCE WITH ALL RULES AND REGULATIONS OF THE ICOC,
- 15 INCLUDING THE PERFORMANCE OF ALL GRANT RECIPIENTS, AND TO
- 16 MANAGE AND EXECUTE ALL INTELLECTUAL PROPERTY AGREEMENTS
- 17 AND ALL OTHER CONTRACTS PERTAINING TO RESEARCH.
- 18 SO VERY BROADLY STATED, THE PRESIDENT IS THE
- 19 CHIEF SCIENTIFIC OFFICER OF THE INSTITUTE AND THE CHIEF
- 20 OPERATING OFFICER OF THE INSTITUTE. SO IN ORDER TO
- 21 RECEIVE THE HIGHEST SCIENTIFIC AND MEDICAL TALENT, WE
- WOULD EXPECT SOMEONE TO BE HIGHLY ESTEEMED AMONG THEIR
- 23 PEERS IN THE SCIENTIFIC AND/OR PHYSICIAN SCIENTIFIC
- 24 FIELDS, AND WE WOULD EXPECT SOMEONE TO HAVE AN
- 25 OUTSTANDING RECORD OF MANAGEMENT OF A MAJOR INSTITUTIONAL

- 1 CAPACITY.
- DR. PIZZO: BOB, COULD I ASK ONE SORT OF
- 3 QUALIFICATION OF THAT? THIS IS PHIL PIZZO SPEAKING. YOU
- 4 USE THE TERM "CHIEF OPERATING OFFICER." I CERTAINLY
- 5 UNDERSTAND THAT IT'S THE CHIEF SCIENTIFIC OFFICER. IT'S
- 6 NOT THE APPROPRIATE (UNINTELLIGIBLE), THOUGH, THE
- 7 EQUIVALENT OF CHIEF EXECUTIVE OFFICER IN THAT REALLY THIS
- 8 INDIVIDUAL IS GOING TO OVERSEE IMPLEMENTING THE
- 9 OPERATION. IT'S A NUANCE, BUT I THINK IT HAS SOME
- 10 IMPLICATIONS FOR THE KIND OF PERSON WE WOULD ATTRACT.
- 11 CHAIRMAN KLEIN: THAT'S A CORRECT STATEMENT,
- 12 AND ONE WOULD ASSUME THERE WOULD BE A COO OR A CHIEF
- 13 OPERATING OFFICER ACTUALLY UNDER IT, BUT THE REAL
- 14 RESPONSIBILITY FOR THOSE OPERATIONS LIES WITH THE
- 15 PRESIDENT. SO IN A SUPERVISORY CAPACITY. IS THAT
- 16 HELPFUL, TINA?
- DR. NOVA: VERY MUCH SO. THANK YOU VERY MUCH,
- 18 BOB.
- 19 CHAIRMAN KLEIN: OKAY.
- DR. MURPHY: BOB, RICH MURPHY AT THE BURNHAM.
- 21 COULD YOU ALSO DESCRIBE FOR US HOW YOU SEE YOUR WORKING
- 22 RELATIONSHIP WITH THE PRESIDENT HOW HANDS-ON WILL YOU BE
- 23 AND DR. PENHOET BE? AND HOW DO YOU SEE YOURSELF WORKING
- 24 WITH THE PRESIDENT ON A DAILY BASIS?
- 25 CHAIRMAN KLEIN: ALL RIGHT. IN SUMMARY FORM,

- 1 IF ONE WERE TO LOOK AT THE CHAIRMAN'S JOB AS VERSUS THE
- 2 PRESIDENT'S JOB, THE CHAIRMAN IS RESPONSIBLE FOR EXTERNAL
- 3 RELATIONS AND THE SUPPORTING ROLE SO THAT THE PRESIDENT
- 4 AND THE INSTITUTE CAN CARRY OUT THEIR SCIENTIFIC MISSION.
- 5 THE EXTERNAL RELATIONS ARE GOVERNMENTAL IN
- 6 PART, DEALING WITH THE CONGRESS, WHICH HAS LEGISLATION
- 7 WHICH WOULD BE VERY DIFFICULT. THE WELDON BROWNBACK
- 8 BILLS THAT HAVE PASSED THE HOUSE IN 2002 AND 2003, FOR
- 9 EXAMPLE, THAT COULD BAN CERTAIN TYPES OF EMBRYONIC STEM
- 10 CELL RESEARCH, DEALING WITH THE STATE LEGISLATURE,
- 11 DEALING WITH THE STATE EXECUTIVE OFFICERS, THE GOVERNOR,
- 12 TREASURER, CONTROLLER, ATTORNEY GENERAL'S OFFICE.
- 13 THE CHAIRMAN HAS A SPECIFIC RESPONSIBILITY
- 14 UNDER THE INITIATIVE TO SIT ON THE FINANCE COMMITTEE.
- 15 THE FINANCE COMMITTEE INVOLVES THE STATE'S FINANCIAL
- 16 OFFICERS AND MEMBERS OF THIS BOARD TO MANAGE THE FUNDING
- 17 OF THE INITIATIVE'S WORK.
- 18 THE CHAIRMAN ALSO SERVES ON THE OVERSIGHT
- 19 COMMITTEE AND/OR HAS A PUBLIC APPOINTMENT ON THE
- 20 OVERSIGHT COMMITTEE TO DEAL WITH PERFORMANCE REVIEWS WITH
- THE PUBLIC, TO MONITOR TRANSPARENCY, ACCOUNTABILITY, AND
- 22 PERFORMANCE OF THIS INSTITUTE.
- THE CHAIRMAN ALSO HAS SPECIFIC RESPONSIBILITY
- 24 TO LEAD THE INTELLECTUAL PROPERTY NEGOTIATIONS, ALTHOUGH
- 25 THAT IS CLEARLY A VERY CLOSE TEAM RELATIONSHIP WITH THE

- 1 PRESIDENT AND THE BOARD MEMBERS BECAUSE OF THE IMPORTANCE
- 2 OF THOSE AREAS TO THE STATE. BUT IN ALL CASES, EVEN
- 3 THOUGH THE PRESIDENT IS DEALING WITH THE SCIENTIFIC
- 4 OPERATION, THE CHAIRMAN IS DEALING WITH THE EXTERNAL
- 5 OPERATIONS, THE CHAIRMAN IS TO MANAGE THE WORK FLOW WITH
- 6 THE BOARD, AND NEEDS TO HAVE A VERY INTEGRATED STYLE
- 7 SUPPORTING THE PRESIDENT. AND THERE HAS TO BE AN ONGOING
- 8 COMMUNICATION ON A CONSTANT BASIS.
- 9 IT'S BEEN CONTEMPLATED THAT STRUCTURALLY THAT
- 10 THERE WOULD BE AN EXECUTIVE COUNCIL THAT WOULD INCLUDE
- 11 THE CHAIRMAN, FOR EXAMPLE, THE GENERAL COUNSEL, THE CHIEF
- 12 FINANCIAL OFFICER, THE HEAD OF COMMUNICATION, THE
- 13 PRESIDENT, HIS CHIEF SCIENTIFIC OFFICER, HIS CHIEF
- 14 OPERATING OFFICER, AND REPRESENTATIVES FROM THE THREE
- 15 WORKING GROUPS' STAFF THAT WOULD WEEKLY MEET AND
- 16 COORDINATE THOSE ACTIVITIES.
- 17 I THINK THAT WOULD BE A REASONABLE SUMMARY OF
- 18 THE RELATIONSHIP.
- 19 UNIDENTIFIED SPEAKER: WHO DOES THE PRESIDENT
- 20 REPORT TO?
- 21 CHAIRMAN KLEIN: THE PRESIDENT REPORTS TO THE
- BOARD.
- 23 DR. PIZZO: SO IS A SIMPLE WAY OF THINKING
- 24 ABOUT THIS, AT LEAST THE WAY I'VE BEEN THINKING ABOUT
- 25 THIS IS THAT AS OTHER ORGANIZATIONS FUNCTION, THE ICOC IS

- 1 WORKING AS A BOARD OF PRESTIGE OR DIRECTORS, CHAIRMAN OF
- THE BOARD IS THE CHAIRMAN OF THAT ORGANIZATION, WHICH
- 3 REALLY IS THE FIDUCIARY FOR OVERSIGHT FOR THE OPERATION;
- 4 WHEREAS, THE CEO/PRESIDENT IS FUNCTIONING AS THE CHIEF
- 5 EXECUTIVE OFFICER OVER THE OPERATIONS AND THE STAFF THAT
- 6 GOVERN THE OPERATIONS FOR THE INSTITUTE ITSELF.
- 7 CHAIRMAN KLEIN: I THINK THAT'S A GOOD SUMMARY.
- 8 DR. KESSLER: I DON'T KNOW WHETHER WE'RE GOING
- 9 BY SITES. I'LL STOP. BUT JUST TO ASK PHIL A QUESTION,
- 10 WHAT'S THE THOUGHT ABOUT THE SCIENTIFIC STRUCTURE VERSUS
- 11 THE ADMINISTRATIVE STRUCTURE? THIS IS DAVID KESSLER.
- 12 CHAIRMAN KLEIN: DAVID, LET ME RESPOND TO THAT
- 13 WITH A FORWARD. AND THE FORWARD IS THAT IN THE --
- 14 PERHAPS I SHOULD ADDRESS AT THIS POINT, RATHER THAN
- 15 LATER, SOME OF THE THOUGHTS ABOUT INTEGRATING THE SEARCH
- 16 COMMITTEE IN THE PROCESS OF THE PRESIDENTIAL SEARCH
- 17 COMMITTEE BECAUSE THE INTEGRATION OF THE SEARCH COMMITTEE
- 18 IN THAT PROCESS IS, IN FACT, FOR PROVIDING DEFINITION TO
- 19 PARTS OF THIS RELATIONSHIP.
- 20 AND IN VERY SHORT FORM, WHAT I WAS GOING TO
- 21 SUGGEST LATER, BUT MAYBE COULD ADVANCE THESE THOUGHTS AT
- 22 THIS POINT, AT LEAST TO GIVE IT TO YOU CONCEPTUALLY, WHEN
- THE SEARCH COMMITTEE COMES BACK WITH ITS LONG LIST, ITS
- JOB DESCRIPTION, AND ITS CRITERIA FOR THE PRESIDENT, IT
- 25 WAS MY INTENT TO SUGGEST THAT OUR PRESIDENTIAL SEARCH

- 1 COMMITTEE HAVE AGAIN ANOTHER CONFERENCE CALL MEETING TO
- 2 GO OVER THOSE CRITERIA, TO GO OVER THE JOB DESCRIPTION,
- 3 TO GO OVER THINGS LIKE THE SCIENTIFIC DEFINITION THAT
- 4 THEY WERE LOOKING FOR IN THIS STRUCTURE, AND HOW THE
- 5 SCIENTIFIC FUNCTIONS MIGHT BE ORGANIZED.
- 6 SECONDLY, WHEN THE SEARCH FIRM CAME BACK WITH
- 7 ITS SHORT LIST, HAVING AN ADDITIONAL PRESIDENTIAL SEARCH
- 8 COMMITTEE MEETING THAT WOULD GO OVER THE SHORT LIST, HOW
- 9 THE SHORT LIST CANDIDATES REFLECTED THE CRITERIA IN THE
- 10 JOB DESCRIPTIONS PREVIOUSLY TO SEE IF THERE'S ANY
- 11 ADDITIONAL REFINEMENTS TO BE MADE IN THE STRUCTURES AND
- 12 RELATIONSHIPS, AND AT THAT POINT ASK THAT THE
- 13 PRESIDENTIAL SEARCH COMMITTEE FORM TWO-MEMBER INTERVIEW
- 14 TEAMS. IT'S IMPORTANT THEY BE TWO-MEMBER INTERVIEW TEAMS
- 15 BECAUSE OF THE FACT THAT IF THERE ARE THREE MEMBERS, THEN
- 16 THEY INTERVIEW WITH THE CANDIDATE AND IT CANNOT BE
- 17 CONFIDENTIAL. AND IT'S IMPORTANT TO THE CONFIDENTIALITY
- 18 FOR SOME OF THESE MEMBERS TO EVEN BE CANDIDATES FOR THIS
- 19 POSITION.
- 20 IT WOULD THEN GO TO AN EXECUTIVE COMMITTEE OF
- THE BOARD AFTER THE TOP CANDIDATES HAD GONE THROUGH THE
- 22 TWO-MEMBER INTERVIEWS. AND THE FULL BOARD OF THE ICOC
- 23 WOULD RANK THAT PRIORITY. FOLLOWING THAT RANKING, IT WAS
- 24 MY HOPE THAT THE PRESIDENTIAL SEARCH COMMITTEE COULD
- 25 ASSEMBLE ACTUALLY IN PERSON TO DO AN IN-PERSON GROUP

- 1 INTERVIEW OF THE FIRST AND SECOND TOP RANKED CANDIDATES
- 2 WITH AN AUTHORITY FROM THE BOARD TO MAKE OFFERS BASED
- 3 UPON THOSE CANDIDATES IF THE BOARD FOUND THE ORIGINAL
- 4 SHORT LIST ACCEPTABLE. THE BOARD OBVIOUSLY COULD CHANGE
- 5 THE CRITERIA, OR IT COULD ASK FOR MORE CANDIDATES, BUT
- 6 THAT WOULD BE A GENERAL PLAN.
- 7 THROUGH THIS PROCESS, DR. KESSLER, THERE ARE
- 8 MEMBERS OF THIS SEARCH COMMITTEE, LIKE YOURSELF, WHO HAVE
- 9 TREMENDOUS SCIENTIFIC EXPERTISE, WHO WE WOULD HOPE THE
- 10 SEARCH COMMITTEE WOULD DRAW UPON FOR INFORMATION AND
- 11 INPUT TO REFINE THE SCIENTIFIC ROLE.
- DR. KESSLER: BOB, YOU JUST MENTIONED AN
- 13 EXECUTIVE COMMITTEE. I MAY HAVE MISSED SOMETHING AT THE
- 14 BOARD. IS THERE AN EXECUTIVE COMMITTEE OF THE BOARD?
- 15 CHAIRMAN KLEIN: I SHOULD HAVE CALLED IT THE
- 16 PRESIDENTIAL SEARCH COMMITTEE.
- 17 DR. KESSLER: I'M SORRY. THANK YOU. I GUESS
- 18 WHERE I WAS HEADING WAS THE QUESTION OF HOW WE THINK
- 19 ABOUT THE SKILLS NECESSARY FOR THE CEO, WHO, IN ESSENCE,
- 20 HAS TO HAVE THE STATURE, CREDIBILITY OF THE SCIENTIST, OR
- 21 IS THAT THE MODEL THAT WE'RE LOOKING FOR, OR ARE WE
- 22 WILLING TO GO TO SOMEONE (INAUDIBLE) BUT ALSO RELY ON
- 23 SCIENTISTS?
- 24 CHAIRMAN KLEIN: I BELIEVE IN ORDER TO ANSWER
- THAT QUESTION, ARE THERE ANY MEMBERS FROM USC, UCLA, OR

- 1 UC BERKELEY THAT WOULD LIKE TO COMMENT ON THE QUESTION
- 2 JUST ASKED?
- 3 MS. LANSING: I WOULD. THIS IS SHERRY LANSING.
- 4 I THINK THAT WHEN YOU READ THE JOB DESCRIPTION, IT WAS
- 5 ACTUALLY I THINK, TO ME AT LEAST, RATHER CLEAR. I THINK
- 6 THE GREATEST THING THAT THE POTENTIAL CANDIDATE NEEDS IS
- 7 THE RESPECT OF THE SCIENTIFIC COMMUNITY. I THINK THAT IS
- 8 THE FOREMOST THING THAT THE PRESIDENT NEEDS. AND WE'RE
- 9 REALLY LOOKING TO HIM TO MANAGE THE SCIENCE.
- 10 BUT THE SECOND SKILL THAT, AND I DON'T THINK
- 11 THAT THESE ARE IMPOSSIBLE SKILLS TO FIND IN A PERSON, I
- 12 THINK THE SECOND SKILL THAT HE OR SHE NEEDS IS MANAGERIAL
- 13 QUALITIES BECAUSE YOU'RE GOING TO BE RUNNING AN
- 14 INSTITUTE. BUT, YOU KNOW, MY -- SO I WOULD SAY THAT THE
- 15 RESPECT OF THE SCIENTIFIC COMMUNITY, WHICH I WOULD HAVE
- 16 TO TURN TO THE SCIENTISTS ON THE ICOC TO VERIFY THAT THE
- 17 CANDIDATE HAD IT, AND THEN WE WOULD HAVE TO SEE -- MAKE
- 18 SURE THAT THE PERSON KNEW HOW TO MANAGE AN INSTITUTE.
- 19 I DO NOT THINK THAT THESE TWO TALENTS ARE
- 20 MUTUALLY EXCLUSIVE. I THINK THAT WE WILL BE ABLE TO FIND
- 21 A CANDIDATE WHO HAS BOTH OF THEM. AND I GUESS MY NAIVE
- FEELING, AND I HOPE I'M PROVEN RIGHT, IS THAT WE'RE GOING
- TO HAVE SOME VERY, VERY, VERY GOOD CANDIDATES TO CHOOSE
- 24 FROM BECAUSE I BELIEVE THAT THIS IS THE CUTTING EDGE OF
- 25 SCIENCE. AND I BELIEVE THAT WE'RE GOING TO HAVE AN

- 1 ABUNDANCE OF QUALITY PEOPLE TO CHOOSE FROM. AND SO I'M
- 2 RATHER OPTIMISTIC THAT WE'RE GOING TO HAVE SOME VERY HIGH
- 3 CLASS CHOICES AMONG THE LIST.
- 4 AND MY ONLY AMENDMENT WOULD BE TO WHAT YOU
- 5 SAID, BOB, IS PERHAPS IN PERSON WE'LL MEET MORE THAN TWO
- 6 PEOPLE. WE MAY MEET THREE PEOPLE OR FOUR PEOPLE,
- 7 DEPENDING ON WHAT OUR CHOICES ARE. AND I THINK WE SHOULD
- 8 BE OPEN TO THAT.
- 9 DR. HENDERSON: SHERRY, BRIAN HENDERSON HERE,
- 10 AT USC. I THINK SHERRY PUT IT VERY WELL, AND I SECOND
- 11 HER DESCRIPTION OF THE KIND OF PERSON WE'RE LOOKING FOR.
- 12 CHAIRMAN KLEIN: I BELIEVE DR. PIZZO HAS A
- 13 COMMENT AS WELL.
- 14 DR. PIZZO: IT'S EASY BECAUSE I THINK SHERRY
- 15 CAPSULIZED IT ENORMOUSLY WELL. I WOULD JUST ADD MY
- 16 UNDERSTANDING FROM THE VERY ONSET WAS THAT WE WERE, IN
- 17 FACT, LOOKING FOR SOMEONE WITH STRONG SCIENTIFIC AND
- 18 MANAGERIAL CREDENTIALS. AND I CONCUR, SHERRY, THAT THERE
- 19 WILL BE, HOPEFULLY, LOTS OF PEOPLE LIKE THAT. I'D LIKE
- 20 TO THINK THAT THOSE OF US WHO ARE RUNNING MEDICAL SCHOOLS
- OR OTHER RESEARCH INSTITUTES HAVE SIMILAR EXPERIENCE TO
- 22 KNOW THAT THOSE KINDS OF CREDENTIALS EXIST. AND YOU
- 23 STATED EXTREMELY WELL. THIS HAS TO BE ONE OF THE MOST
- 24 ATTRACTIVE AND EXCITING OPPORTUNITIES FOR AN INDIVIDUAL
- 25 TO ASPIRE TO. SO I HOPE WE CAN REACH FOR THE STARS AND

- 1 FIND A REALLY WONDERFUL PERSON.
- CHAIRMAN KLEIN: SHERRY, THIS IS BOB KLEIN. I
- 3 THINK YOUR COMMENT ON THE FACT THAT THE SEARCH COMMITTEE
- 4 MAY ELECT TO INTERVIEW IN PERSON AS A COMMITTEE OF THE
- 5 WHOLE THREE OR FOUR PEOPLE IS ABSOLUTELY APPROPRIATE.
- 6 IT'S JUST DEPENDING ON THE CANDIDATE AND WHERE THE
- 7 COMMITTEE FINDS THERE'S A SIGNIFICANT DIFFERENTIATING
- 8 POINT IN THE TOP-TIER LIST.
- 9 MS. LANSING: I AGREE.
- 10 DR. BIRGENEAU: BOB, THIS IS BOB BIRGENEAU AT
- 11 BERKELEY. I AGREE WITH EVERYTHING THAT'S BEEN SAID. I
- 12 WOULD ADD, HOWEVER, WHEN I THINK ABOUT THE KINDS OF
- 13 PEOPLE WE WILL BE LOOKING FOR, SHE WILL CERTAINLY HAVE
- 14 THE CHARACTERISTICS THAT SHERRY DESCRIBED; BUT IN
- 15 ADDITION, I THINK THIS PERSON IS GOING TO HAVE TO HAVE A
- 16 LEVEL OF POLITICAL SOPHISTICATION WHICH IS NOT
- 17 NECESSARILY IN ABUNDANCE AMONG SCIENTISTS. BECAUSE JUST
- 18 IN TALKING TO PEOPLE WHO ARE ACTUALLY ACTIVE IN THIS
- 19 FIELD, BECAUSE OF OBVIOUS ISSUES, BOTH STATEWIDE AND WITH
- 20 RESPECT TO THE FEDERAL GOVERNMENT, YOU KNOW, THIS IS
- 21 EXTRAORDINARILY COMPLICATED. AND I THINK WE WILL, YOU
- 22 KNOW, HOPEFULLY FIND SOMEONE WHO HAS ALSO DEMONSTRATED
- 23 EXPERTISE IN GOVERNMENT RELATIONS AND THE ABILITY TO
- 24 MANAGE IN COMPLICATED POLITICAL SITUATIONS.
- MS. LANSING: BOB, THIS IS SHERRY AGAIN. I

- 1 UNDERSTAND WHAT YOU'RE SAYING, AND I RESPECT THE THOUGHT
- OF IT. BUT IF WE HAD TO SACRIFICE ANY QUALITY, I THINK
- 3 THAT'S THE QUALITY WE CAN SACRIFICE BECAUSE I THINK THERE
- 4 ARE MEMBERS OF THE ICOC, THE CHAIRMAN, THE VICE CHAIRMAN
- 5 OF THE ICOC IN PARTICULAR, WHO HAVE DEMONSTRATED THOSE
- 6 SKILLS, AND I THINK MEMBERS OF THE BOARD CAN ALSO BE
- 7 HELPFUL. AND, YOU KNOW, WE MAY NOT -- IT WOULD BE
- 8 WONDERFUL IF THAT PERSON HAD ALL THREE, BUT I WOULD PUT
- 9 THE FIRST TWO WAY ON TOP AND THINK THAT THE POLITICAL
- 10 THINGS THAT WE HAVE TO DO CAN BE DONE BY OUR COMMITTEE,
- 11 SO TO SPEAK.
- 12 CHAIRMAN KLEIN: DR. PRECIADO HAS A COMMENT.
- DR. PRECIADO: SHERRY, I JUST WANT TO ECHO WHAT
- 14 YOU'RE SAYING. I THINK WE HAVE TO REMEMBER THAT WE'RE
- 15 NOT WORKING IN ISOLATION, BUT RATHER WE'RE WORKING AS A
- 16 TEAM REALLY WITH OUR VARYING STRENGTHS AND BACKGROUNDS TO
- 17 SORT OF PUT TOGETHER THIS INSTITUTE. IT'S IMPORTANT NOT
- 18 TO EXPECT THAT THE PRESIDENT HAS ALL OF THE QUALITIES
- 19 THAT WE NEED FOR AN INSTITUTE, BUT RATHER HAS THE MOST
- 20 IMPORTANT ONES.
- 21 AND FROM MY PERSPECTIVE, I ECHO THE RESPECT OF
- THE ACADEMIC COMMUNITY IS CRITICAL, MORE CRITICAL, I
- THINK, THAN THE POLITICAL ONES.
- MS. LANSING: AGAIN, THIS IS SHERRY. WE'RE NOT
- 25 GOING AWAY. WE'RE A COMMITTEE THAT'S GOING TO WORK

- 1 TOGETHER AND CAN BE VERY HELPFUL.
- DR. MURPHY: RICH MURPHY AT THE BURNHAM. LET
- 3 ME ADD ONE MORE QUALITY TO THIS SUPER PERSON THAT WE'RE
- 4 GOING TO HIRE. AND THAT IS THE FACT THAT THEY'RE NOT
- 5 COMING INTO A FORMED ORGANIZATION, AND THEY ARE GOING TO
- 6 HAVE TO BUILD FROM SCRATCH, WHICH IS GOING TO TAKE A
- 7 TREMENDOUS AMOUNT OF ENERGY AND TIME COMMITMENT AND
- 8 WISDOM TO PULL ALL OF THIS TOGETHER AND THEN TO MAKE IT
- 9 WORK AND THEN TO HAVE ALL OF THE QUALITIES OF RUNNING THE
- 10 SHOW THAT SHERRY SO WELL DESCRIBES.
- DR. PIZZO: AND WITH ONE BIG CAVEAT --
- 12 CHAIRMAN KLEIN: THIS IS DEAN PIZZO.
- DR. PIZZO: I JUST WANT TO ADD TO THAT, AND
- 14 THAT IS TO DO IT IN LIGHTNING SPEED. IT'S ONE THING TO
- 15 HAVE THAT ASSIGNMENT TO DO IT OVER THE COURSE OF A YEAR
- 16 OR TWO. TO DO IT WITHIN THE FIRST MONTHS, WHICH IS WHAT
- 17 WE'RE REALLY TALKING ABOUT, REQUIRES REALLY AN
- 18 EXTRAORDINARY INDIVIDUAL WHO KNOWS WHAT SHE OR HE HAS
- 19 BEFORE THEM AND KNOWS PEOPLE THAT THEY CAN RAPIDLY GATHER
- 20 TOGETHER AS WELL.
- 21 CHAIRMAN KLEIN: THIS IS BOB KLEIN AGAIN.
- 22 WHILE I'M USUALLY THE ONE THAT'S TALKING ABOUT SPEED, I'D
- 23 LIKE TO EMPHASIZE HERE THAT I'M SURE THE COMMON SENSE OF
- 24 ALL OF US IS THAT WHILE WE MOVE FORWARD WITH ALL DUE
- 25 SPEED. WE WILL NOT SACRIFICE GETTING THE HIGHEST POSSIBLE

- 1 CANDIDATES SO THAT IT IS -- WE ARE AT THE MOMENT
- 2 OPTIMISTIC THAT, BECAUSE THIS IS SUCH AN IMPORTANT JOB,
- 3 WE'LL BE ABLE TO MOVE AHEAD RAPIDLY WHILE OBTAINING THE
- 4 HIGHEST POSSIBLE CANDIDATE, WHICH IS OUR SINGLE MOST
- 5 IMPORTANT OBJECTIVE.
- DR. MURPHY: RICH MURPHY AGAIN. IF I COULD
- 7 JUST ADD ONE FINAL POINT. ANOTHER FUNCTION OF THIS
- 8 INDIVIDUAL WILL BE MANAGING A BOARD OF 29 PEOPLE WITH
- 9 VERY DIVERSE BACKGROUNDS. AND OBVIOUSLY THE PRESIDENT IS
- 10 GOING TO HAVE TO KEEP THE BOARD INFORMED AND ON SIDE, AND
- 11 THE BOARD IS GOING TO HAVE TO KNOW THAT IT IS ADVISORY
- 12 RATHER THAN OPERATIONAL. AND IF IT BECOMES OPERATIONAL,
- 13 THE PRESIDENT IS GOING TO HAVE TO BE ABLE TO STICKHANDLE
- 14 THAT AND ORGANIZE US IN A WAY THAT WE FEEL INVOLVED AND
- 15 ON SIDE AND SUPPORTIVE RATHER THAN CHALLENGED IN A
- 16 NEGATIVE WAY.
- 17 CHAIRMAN KLEIN: RICH, POINT IS WELL TAKEN. I
- 18 WOULD SAY THAT I THINK THIS BOARD IS THE DREAM TEAM, AND
- 19 IT IS A GREAT COMFORT TO ME THAT SHERRY LANSING SAID IT
- 20 WASN'T GOING TO LEAVE.
- MS. LANSING: WE'RE NOT.
- DR. PRECIADO: COULD I ADD SOMETHING, AND THIS
- 23 ACTUALLY --
- 24 CHAIRMAN KLEIN: THIS IS DR. PRECIADO.
- DR. PRECIADO: I'M SORRY. I KEEP FORGETTING.

- 1 THE PUBLIC'S VOICE IS CRITICAL, AND WE ALL FEEL THE
- 2 ANXIETY SORT OF TO MOVE FORWARD, AND WE KNOW THE NEED IN
- 3 TERMS OF DISEASE, BUT LET'S NOT FORGET THAT, FIRST OF
- 4 ALL, THE PRESIDENT NEEDS TIME TO DEVELOP RELATIONSHIPS
- 5 WITH THE BOARD AND THE PUBLIC. AND RELATIONSHIP BUILDING
- 6 TAKES TIME. THIS IS INFRASTRUCTURE BUILDING RIGHT NOW.
- 7 AND SO IF WE GET OVERZEALOUS, AND CERTAINLY I KNOW THAT I
- 8 FEEL THE SCIENCE PUSH RIGHT NOW, IF WE GET OVERZEALOUS,
- 9 WE'RE GOING TO FORGET THAT, WAIT A MINUTE, THIS IS AN
- 10 AGREEMENT WE HAVE WITH THE PUBLIC. WE HAVE TO KEEP AT
- 11 PACE WITH THE PUBLIC'S PACE AS MUCH AS POSSIBLE.
- DR. KESSLER: BOB, THIS IS DAVID IN SAN
- 13 FRANCISCO. I THINK SHERRY'S POINT MAY BE THE MOST
- 14 IMPORTANT POINT THAT THIS COMMITTEE GETS BEHIND. THE
- 15 NOTION THAT THE NO. 1 PRIORITY IN THE PROFILE OF A
- 16 PRESIDENTIAL CANDIDATE IS THE SCIENTIST CREDIBILITY AND
- 17 THEN STRONG MANAGEMENT AND THEN STRONG POLITICAL, I
- 18 THINK, IS A VERY IMPORTANT POINT.
- 19 I WONDER, BOB, I WONDER WHETHER IT'S WORTHWHILE
- 20 AT THIS POINT, WITH SHERRY'S POINT BEING SO IMPORTANT,
- 21 THAT THE NO. 1 PRIORITY IS SCIENCE AND THEN MANAGEMENT, I
- 22 WONDER WHETHER WE SHOULD HEAR FROM THE PUBLIC.
- CHAIRMAN KLEIN: DR. KESSLER, IF WE COULD DO
- 24 THIS SO THAT, BECAUSE WE HAVE SIX DIFFERENT SITES TO HEAR
- 25 FROM THE PUBLIC FROM, MAYBE WE COULD JUST FINISH SOME

- 1 ADDITIONAL BOARD COMMENTS ON THE PROPOSALS THEMSELVES AND
- 2 HOW THEY RELATE TO THAT CRITERIA.
- 3 DR. KESSLER: BUT IN SOME WAYS SHERRY'S POINT
- 4 IS SO IMPORTANT.
- 5 CHAIRMAN KLEIN: OKAY. WELL TAKEN. WHY DON'T
- 6 WE DEPART FROM THAT PLAN AND ASK THE PUBLIC. ARE THERE
- 7 ANY COMMENTS FROM THE PUBLIC AT BURNHAM INSTITUTE AS TO
- 8 THAT POINT?
- 9 UNIDENTIFIED SPEAKER: NO.
- 10 CHAIRMAN KLEIN: ANY PUBLIC COMMENTS FROM USC
- 11 AS TO THAT POINT?
- DR. HENDERSON: NO.
- 13 CHAIRMAN KLEIN: AT UCLA?
- MS. KING: JUST ONE COLLECTIVE COMMENT COMING
- 15 THROUGH, AND THAT IS WE AGREE.
- 16 CHAIRMAN KLEIN: OKAY. WHICH SITE WAS THAT?
- MS. KING: UCLA.
- 18 CHAIRMAN KLEIN: OKAY. THERE'S A REAL
- 19 COMMUNITY OF PURPOSE THERE. AT UC BERKELEY?
- DR. BARGLOW: THIS IS RAYMOND BARGLOW FROM THE
- 21 STEM CELL ACTION NETWORK. AND WE'RE VERY PLEASED WITH
- THE WAY THE PROCESS IS GOING ON. WE THINK THE
- 23 PRESIDENTIAL SEARCH IS CRUCIAL, AND WE LIKE THE IDEA OF
- 24 BUILDING IN PUBLIC PARTICIPATION TO THE INFRASTRUCTURE OF
- 25 THIS ENTIRE EFFORT.

- 1 CHAIRMAN KLEIN: OKAY. ANY COMMENTS FROM UC
- 2 SAN FRANCISCO?
- 3 DR. KESSLER: THERE'S AGREEMENT HERE.
- 4 CHAIRMAN KLEIN: AND AT STANFORD?
- DR. POSNER: PHIL POSNER FROM OAK RIDGE
- 6 UNIVERSITY. AND IT'S JUST A QUESTION, THAT WITH THE
- 7 INITIAL LEGISLATION THAT 90 PERCENT OF THE MONIES GOING
- 8 INTO RESEARCH, I THINK IT'S VERY IMPORTANT THAT THERE'S
- 9 SUFFICIENT FUNDS FOR STAFFING OF THE OFFICE, THAT THE
- 10 PRESIDENT'S OFFICE IS GOING TO HAVE A HUGE JOB, SIMILAR
- 11 TO ANY PRESIDENT, PROVOST, CHIEF SCIENCE OFFICER, WHAT
- 12 HAVE YOU, AND THE DELEGATION OF STAFFING, I THINK, FOR
- 13 THE RECRUITING IS AN IMPORTANT PART OF THE PACKAGE TO
- 14 KNOW WHAT THE ORG CHART IS AND HOW MUCH FUNDING THEY'LL
- 15 HAVE TO STAFF IT.
- 16 CHAIRMAN KLEIN: YEAH. THE POINT AS THE
- 17 FUNDING, AS WE REMEMBER, THERE'S A DISCIPLINE FINANCIALLY
- 18 BUILT IN, HOPEFULLY BECAUSE OF SCALE, THAT DISCIPLINE
- 19 WILL WORK WELL. THERE'S NO MORE THAN 3 PERCENT OF THE
- 20 COMMITMENTS IN ANY ONE YEAR SPENT ON GENERAL OVERHEAD, NO
- 21 MORE THAN 3 PERCENT ON GRANT ADMINISTRATION. IT'S THE
- 22 TOTAL AMOUNT AUTHORIZED IN ANY ONE YEAR THAT IS THE
- 23 SPECIFIC BENCHMARK ON WHICH THE OVERHEAD IS CALCULATED
- 24 BECAUSE THAT RELATES TO THE AMOUNT OF GRANTS THAT WERE
- 25 PROCESSED.

- 1 WHAT I WOULD LIKE TO DO WITH THOSE PUBLIC
- 2 COMMENTS IS ASK IF THE BOARD, GOING BACK NOW TO THE
- 3 SEARCH PROPOSALS, WOULD LIKE TO MAKE COMMENTS
- 4 SPECIFICALLY LOOKING AT THE BIOMEDICAL RESEARCH AND
- 5 SCIENTIFIC RESEARCH POSITIONS THAT THE VARIOUS APPLICANTS
- 6 HAVE REFERENCED IN THEIR RESUMES.
- 7 DR. HENDERSON: BRIAN HENDERSON HERE. BEFORE
- 8 WE DO THAT, BOB, I WONDER IF WE SHOULDN'T FOLLOW UP ON
- 9 WHAT DAVID KESSLER SUGGESTED INITIALLY, WHICH IS TO
- 10 FORMALLY ADOPT THE LANSING PROPOSAL SO THAT THE PUBLIC
- 11 KNOWS FOR THE RECORD THE APPROACH WE'RE TAKING; THAT IS,
- 12 ALL THE PUBLIC THAT'S NOT ABLE TO PARTICIPATE TODAY.
- 13 CHAIRMAN KLEIN: SO WHAT WE'RE SUGGESTING IS
- 14 THAT WE CONSIDER SHERRY LANSING'S SUMMARY ON THE PRIORITY
- 15 IN THE CRITERIA BEING FOR OUTSTANDING SCIENTIFIC AND
- 16 BIOMEDICAL EXPERTISE AND WITH MANAGEMENT CAPACITY --
- 17 DR. HENDERSON: CORRECT.
- 18 CHAIRMAN KLEIN: -- WITH A SENSITIVITY TO
- 19 POLITICAL RAMIFICATIONS AND IMPLICATIONS, BUT THAT IS A
- 20 SUBORDINATE CHARACTERISTIC TO THE OTHER TWO
- 21 CHARACTERISTICS. IS THAT A PROPER SUMMARY?
- DR. HENDERSON: WELL PUT.
- 23 CHAIRMAN KLEIN: IS THERE SOMEONE WHO WOULD
- 24 LIKE TO MAKE A MOTION TO ADOPT THAT AS A CRITERIA?
- DR. PIZZO: SO MOVED.

- 1 DR. HENDERSON: SECOND IT.
- 2 CHAIRMAN KLEIN: MOVED BY DR. PIZZO. WHO WAS
- 3 THE SECOND?
- 4 DR. HENDERSON: HENDERSON.
- 5 CHAIRMAN KLEIN: HENDERSON SECOND. IS THERE
- 6 DISCUSSION ON THE MOTION?
- 7 DR. MURPHY: YEAH. RICH MURPHY. YOU KNOW, I
- 8 THINK WE ALL AGREE IN PRINCIPLE WITH THIS, BUT I WONDER
- 9 IF IT'S REALLY ESSENTIAL AT THIS POINT TO PUT THIS DOWN
- 10 IN A FORMAL PROPOSITION BECAUSE I THINK WE DON'T KNOW
- 11 WHAT'S OUT THERE IN TERMS OF THE CANDIDATES WHO COULD BE
- 12 AVAILABLE FOR THIS POSITION. AND I THINK THAT IT'S
- 13 HIGHLY UNLIKELY THAT WE'RE GOING TO GET SOMEONE WHO
- 14 REALLY IS AS STRONG AS WE WOULD HOPE IN ALL THE CRITERIA
- 15 WE'VE BEEN TALKING ABOUT. CERTAINLY SCIENTIFIC
- 16 EXCELLENCE SHOULD BE THERE, BUT I GUESS I THINK WE SHOULD
- 17 AT LEAST CONSIDER MAINTAINING ENOUGH FLEXIBILITY TO ALLOW
- 18 THE COMMITTEE TO HAVE ITS DISCUSSIONS, TO ALLOW THE HEAD
- 19 HUNTERS TO DO THEIR THING, AND THEN TO WITHIN BROAD
- 20 GUIDELINES, I CERTAINLY AGREE WITH WHAT'S BEING SAID, BUT
- 21 I'M NOT SURE THAT IT'S WISE AT THIS POINT TO PERHAPS CUT
- 22 OUT OF THE EQUATION PEOPLE WHO WE WOULD SEE WITH UNUSUAL
- 23 TALENT AND UNUSUAL CRITERIA FOR THE POSITION.
- CHAIRMAN KLEIN: WELL, DR. MURPHY, IF WE WERE
- 25 TO TAKE YOUR STATEMENT AS A GENERAL CAVEAT, BUT CONSIDER

- 1 THIS MOTION TO BE INITIAL DIRECTION, WE'RE -- I HAVE
- 2 SUGGESTED THAT WE BRING THIS BACK WHEN THE LONG LIST IS
- 3 ESTABLISHED, REVIEW THE JOB DESCRIPTION AND CRITERIA, SO
- 4 WE'LL HAVE ANOTHER LOOK AT IT THEN, SO WE'RE NOT BUILDING
- 5 IN INFLEXIBILITY HERE.
- DR. MURPHY: I WOULD AGREE WITH THAT THEN, BOB.
- 7 CHAIRMAN KLEIN: DR. PIZZO?
- 8 DR. PIZZO: YEAH. ALONG THAT SAME LINE, I
- 9 THINK ACTUALLY IN FAIRNESS. THIS WILL HELP THE SEARCH
- 10 FIRM AND HELP US TO LOOK FOR AND FIND THE VERY BEST AND
- 11 MOST SUITABLE CANDIDATES. I THINK SEARCH FIRMS TAKE
- 12 GUIDANCE FROM THOSE WHO ARE OFFERING THE OPPORTUNITY TO
- 13 THEM, AND I THINK THIS PROVIDES A BROAD BOUNDARY. QUITE
- 14 HONESTLY, THE COMBINATION OF SCIENTIFIC KNOWLEDGE AND
- 15 MANAGEMENT SKILLS IS PRETTY VANILLA WHEN YOU COME DOWN TO
- 16 IT. IT REALLY DOES DEFINE THE OVERALL SCOPE OF
- 17 ACTIVITIES. I THINK THE IMPORTANCE OF THAT IS THAT IT
- 18 DIFFERENTIATES IT FROM SOMEONE WHO IS SIMPLY JUST A
- 19 STRONG ADMINISTRATOR. AND THAT'S, I THINK, THE
- 20 BIFURCATION THAT WE'RE LOOKING FOR AT THIS JUNCTURE.
- 21 SO I ACTUALLY AM QUITE SUPPORTIVE TO THIS
- 22 PROPOSAL. I THINK IT IS FLEXIBLE ENOUGH FOR US AT THIS
- JUNCTURE, AND I THINK IT WILL HELP TO EXPEDITE THE WORK
- 24 OF THE SEARCH FIRM AS WELL.
- 25 DR. HENDERSON: I AGREE. BRIAN HENDERSON.

- 1 CHAIRMAN KLEIN: OKAY.
- DR. BIRGENEAU: THIS IS BOB BIRGENEAU AGAIN.
- 3 AND, YOU KNOW, AS A SCIENTIST ADMINISTRATOR, OBVIOUSLY I
- 4 SUPPORT SCIENTIFIC ADMINISTRATORS. HOWEVER, WE'VE HAD A
- 5 SORT OF DRAMATIC ILLUSTRATION AT AN ELITE UNIVERSITY ON
- THE EAST COAST OF WHAT HAPPENS WHEN A PERSON DOESN'T SHOW
- 7 APPROPRIATE POLITICAL SENSITIVITY. SINCE I'VE BEEN
- 8 TALKING TO NEWSPAPER REPORTERS OFTEN ABOUT THIS IN THE
- 9 LAST WEEK, I PERSONALLY BELIEVE THAT THE POLITICAL
- 10 ASPECTS, THE POLITICAL SKILLS ARE GOING TO BE MORE
- 11 IMPORTANT THAN EVERYONE ELSE SEEMS TO THINK. AND I THINK
- 12 IT'S VERY IMPORTANT THAT NOT END UP WITH A PRESIDENT
- 13 WHO'S GOING TO HAVE HIS OR HER FOOT IN THEIR MOUTH
- 14 CONSTANTLY BECAUSE I THINK THAT CAN DO A LOT OF DAMAGE IN
- 15 TERMS OF TRYING TO ACCOMPLISH WHAT WE WANT TO ACCOMPLISH
- 16 HERE.
- 17 CHAIRMAN KLEIN: OKAY. WITH THAT
- 18 UNDERSTANDING, THAT WE CERTAINLY NEED THAT SENSITIVITY,
- 19 IF THERE'S NOT ADDITIONAL BOARD COMMENTS, I'D LIKE TO
- 20 CALL FOR THE QUESTION HERE BECAUSE ON TIME, WE DO NEED TO
- 21 MOVE THROUGH THE AGENDA IF WE CAN, REALIZING THAT WE'RE
- 22 GOING TO COME BACK TO MANY OF THESE ISSUES AS STATED,
- 23 ASSUMING THAT THIS COMMITTEE ADOPTS A LATER RESOLUTION ON
- 24 PROCESS WHERE WE WILL HAVE THE ABILITY TO GO INTO THESE
- 25 IN GREATER DEPTH ON SEVERAL OCCASIONS.

- 1 IS THERE ADDITIONAL COMMENT FROM THE BOARD ON
- 2 THIS MOTION? CALLING FOR THE QUESTION. ALL IN FAVOR.
- 3 OPPOSED. OKAY. THAT MOTION PASSES. WE THANK YOU FOR
- 4 THE LANSING MOTION.
- 5 MS. LANSING: TO SAY THAT'S THE FIRST TIME I'VE
- 6 EVER HAD A MOTION IN MY NAME.
- 7 CHAIRMAN KLEIN: OKAY. IT'S BEEN SUGGESTED TO
- 8 ME THAT EVEN THOUGH IT IS UNANIMOUS, FOR THE PURPOSES OF
- 9 THE RECORD AND BEING CONSERVATIVE, WE NEED TO DO A ROLL
- 10 CALL VOTE. SO WE WILL START AT BURNHAM. ACTUALLY, I
- 11 HAVE A LIST HERE THAT I'LL WORK OFF.
- 12 BRIAN HENDERSON.
- DR. HENDERSON: YES.
- 14 CHAIRMAN KLEIN: JANET WRIGHT.
- DR. WRIGHT: YES.
- 16 CHAIRMAN KLEIN: PHYLLIS PRECIADO.
- 17 DR. PRECIADO: YES.
- 18 CHAIRMAN KLEIN: BOB BIRGENEAU.
- 19 DR. BIRGENEAU: YES.
- 20 CHAIRMAN KLEIN: KEITH BLACK. SUSAN BRYANT.

- 2 LANSING.
- 3 MS. LANSING: YES.
- 4 CHAIRMAN KLEIN: RICHARD MURPHY.

- 6 CHAIRMAN KLEIN: TINA NOVA.
- 7 DR. NOVA: YES.
- 8 CHAIRMAN KLEIN: PHIL PIZZO.
- 9 DR. PIZZO: YES.
- 10 CHAIRMAN KLEIN: JOAN SAMUELSON IS NOT PRESENT.
- 11 OKAY. I THANK YOU VERY MUCH.
- 12 COULD WE, JUST IN TERMS OF THE CRITERIA THAT'S
- 13 JUST BEEN DESCRIBED AS SCIENTIFIC AND BIOMEDICAL
- 14 CRITERIA, I WOULD LIKE TO KIND OF KICK OFF THIS
- 15 DISCUSSION OF THE -- WE'RE GETTING SOME FEEDBACK FROM
- 16 SOMEONE TALKING IN THE BACKGROUND. I'D LIKE TO GO
- 17 THROUGH THE PROCESS HERE AND DISCUSS IN TERMS OF THE
- 18 PROPOSALS WE HAVE IN FRONT OF US, I WOULD LIKE TO SUGGEST
- 19 THAT IT APPEARS THAT THE SPENCER STUART PROPOSAL HAS A
- 20 BACKGROUND AND REFERENCES IN SCIENTIFIC AND BIOMEDICAL
- 21 EXPERTISE IN THEIR PRIOR SELECTIONS. AND I WAS WONDERING
- 22 WHAT THE COMMITTEE'S VIEW WAS OF THE OTHER PROPOSALS AS
- 23 TO THE RELATIVE EXPERIENCE OF THE FIRMS AS PROPOSED.
- 24 WE'VE REVERSED THE ORDER, AND WE'RE TALKING
- 25 WITH DR. PIZZO.

- 1 DR. PIZZO: AMONG THE SEARCH FIRMS THAT COME
- 2 FORWARD, LET ME BEGIN WITH THE STATEMENT WHICH IS THAT
- 3 MANY OF US CHOOSE OFTENTIMES TO WORK WITHOUT SEARCH FIRMS
- 4 AS WELL. SO THE PROCESS OF WORKING WITH A SEARCH FIRM,
- 5 WHICH I THINK IS A GOOD ONE FOR THIS ARENA, IS THAT IT
- 6 WILL ALLOW US TO EXPEDITE THE PROCESS, HAVE THE REFERENCE
- 7 CHECKS BE DONE, REFINE THE JOB DESCRIPTION ETC., ETC. SO
- 8 I THINK THERE IS GOOD REASON FOR US TO BE DOING THAT IN
- 9 THIS PARTICULAR SETTING BECAUSE OF TIME.
- 10 AS I SEE THE PROPOSAL, THERE REALLY ARE THREE
- 11 THAT I THINK ARE COMPETITIVE, AND THEY ARE, AS BOB JUST
- 12 MENTIONED, THE SPENCER STUART, THE A. T. KEARNEY, AND THE
- 13 ISAACSON MILLER. I THINK THE OTHER TWO HAVE MORE NARROW
- 14 FOCUSED AREAS THAT, TO ME AT LEAST, DON'T SEEM TO BE OF
- 15 THE SAME OVERALL DEPTH TO ALLOW THEM TO BE AS FUNCTIONAL
- 16 FOR THIS PARTICULAR SEARCH.
- 17 THAT SAID, THERE'S ALSO A PROCESS, AT LEAST
- 18 THAT I'VE GONE THROUGH IN THE PAST, AND MAYBE OTHERS
- 19 COULD COMMENT ON THIS AS WELL, WITH SEARCH FIRMS, WHICH
- 20 IS IT'S NOT JUST A MATTER OF REVIEWING THE PROPOSAL.
- 21 IT'S KNOWING WHO'S GOING TO DO THE SEARCH BECAUSE THAT
- 22 BECOMES THE KEY CRITERIA, AND IT'S ALSO INTERVIEWING THE
- 23 SEARCH FIRMS. SO THE SELECTION PROCESS, I DON'T THINK,
- 24 IS JUST A PAPER ONE. I DON'T THINK WE SHOULD LIMIT
- 25 OURSELVES TO JUST WHAT WE HAVE BEFORE US. I THINK WE

- 1 NEED TO DELEGATE A SMALL GROUP OF PEOPLE TO BE ABLE TO
- 2 CARRY OUT AN INTERVIEW PROCESS WITH THE SEARCH FIRM OR
- 3 HAVE THEM COME AND SUBMIT THEIR, EITHER TELEPHONICALLY OR
- 4 IN PERSON, HOW THEY WOULD CARRY THIS OUT. AND THEN TO
- 5 CHOOSE FROM THAT KIND OF INTERACTIVE PROCESS SO THAT
- 6 WE'RE SURE THAT WE'VE GOT THE VERY, VERY BEST ONE TO
- 7 CARRY OUT THIS WORK.
- 8 DR. BRYANT: I WOULD AGREE WITH THAT. THIS IS
- 9 SUSAN BRYANT. I THINK THAT IT'S ALSO IMPORTANT TO KNOW
- 10 WHO'S GOING TO BE ON THE TEAM THAT'S ACTUALLY DOING THE
- 11 RECRUITING BECAUSE THAT'S CRITICAL ALSO. SO I WAS
- 12 WONDERING IF WE COULDN'T REDUCE THIS LIST DOWN TO A
- 13 SMALLER NUMBER AND THEN HAVE PRESENTATIONS BY THE TEAM
- 14 THAT'S ACTUALLY GOING TO BE DOING THE SEARCH FOR A SMALL
- 15 GROUP.
- DR. PIZZO: MY PROPOSAL, SUSAN, WAS THAT WE
- 17 LIMIT AT LEAST THE CONSIDERATION -- THIS IS PHIL PIZZO
- 18 SPEAKING -- TO SPENCER STUART, A. T. KEARNEY, AND
- 19 ISAACSON MILLER (INAUDIBLE) AROUND THAT BECAUSE THAT WILL
- 20 HELP US WITH WHO WE INTERVIEW.
- MS. LANSING: THIS IS SHERRY LANSING. ARE WE
- 22 GOING IN ORDER OR NOT?
- 23 CHAIRMAN KLEIN: WHAT WE'RE GOING IS IN A
- 24 REVERSE ORDER FROM THE PRIOR COMMENTS, SHERRY. WE'RE
- 25 GOING TO UC SAN FRANCISCO FOR COMMENT.

- 1 DR. KESSLER: I'M IN AGREEMENT WITH -- FIRST OF
- 2 ALL, I'D BE HAPPY TO YIELD TO SHERRY.
- 3 MS. LANSING: NO, DON'T DO THAT. GO AHEAD.
- 4 DR. KESSLER: I'M VERY MUCH IN AGREEMENT WITH
- 5 WHAT DR. PIZZO SET OUT. I THINK IT'S VERY IMPORTANT THAT
- 6 WE BE ABLE TO ASK QUESTIONS OF THE SEARCH FIRMS AND
- 7 ESPECIALLY WHO REALLY WILL BE LEADING THESE TEAMS.
- 8 CHAIRMAN KLEIN: ALL RIGHT.
- 9 DR. PIZZO: DAVID. THERE'S FIVE PROPOSALS. I
- 10 HAD INDICATED THREE OF THEM AS THE LIKELY GROUPING. DO
- 11 YOU HAVE A COMMENT ON THAT?
- DR. KESSLER: I THINK, PHIL, MY SENSE WAS,
- 13 AGAIN, MY GOAL WAS NOT TO BE EXCLUSIVE, BUT I THINK YOU
- 14 CERTAINLY, BASED ON WHAT I READ FROM THESE PROPOSALS, I
- 15 WOULD AGREE, PHIL.
- 16 CHAIRMAN KLEIN: OKAY. IN TERMS OF THE
- 17 PROCESS -- THIS IS BOB KLEIN -- LET ME REMIND EVERYONE
- 18 THAT THE TIMETABLE FOR US TO GET TOGETHER AGAIN REQUIRES
- 19 ANOTHER TEN DAYS POSTING ON A DATE THAT FITS ALL THE
- 20 CALENDARS ON THE COMMITTEE. SO IF WE CAN GET TO A POINT
- OF SELECTING A FIRM, IT WOULD SAVE A SUBSTANTIAL AMOUNT
- 22 OF TIME. BUT IF THEY ARE CLOSE, WE SHOULD OBVIOUSLY HOLD
- 23 A SECOND SESSION.
- 24 SO IF THE PEOPLE COULD ADDRESS THE DIFFERENCES
- 25 BETWEEN THESE FIRMS IN THEIR COMMENTS.

- DR. KESSLER: BOB, THERE'S NO WAY, BASED ON
- THESE PROPOSALS ALONE, I FEEL, AND I KNOW THESE FIRMS
- 3 PRETTY WELL, BUT EVERYTHING COMES DOWN TO THE TEAM AND
- 4 THE INTERACTION. WE DO NEED AN ABILITY TO HEAR FROM
- 5 THESE SEARCH FIRMS. I DON'T KNOW WHETHER THAT'S PROVIDED
- 6 FOR TODAY OR NOT, WHETHER THEY'RE, IN FACT, HERE. I'M
- 7 VERY HESITANT TO MOVE AHEAD WITHOUT SOME KIND OF
- 8 INTERACTION AND QUESTIONING AND BACK AND FORTH BETWEEN
- 9 THE SEARCH COMMITTEE AND THE FIRMS. WHEN IT HAPPENS, YOU
- 10 KNOW, I LEAVE TO YOU OBVIOUSLY.
- DR. PIZZO: CAN WE ORGANIZE THINGS, AS YOU HAD
- 12 STATED EARLIER, BOB, WHEREBY WE HAVE TWO-PERSON TEAMS
- 13 BEGINNING TO DO DUE DILIGENCE AROUND THE FIRMS, GATHER
- 14 THE INFORMATION, SO THAT WE CAN COME BACK TO THE NEXT
- 15 MEETING WITH THAT DELINEATION, PERHAPS WITH THOSE
- 16 RELEVANT SEARCH FIRMS ACTUALLY COMING TO THAT MEETING TO
- 17 PRESENT TO THE GROUP THAT WAY?
- 18 CHAIRMAN KLEIN: WE CERTAINLY COULD FOLLOW THAT
- 19 PROTOCOL.
- 20 DR. HENDERSON: BRIAN HENDERSON. CAN WE DO
- 21 THIS MEETING, THOUGH, BY PHONE SO WE CAN EXPEDITE IT? IF
- 22 WE DO THE TWO-PERSON -- IF WE COULD DELEGATE TWO OF US ON
- THE COMMITTEE TO MEET WITH EACH OF THESE THREE FIRMS, IF
- 24 WE STAY WITH THESE THREE, AND THEN GET BACK TO THE PHONE
- 25 TEN DAYS FROM NOW, WE COULD GET A SEARCH COMMITTEE IN A

- 1 PRETTY EXPEDITIOUS FASHION.
- DR. KESSLER: THE ONLY PROBLEM WITH THAT IS
- 3 WE'RE NOT GOING TO BE ABLE TO SEE MORE BROADLY. THE TWO
- 4 PEOPLE WILL SEE EACH FIRM. IT TAKES AWAY THE ABILITY TO
- 5 SEE ACROSS FIRMS OBVIOUSLY.
- 6 MS. LANSING: THIS IS SHERRY LANSING. I'D LIKE
- 7 TO MAKE A DISSENTING OPINION FOR A SECOND. I'VE READ ALL
- 8 OF THE PROPOSED PEOPLE. AND TO ME, I HAVE TO SAY THIS, I
- 9 REALLY FELT THAT SPENCER STUART JUST LEAPT OUT. I THINK
- 10 EVERYBODY, YOU KNOW, IS QUALIFIED, BUT I FELT THAT
- 11 SPENCER STUART JUST HAD SO MUCH MORE EXPERIENCE AND SO
- 12 MUCH MORE EXPERIENCE IN THE CROSSOVER BETWEEN HEALTH AND
- 13 ACADEMICS. AND TO ME IT JUST SEEMED TO HAVE THE BROADEST
- 14 HEALTH BASE OF ANYONE. IT SEEMED TO HAVE THE BROADEST
- 15 EXPERIENCE.
- 16 AND I HAVE TO SAY THAT I HAVE WORKED WITH THEM
- 17 TWICE ON UC SEARCHES. AND THE CALIBER OF PEOPLE THAT
- 18 THEY TURNED UP WAS EXTRAORDINARY, I MEAN JUST
- 19 EXTRAORDINARY. IT WAS REALLY HARD -- AND, BOB, YOU'RE
- 20 ONE OF THE PEOPLE THAT WE FELT SO LUCKY ABOUT. IT WAS
- 21 REALLY HARD TO CHOOSE AMONG PEOPLE.
- 22 SO I JUST WOULD LIKE TO AMEND, I GUESS, THE
- 23 PROPOSITION OR WHATEVER WE'RE TALKING ABOUT TO JUST SAY,
- 24 IN THE EMPHASIS OF TIME, TO SAY THAT IF WE ALL THINK THAT
- 25 SPENCER STUART LEAPS OUT, AND MAYBE WE DON'T, TO ME, WHEN

- 1 I READ ALL OF THEM, YOU KNOW, IT JUST LEAPT OUT AS BEING
- 2 SO QUALIFIED, THAT PERHAPS WE SHOULD SEE WHO THEIR TEAM
- 3 IS AND MEET WITH THEM IN PERSON AND FEEL GOOD ABOUT IT.
- 4 BECAUSE WE DON'T HAVE TO ACCEPT A PROPOSAL. WE CAN JUST
- 5 SAY THIS IS WHERE WE'RE LEANING. SEE WHERE THEY COME OUT
- 6 BECAUSE I'M JUST AFRAID THAT THIS PROCESS IS GOING TO
- 7 TAKE LONGER THAN IS MAYBE EFFICIENT.
- 8 CHAIRMAN KLEIN: MICHAEL GOLDBERG. I PASSED
- 9 OVER AT STANFORD, MICHAEL.
- 10 MR. GOLDBERG: YES. SHERRY, I'M IN GENERAL
- 11 AGREEMENT WITH THAT. AS I READ THROUGH THESE TWICE OVER
- 12 THE WEEKEND, I READ THROUGH THEM FIRST TO GET A GENERAL
- 13 SENSE OF THEM, AND THEN I READ THROUGH THEM AND SCORED
- 14 THEM AGAINST THE FOLLOWING CRITERIA. THE FIRST WAS DEEP
- 15 EXPERTISE IN LIFE SCIENCES, NOT FOR PROFIT ORGANIZATIONS,
- 16 AND DIVERSITY.
- 17 THE SECOND WAS A DEMONSTRATED UNDERSTANDING OF
- 18 THE ASSIGNMENT AND THE THOUGHTFULNESS TO THEIR PROPOSAL.
- 19 THE THIRD WAS A HIGH QUALITY REPUTATION OF THE
- 20 FIRM SO THEY CAN ATTRACT AND GET ACCESS TO THE BEST
- 21 CANDIDATE POOL.
- THE FOURTH WAS EXPERTISE OF THE DESIGNATED
- TEAM.
- THE FIFTH WAS THE DEPTH OF THE FIRM.
- 25 AND THE SIXTH WAS THE COMMITMENT OF THE FIRM SO

- 1 THAT WE COULD BE A HIGH PRIORITY SEARCH IN THEIR
- 2 UNIVERSE.
- 3 CHAIRMAN KLEIN: I WOULD ALSO -- ARE YOU
- 4 FINISHED?
- 5 MR. GOLDBERG: I WAS SIMPLY GOING TO SAY THAT
- 6 AGAINST THOSE CRITERIA, WHICH PERHAPS THERE ARE OTHER
- 7 RELEVANT CRITERIA WHICH I MAY HAVE MISSED, AND I'VE DONE
- 8 A LOT OF THIS, SPENCER STUART TO ME AS WELL, SHERRY,
- 9 JUMPED OUT. AND I NOTICED THAT THEY HAD DONE A SEARCH
- 10 FOR THE CEO OF CITY OF HOPE, SO I CALLED MICHAEL FRIEDMAN
- 11 THIS MORNING WITHOUT SHARING ANY OF WHAT I JUST SHARED
- 12 WITH ALL OF YOU, JUST SIMPLY ASKED HIM WHAT HIS
- 13 EXPERIENCE WAS. AND MICHAEL REPORTED THAT HIS EXPERIENCE
- 14 WAS THEY WERE OUTSTANDING. HE WORKS WITH LOTS OF
- 15 DIFFERENT SEARCH FIRMS IN HIS PRESENT ROLE. HE THINKS
- 16 THEY'RE THE BEST IN THE CLASS. THEY DO THE BEST
- 17 RESEARCH. I'M PARAPHRASING MY NOTES FROM HIM. THE BEST
- 18 RESEARCH, EXCELLENT PRESCREENING OF CANDIDATES, THEY
- 19 DON'T WASTE YOUR TIME. HE'D USE THEM AGAIN WITHOUT
- 20 HESITATION.
- ON THAT BASIS, I WOULD PERSONALLY BE VERY
- 22 COMFORTABLE IF WE PROCEEDED WITH WHATEVER ADDITIONAL
- 23 INFORMATION WE WANTED TO OBTAIN FROM SPENCER STUART
- 24 WITHOUT GOING THROUGH A MORE ELABORATE PROCESS. I THINK
- 25 THEY CLEARLY DEMONSTRATED THEY TOOK THE TIME TO TAILOR

- 1 THEIR PROPOSAL TO US IN A WAY THAT NONE OF THE OTHER
- 2 PROPOSALS DID.
- 3 CHAIRMAN KLEIN: DEAN PIZZO.
- 4 DR. PIZZO: JUST A FRIENDLY MODIFIER TO THAT.
- 5 I ALSO HAVE WORKED WITH SPENCER STUART, AND I CERTAINLY
- 6 HAVE THEM AT THE TOP OF MY LIST. I MENTIONED THE OTHER
- 7 TWO FOR COMPLETENESS SAKE. THE ONE QUALIFIER I'D HAVE
- 8 WITH REGARD TO DR. FRIEDMAN'S COMMENT, KNOW HIM WELL, BUT
- 9 SINCE HE WAS SELECTED THROUGH A SEARCH THAT THEY DID,
- 10 THERE'S JUST A SLIGHT BIT OF REASON WHY HE MIGHT BE
- 11 AFFIRMATIVE TO THEM.
- 12 SINCE THIS IS A PUBLIC MEETING, I THINK WE
- 13 SHOULD JUST BE A LITTLE CAUTIOUS WITH THAT
- 14 RECOMMENDATION. BUT I ALSO THINK THAT WE MAY BE SERVED
- 15 BY HAVING A TOP PRIORITY, BUT ALSO BEING SURE THAT WE'RE
- 16 BALANCED IN LOOKING AT AT LEAST ONE OTHER ONE SO THAT
- 17 WE'RE SURE. THIS IS SUCH A BIG ISSUE FOR ALL THE REASONS
- 18 WE'VE STATED. AND THERE ARE OTHER EXECUTIVE SEARCH FIRMS
- 19 THAT DIDN'T SUBMIT PROPOSALS THAT DO THINGS ALSO QUITE
- 20 WELL. KORN FERRY IS ANOTHER ONE THAT DOES THESE KINDS OF
- 21 THINGS.
- 22 SO SPENCER STUART IS CERTAINLY TERRIFIC, BUT I
- THINK THE OTHER ONES, WE'VE WORKED WITH ISAACSON MILLER,
- 24 WE'VE WORKED WITH KEARNEY. I THINK THAT THEY CAN ALL DO
- 25 THE JOB. IT'S A QUESTION OF WHETHER WE GET THE RIGHT

- 1 TEAM.
- DR. KESSLER: THIS IS DAVID. I AGREE WITH PHIL
- 3 A HUNDRED PERCENT. I MEAN IF YOU LOOK -- AGAIN, I WORKED
- 4 VERY CLOSELY WITH SPENCER STUART ON A NUMBER OF SEARCHES
- 5 OVER THE YEARS. BUT YOU LOOK AT THE ISAACSON MILLER,
- 6 THEY RECRUITED A DIRECTOR AND PRESIDENT OF WHITEHEAD.
- 7 YOU LOOK AT A. T. KEARNEY, THEY'VE DONE BROOKHAVEN AND
- 8 LVL AND OAK RIDGE, SO THAT -- I THINK THAT THERE'S
- 9 CONSIDERABLE DOLLARS HERE. THIS IS IMPORTANT. AND I
- 10 THINK WE NEED AN ABILITY, EVEN IF PEOPLE HAVE CERTAIN
- 11 PRESUMPTIONS HERE, AND I'M NOT DISAGREEING WITH
- 12 NECESSARILY THOSE PRESUMPTIONS, I JUST THINK IN A SENSE
- OF FAIRNESS, WE DO NEED TO BE ABLE TO HAVE FIRMS BE ABLE
- 14 TO COME IN AND PRESENT TO US.
- 15 DR. HENDERSON: BRIAN HENDERSON. I JUST WANT
- 16 TO SECOND THE NOTION THAT I WANT TO BE SURE THAT THE
- 17 SEARCH FIRM PUTS THIS AT A VERY HIGH PRIORITY AND THAT
- 18 THEY GIVE US A SEARCH TEAM THAT WE CAN BE CONFIDENT IN.
- 19 I DON'T GET THAT FROM THE PROPOSALS IN THEMSELVES. I
- THINK WE HAVE TO REALLY HEAR WHAT THEY HAVE IN MIND.
- 21 CHAIRMAN KLEIN: JUST TO PUT ANOTHER OPTION ON
- THE TABLE, DR. HENDERSON, OUT OF AN ABUNDANCE OF CAUTION
- 23 AND FLEXIBILITY, I HAVE PUT ON THE FEBRUARY 3D AGENDA FOR
- 24 THE ICOC BOARD AN ITEM WHERE WE CAN REVIEW THESE
- 25 PROPOSALS. IS THAT A CORRECT STATEMENT?

- 1 DR. HENDERSON: YEP.
- 2 CHAIRMAN KLEIN: I'M BEING TOLD THAT ACTUALLY
- 3 THAT'S AN OPTION FOR US, AND WE CAN AMEND THE AGENDA
- 4 TODAY AND BE WITHIN THE TEN-DAY NOTICE PERIOD.
- DR. WRIGHT: BOB, THIS IS JANET WRIGHT. IS IT
- 6 POSSIBLE TO BRING IN ONE OR THE OTHER OF THESE TEAMS AND
- 7 INTERVIEW THEM AT THAT MEETING?
- 8 CHAIRMAN KLEIN: THAT'S EXACTLY WHERE I'M
- 9 GOING, DR. WRIGHT. I'M THINKING TO SERVE TIME, BECAUSE
- 10 THAT MEETING IS ALREADY ON EVERY ONE'S AGENDA, AND
- 11 BECAUSE THIS IS SO IMPORTANT TO THE ENTIRE BOARD, THAT WE
- 12 COULD ASK EITHER TWO OR THREE OR ANY OTHER NUMBER, IF
- 13 THIS COMMITTEE SO CHOSE, TO COME AND MAKE PRESENTATIONS
- 14 TO THE BOARD AND TO BE VERY SPECIFIC ABOUT COMMITMENTS ON
- 15 EXACTLY WHO WOULD THE TEAM THAT WAS GOING TO PARTICIPATE
- 16 AND WHAT THE LEVEL OF PARTICIPATION INTENSITY WOULD BE OF
- 17 THOSE MEMBERS. THAT WOULD ALLOW THE REST OF THE BOARD TO
- 18 PARTICIPATE IN THIS VERY IMPORTANT DECISION IN GUIDING
- 19 THE SEARCH TEAMS. BUT THAT'S JUST TO PUT ANOTHER OPTION
- 20 ON THE TABLE.
- DR. HENDERSON: THAT WOULD GIVE SOME GOOD
- 22 CHANCE FOR PUBLIC INPUT AS WELL THAT WE DON'T HAVE ON
- 23 THIS PHONE. WE'D ACTUALLY HAVE TWO OR THREE OF THESE
- 24 FIRMS PRESENT, THE PUBLIC WOULD BE INVOLVED, THE WHOLE
- 25 BOARD WOULD BE INVOLVED. I THINK IT'S A GOOD MOVE AT

- 1 THIS STAGE IN THE SEARCH.
- DR. PIZZO: TO THAT REGARD, AGAIN, THE
- 3 MODIFICATION IS THAT I WOULD ADVOCATE THAT WE ACTUALLY
- 4 INVITE ALL THREE OF THOSE TOP FIRMS. THAT WAY WE WOULD
- 5 HAVE A COMPLETE VIEW. I THINK WE'D ALL AGREE AND THE
- 6 PUBLIC WOULD AGREE THAT WE CARRIED OUT A THOUGHTFUL
- 7 PROCESS IN THIS SELECTION.
- 8 DR. HENDERSON: I SUPPORT THAT. GOOD IDEA.
- 9 CHAIRMAN KLEIN: OKAY. LET'S FIND OUT IF WE
- 10 HAVE ADDITIONAL COMMENTS. HAS UCLA BEEN ABLE TO PROVIDE
- 11 COMMENT?
- MS. KING: YES.
- 13 CHAIRMAN KLEIN: OKAY. ARE THERE ANY OTHER
- 14 SITES THAT HAVE BOARD COMMENTS TO THIS POINT?
- DR. BIRGENEAU: BOB BIRGENEAU AT BERKELEY. I
- 16 HAVE ACTIVE EXPERIENCE EITHER HAVING HIRED OR BEEN
- 17 RECRUITED BY THREE OF THE FIRMS, WHICH ARE THE THREE THAT
- 18 HAVE BEEN MENTIONED ALREADY. I ACTUALLY HAVE A DIFFERENT
- 19 RANK ORDERING BASED ON MY EXPERIENCE THAN I'VE HEARD ON
- THE TELEPHONE. I DON'T BELIEVE ONE STANDS OUT; AND,
- 21 THEREFORE, I WOULD BE -- WELL, I ACTUALLY DO BELIEVE ONE
- 22 STANDS OUT, BUT IT'S A DIFFERENT ONE. SO, THEREFORE, YOU
- 23 KNOW, I THINK YOUR IDEA, BOB KLEIN, IS EXCELLENT. AND I
- 24 THINK WE SHOULD TALK TO AT LEAST TWO. MY AT LEAST TWO
- WOULD BE SPENCER STUART AND A. T. KEARNEY, BUT I'M NOT

- 1 OPPOSED TO ISAACSON MILLER EITHER.
- I THINK IF WE WERE ABLE TO MEET WITH THEM IN
- 3 PERSON ON FEBRUARY 3D, I THINK THAT WOULD JUST BE
- 4 EXCELLENT.
- 5 MS. LANSING: WILL THEY COME TO A PUBLIC
- 6 SESSION AND PRESENT THEIR THINGS?
- 7 CHAIRMAN KLEIN: MY EXPECTATION WOULD BE THAT
- 8 THEY WOULD BE HAPPY TO.
- 9 MS. LANSING: GREAT.
- 10 CHAIRMAN KLEIN: I CANNOT GUARANTEE THAT
- 11 BECAUSE I HAVE NOT TALKED WITH THEM ABOUT THAT. THIS IS
- 12 AN EXTEMPORANEOUS CONCEPT TO IMPROVE OUR MODEL.
- DR. PIZZO: WE SHOULD ASSUME, OF ALL THE
- 14 POSITIONS IN THE COUNTRY RIGHT NOW, SHORT OF A NORTHEAST
- 15 SCHOOL, THIS MAY BE ONE OF THE MOST IMPORTANT POSITIONS
- 16 OUT THERE. AND THE WHOLE COUNTRY IS GOING TO BE LOOKING
- 17 AT THIS. IF I WERE A SEARCH FIRM, THIS WOULD BE A REAL
- 18 PLUM TO BE INVOLVED IN, AND THEY WOULD WANT TO HAVE THIS
- 19 ON THEIR BANNER GOING FORWARD. SO OUR EXPECTATION IS
- 20 THAT THEY SHOULD BE HERE TO SERVE THE CITIZENS OF
- 21 CALIFORNIA.
- 22 CHAIRMAN KLEIN: OKAY. IN THAT CONTEXT, IS
- 23 THERE A CONSENSUS ON THIS CALL THAT THE THREE FIRMS THAT
- 24 HAVE -- IF THERE IS A CONSENSUS ON THIS CALL, THE THREE
- 25 FIRMS THAT HAVE BEEN MENTIONED SHOULD BE SELECTED TO MAKE

- 1 THAT KIND OF A PRESENTATION, I WOULD WONDER IF WE COULD
- 2 HAVE A MOTION AND THEN ADDRESS SOME VERY SPECIFIC
- 3 SUBJECTS THAT YOU WOULD LIKE TO HAVE THEM FOCUS ON
- 4 IN-DEPTH AT THAT MEETING.
- DR. HENDERSON: HENDERSON. SO MOVED.
- 6 DR. WRIGHT: SECOND.
- 7 CHAIRMAN KLEIN: SECOND FROM DR. WRIGHT. IS
- 8 THERE -- I'D LIKE TO --
- 9 DR. KESSLER: BOB, I WONDER WHETHER THE
- 10 FEBRUARY 3D MEETING --
- 11 CHAIRMAN KLEIN: YES. YOU WERE WONDERING IF
- 12 THE FEBRUARY 3D MEETING --
- 13 DR. KESSLER: THERE WAS A LOT OF NOISE ON THE
- 14 PHONE. I WAS WONDERING, I THINK IT WAS MICHAEL, IF I'M
- 15 CORRECT, LAID OUT CERTAIN CRITERIA THAT I FOUND HELPFUL
- 16 THIS MORNING. I THINK YOU AMENDED IT A LITTLE. I WONDER
- 17 WHETHER AT OUR PLACES YOU CAN GIVE US THAT SHEET SO THAT,
- 18 AS WE LISTEN TO THE PRESENTATIONS, IN OUR OWN MINDS WE
- 19 CAN RANK EACH OF THOSE CRITERIA SO WE HAVE A BASIS UPON
- 20 WHICH TO MAKE OUR DECISION?
- 21 CHAIRMAN KLEIN: I THINK THAT'S A GOOD IDEA.
- 22 BUT MY THOUGHT WAS WE WOULD GO TO CRITERIA IMMEDIATELY
- 23 AFTER IDENTIFYING THE THREE FIRMS.
- DR. KESSLER: ABSOLUTELY. I'M SORRY IF I'M OUT
- 25 OF ORDER HERE.

- 1 CHAIRMAN KLEIN: YOU'RE NEVER OUT OF ORDER. I
- 2 WOULD LIKE TO KNOW, BEFORE WE HAVE A VOTE ON THIS, SINCE
- 3 THE PUBLIC HAS HEARD THE BOARD COMMENT, ASK FOR PUBLIC
- 4 COMMENT. STARTING AT STANFORD, ANY PUBLIC COMMENT?
- DR. POSNER: PHIL POSNER FROM OAK RIDGE
- 6 ASSOCIATED UNIVERSITIES. I THINK DR. GOLDBERG'S COMMENTS
- 7 FOR CRITERIA FOR RANKING SEARCH FIRMS, NOT CRITERIA FOR
- 8 THE PRESIDENT, HAVING A LIST OF THOSE WOULD BE VERY
- 9 USEFUL FOR EVERYBODY.
- 10 CHAIRMAN KLEIN: OKAY. I HOPE EVERYONE HEARD
- 11 THE COMMENT. PHIL POSNER FROM OAK RIDGE INDICATED THAT
- 12 MICHAEL GOLDBERG'S COMMENTS WERE FOR RANKING THE SEARCH
- 13 FIRMS, AND HE THOUGHT THOSE WOULD BE VERY USEFUL. ANY
- 14 OTHER COMMENTS FROM STANFORD?
- MR. SHOPPENHAUR: YOU MIGHT ALSO WANT TO LOOK
- 16 AT THE COMPENSATION SINCE THAT'S THE KEY MODEL THAT THE
- 17 FIRMS HAVE SUGGESTED. SPENCER STUART CAME FORWARD WITH A
- 18 FLAT FEE STRUCTURE, AND I BELIEVE THE OTHER TWO FIRMS
- 19 HAVE NOT, SO THERE'S A DIFFERENTIATOR HERE.
- 20 CHAIRMAN KLEIN: YOUR NAME?
- MR. SHOPPENHAUR: MIKE SHOPPENHAUR (PHONETIC).
- 22 CHAIRMAN KLEIN: MIKE SHOPPENHAUR. OKAY. ANY
- 23 PUBLIC COMMENTS FROM UC SAN FRANCISCO?
- DR. KESSLER: THERE ARE NONE.
- 25 CHAIRMAN KLEIN: FROM UC BERKELEY?

- 1 UNIDENTIFIED SPEAKER: NO COMMENTS.
- 2 CHAIRMAN KLEIN: OKAY. FROM UCLA?
- 3 MS. KING: NONE.
- 4 CHAIRMAN KLEIN: FROM USC?
- 5 DR. HENDERSON: NO.
- 6 CHAIRMAN KLEIN: OKAY. FROM BURNHAM?
- 7 UNIDENTIFIED SPEAKER: NONE.
- 8 CHAIRMAN KLEIN: OKAY. SEEING THAT WE HAVE
- 9 COVERED THE BOARD COMMENTS AND PUBLIC COMMENTS, I'D LIKE
- 10 TO CALL THE QUESTION. AND WE'RE GOING TO DO A ROLL CALL
- 11 VOTE THEN. STARTING WITH BRIAN HENDERSON.
- DR. HENDERSON: YES.
- 13 CHAIRMAN KLEIN: JANET WRIGHT.
- DR. WRIGHT: YES.
- 15 CHAIRMAN KLEIN: PHYLLIS PRECIADO.
- DR. PRECIADO: YES.
- 17 CHAIRMAN KLEIN: BOB BIRGENEAU.
- DR. BIRGENEAU: YES.
- 19 CHAIRMAN KLEIN: KEITH BLACK. SUSAN BRYANT.
- DR. BRYANT: YES.
- 21 CHAIRMAN KLEIN: MICHAEL GOLDBERG.
- MR. GOLDBERG: YES.
- 23 CHAIRMAN KLEIN: DR. DAVID KESSLER.
- DR. KESSLER: YES.
- 25 CHAIRMAN KLEIN: BOB KLEIN IS YES. SHERRY

- 1 LANSING.
- MS. LANSING: YES.
- 3 CHAIRMAN KLEIN: DR. RICHARD MURPHY.
- 4 DR. MURPHY: YES.
- 5 CHAIRMAN KLEIN: TINA NOVA.
- 6 DR. NOVA: YES.
- 7 CHAIRMAN KLEIN: DR. PHIL PIZZO.
- 8 DR. PIZZO: YES.
- 9 CHAIRMAN KLEIN: AND JOAN SAMUELSON IS ABSENT.
- 10 MS. KING: BOB, WE HAVE A REQUEST HERE AT UCLA.
- 11 IF YOU COULD PLEASE ANNOUNCE BY HOW MANY VOTES THE MOTION
- 12 IS CARRIED, THAT WOULD BE HELPFUL.
- 13 CHAIRMAN KLEIN: YES. ALL THE PARTIES THAT
- 14 VOTED VOTED YES. THERE WERE TWO ABSENCES, KEITH BLACK
- 15 AND JOAN SAMUELSON.
- 16 MS. KING: SO I BELIEVE THAT MAKES IT 12 YESES
- 17 AND TWO ABSENCES.
- 18 CHAIRMAN KLEIN: YES, THAT'S CORRECT.
- 19 MS. KING: THANK YOU.
- 20 DR. WRIGHT: BUT IT'S A UNANIMOUS CONSENT.
- 21 CHAIRMAN KLEIN: IT'S UNANIMOUS OF ALL THE
- 22 PARTIES PRESENT, AND THAT WAS TRUE OF THE FIRST MEASURE
- 23 AS WELL.
- MS. KING: THANK YOU.
- 25 CHAIRMAN KLEIN: OKAY. I BELIEVE THAT THAT

- 1 BRINGS US TO THE ISSUE OF IDENTIFYING CRITERIA FOR
- 2 OBJECTIVELY RATING THE FIRMS. DR. KESSLER, I THINK THAT
- 3 WAS YOUR POINT AND MICHAEL GOLDBERG'S POINT. MICHAEL,
- 4 WOULD YOU LIKE TO GO BACK THROUGH THOSE CRITERIA?
- 5 MR. GOLDBERG: CERTAINLY. FOR PURPOSES OF THE
- 6 BOARD'S CONSIDERATION AND MODIFICATION, THE FIRST WAS A
- 7 DEEP EXPERTISE IN LIFE SCIENCE, NOT FOR PROFIT, AND
- 8 DIVERSITY.
- 9 THE SECOND WAS A DEMONSTRATED UNDERSTANDING OF
- 10 THE ASSIGNMENT AND THE THOUGHTFULNESS OF THE SPECIFIC
- 11 PROPOSAL MADE.
- 12 THIRD WAS A HIGH QUALITY REPUTATION OF THE FIRM
- 13 TO BE ABLE TO ATTRACT THE BEST CANDIDATES.
- 14 FOURTH WAS THE EXPERTISE OF THE DESIGNATED
- 15 TEAM.
- 16 FIFTH WAS THE DEPTH OF THE FIRM. SO NOT JUST
- 17 THE IMMEDIATE TEAM ON THE SEARCH, BUT ALSO THE ACCESS
- 18 THEY HAVE WITHIN THE FIRM.
- 19 SIXTH RELATES TO THAT, WHICH IS THIS COMMITMENT
- 20 OF THE FIRM ITSELF. SO THAT WE HAVE A SENSE THAT NOT
- 21 ONLY ARE WE GOING TO HAVE THE DIRECT INVOLVEMENT OF
- WHATEVER TEAM IS ASSIGNED TO THE SEARCH, BUT THAT THEY
- 23 WILL, AS A HIGH PRIORITY WITHIN THE FIRM, HAVE ACCESS TO
- 24 ALL THE RESOURCES OF THE FIRM TO MAKE SURE THAT WE HAVE A
- 25 SUCCESSFUL EXPERIENCE.

- 1 CHAIRMAN KLEIN: IS THE QUESTION, MICHAEL,
- 2 UNDER THE EXPERTISE OF THE FIRM, I TAKE IT YOU WANT TO
- 3 KNOW THE EXPERTISE OF THE INDIVIDUALS AND THE COMMITMENT
- 4 OF THAT INDIVIDUAL IN TERMS OF THE TIME COMMITMENT TO THE
- 5 PROCESS?
- 6 MR. GOLDBERG: THAT'S CORRECT.
- 7 DR. PIZZO: ALSO, WOULD YOU CARE TO ADD THE
- 8 COST OF THE PROPOSAL OR THE FINANCIAL STRUCTURING?
- 9 MR. GOLDBERG: YES. ALTHOUGH GENERALLY MY WORK
- 10 TENDED TO BE FAIRLY COMPARABLE.
- DR. PIZZO: SINCE WE ARE USING STATE MONEY, WE
- 12 WANT TO BE ATTENTIVE.
- 13 MR. GOLDBERG: I WOULD AGREE WITH THAT.
- 14 CHAIRMAN KLEIN: I WOULD POINT OUT THAT THERE
- 15 IS A DIFFERENCE AS WELL -- THIS IS BOB KLEIN -- BETWEEN
- 16 THE PROPOSALS IN THAT SOME PROPOSALS MAKE AN AFFIRMATIVE
- 17 REPRESENTATION THAT THEY WILL NOT RECRUIT FROM THIS
- 18 INSTITUTE FOR A CERTAIN PERIOD OF TIME IN THIS POSITION.
- 19 AND THAT COULD BE A MATERIAL CONSIDERATION FOR US,
- 20 PARTICULARLY BECAUSE, IF WE HAVE THE BEST PEOPLE IN THE
- 21 COUNTRY, WE DO NOT WANT THE SAME FIRMS THAT WE JUST
- 22 DECIDED WERE THE BEST FIRMS IN THE COUNTRY TO COME BACK
- 23 AND RECRUIT FROM OUR FINE REPRESENTATIVES.
- DR. PIZZO: THERE IS ONE QUALIFIER TO THAT, IF
- 25 I COULD MAKE, AND OTHER'S EXPERIENCE MAY BE HELPFUL WITH

- 1 THIS. THIS IS PHIL PIZZO SPEAKING. MANY TIMES THESE
- 2 SEARCH FIRMS ALSO GIVE A SIMILAR GUARANTEE TO OTHER
- 3 INSTITUTIONS FROM WHOM THEY'VE PLACED PEOPLE. AND SO ONE
- 4 OF THE DOWNSIDES OF THE LARGE SEARCH FIRM THAT CARRY OUT
- 5 THESE VERY COMPLETED SEARCHES IS THAT THEY MAY NOT HAVE
- 6 THE ABILITY TO GO BACK TO SOME OF THE INSTITUTIONS THAT
- 7 WE'D MOST LIKE THEM TO GO BACK. SO WE JUST NEED TO BE
- 8 COGNIZANT OF THAT AS A NEGATIVE.
- 9 MR. GOLDBERG: I THINK THAT'S A VERY GOOD
- 10 POINT, AND PERHAPS WE COULD ADD THAT AS ONE OF THE
- 11 QUESTIONS FOR THEIR PRESENTATIONS IS WHAT RELEVANT
- 12 INSTITUTIONS MIGHT BE OFF LIMITS.
- DR. PIZZO: AND THE OTHER PART OF IT, MAYBE
- 14 ALONG THAT LINE, IS DO WE HAVE -- LOOK AT THE SEARCH FIRM
- 15 AS BOTH CARRYING OUT OUR BUSINESS, BUT ALSO BEING
- 16 ADVISORY TO THE PRESIDENTIAL SEARCH COMMITTEE AND THE
- 17 ICOC. THE REASON I'M RAISING THAT, AND, IN FACT, ONE OF
- 18 THE SEARCHES LISTED IN THE DOCUMENTS, THEY HAVE
- 19 THEMSELVES LISTED IN A CONSULTING ROLE. AND THE REASON
- 20 IS SHOULD WE, THAT IS, MEMBERS OF EITHER THE ICOC, THE
- 21 SEARCH COMMITTEE, OR THE PUBLIC, COME UP WITH NAMES OR
- 22 ANY NAME OF AN INDIVIDUAL WHO HAPPENS TO BE AT ONE OF THE
- 23 INSTITUTIONS THAT THE SEARCH FIRM "CAN'T GO BACK TO," IF
- 24 WE HAVE A CERTAIN DEGREE OF AUTONOMY, WE COULD GO BACK TO
- 25 THAT PERSON AND OPERATE INDEPENDENT OF THE SEARCH FIRM SO

- 1 THAT WE DON'T PRECLUDE REALLY THE BEST PEOPLE.
- 2 CHAIRMAN KLEIN: ALL RIGHT. THERE ARE CRITERIA
- 3 THAT HAVE BEEN PUT FORTH. I'D LIKE TO JUST GO THROUGH
- 4 AND ASK FOR AN ORDER OF COMMENT ON THOSE CRITERIA. WE'LL
- 5 START AT BURNHAM. WOULD YOU LIKE TO ADD, MODIFY, OR
- 6 OTHERWISE REINFORCE THOSE CRITERIA?
- 7 DR. BRYANT: I WOULD REINFORCE THEM. I THINK
- 8 THEY'RE EXCELLENT. I THINK MAYBE PEOPLE WILL PUT
- 9 DIFFERENT WEIGHTS ON THEM. YOU KNOW, THEY MIGHT NOT BE
- 10 IN THAT ORDER, ALTHOUGH THEY SEEM IN A GOOD ORDER TO ME.
- 11 CHAIRMAN KLEIN: AT USC IS THERE ANY COMMENT?
- DR. HENDERSON: I THINK THEY'RE EXCELLENT
- 13 CRITERIA.
- 14 CHAIRMAN KLEIN: OKAY. THAT'S BRIAN HENDERSON.
- 15 IF YOU WILL JUST IDENTIFY YOURSELF, IT WOULD BE HELPFUL,
- 16 DR. HENDERSON.
- 17 DR. HENDERSON: YES. BRIAN HENDERSON.
- 18 CHAIRMAN KLEIN: AND AT UCLA?
- MS. LANSING: WE THINK THEY'RE EXCELLENT. ALL
- 20 OF US HERE. THIS IS SHERRY LANSING.
- 21 CHAIRMAN KLEIN: THANK YOU, SHERRY. AND AT UC
- 22 BERKELEY?
- DR. BIRGENEAU: THEY'RE FINE.
- 24 CHAIRMAN KLEIN: AT UC SAN FRANCISCO?
- DR. KESSLER: CERTAINLY IN AGREEMENT. THE ONLY

- 1 POINT TO ADD MAY BE A LITTLE, THE EXPERTISE OF THE TEAM,
- 2 A LITTLE MORE ABOUT THE PERSON WHO REALLY WILL LEAD THE
- 3 TEAM AND BE RESPONSIBLE FOR THE SEARCH.
- 4 CHAIRMAN KLEIN: ALL RIGHT.
- DR. KESSLER: THAT WE REALLY LOOK AND NOTE WHO
- 6 WILL BE HEADING THAT UP.
- 7 CHAIRMAN KLEIN: OKAY. AND WHO IS SPEAKING?
- 8 DR. KESSLER: DAVID.
- 9 CHAIRMAN KLEIN: DR. KESSLER. AT STANFORD?
- 10 DR. PRECIADO: I'M WONDERING IF WE CAN HAVE
- 11 JUST A LITTLE BIT MORE COMMENT ON NO. 1, THE EXPERTISE IN
- 12 LIFE SCIENCE AND NOT FOR PROFIT, THE FIRST TWO? THAT'S
- 13 THE ONE THAT SORT OF I'M WONDERING ABOUT.
- 14 MR. GOLDBERG: IT'S MICHAEL GOLDBERG RESPONDING
- 15 TO THAT QUESTION. ONE OF THE THINGS THAT I TOOK OUT OF
- 16 THE PROPOSALS WAS THAT OF THE THREE THAT WE'RE
- 17 CONSIDERING IN PARTICULAR, THEY SHOWED VARYING DEGREES OF
- 18 DEPTH IN EACH OF THOSE AREAS. SOME OF THEM WERE FOCUSED
- 19 MORE ONE FACTOR TO THE OTHER. ONE, I THOUGHT, DID AN

- 25 SCIENCES. IN MY VIEW SOME OF THEM WERE BETTER ACROSS THE

- 1 RANGE OF THOSE SKILLS, BUT I THINK ALL OF THOSE SKILL
- 2 SETS ARE IMPORTANT, ALL THOSE CANDIDATE POOLS ARE
- 3 IMPORTANT FOR US TO ACCESS.
- 4 AND AT THE BEGINNING OF THE SEARCH, I CERTAINLY
- 5 WOULDN'T WANT TO PRECLUDE OUR ACCESS TO ALL OF THOSE

- 19 TODAY, FOR EXAMPLE, IT WOULD HAVE BEEN FEBRUARY 17TH. IF

- 23 WE NEED TO LOOK AT EASTER HOLIDAY TO MAKE SURE
- 24 WE'RE OUTSIDE OF THOSE. THAT'S RIGHT. IT'S THE NEXT
- 25 MONTH THAT WE HIT IT, RIGHT.

- 1 AND THAT REVIEW WOULD BE ON REFINED JOB
- 2 DESCRIPTION ON THE JOB CRITERIA, AND IT WOULD BE REVIEW
- 3 OF THE LONG LIST AS PROPOSED BY THE SEARCH FIRMS. I
- 4 WOULD SUGGEST CONVENING AGAIN A CALL TO CONSIDER THE
- 5 SHORT FORM CANDIDATES, PRIORITIZATION OF THOSE
- 6 CANDIDATES, AND TWO-PERSON INTERVIEW TEAMS BEING ASSIGNED
- 7 TO GO THROUGH THOSE IN-DEPTH. AND THAT WOULD BE
- 8 APPROXIMATELY FOUR WEEKS AFTER THE PRIOR MEETING.

- 25 COMMITTEE FIRMS, THEY COULD COMMENT ON WHETHER IT'S

- 1 REALISTIC IN THEIR PRESENTATION, WHETHER THEY WOULD
- 2 PROPOSE AN AMENDED PROCESS AS A PART OF THEIR

- 2 ARE THERE ANY OTHER BOARD COMMENTS AS TO THE
- 3 CONFIDENTIALITY ISSUE AND THE OPPORTUNITY OF THE PUBLIC
- 4 TO SUBMIT NAMES PUBLICLY, IF THEY SO CHOOSE? ARE THERE
- 5 ANY PUBLIC COMMENTS AS TO THAT FROM ANY OF THE SITES? I
- 6 DON'T HEAR --
- 7 DR. HENDERSON: I HAVE A PUBLIC COMMENT AT USC.
- 8 WOULD YOU IDENTIFY YOURSELF?
- 9 MR. MARTINEZ: MY NAME IS CHRIS MARTINEZ. I
- 10 JUST HAD A QUICK QUESTION. I THINK THIS WAS COVERED
- 11 EARLIER, BUT I JUST WANTED TO HAVE IT CLARIFIED. WILL --
- 12 IN THE SEARCH FOR THE PRESIDENT, ARE THE BOARD MEMBERS,
- 13 THE INSTITUTES THAT THE BOARD MEMBERS REPRESENT, ARE THEY
- 14 EXEMPT? ARE THEY GOING TO TAKE CANDIDATES FROM THE
- 15 INSTITUTES THAT BOARD MEMBERS REPRESENT?
- DR. HENDERSON: DID YOU HEAR THE QUESTION?
- 17 CHAIRMAN KLEIN: YES. THE QUESTION, AS I
- 18 UNDERSTAND IT, IS ARE THE SEARCH FIRMS GOING TO TAKE
- 19 CANDIDATES FROM INSTITUTES THAT THE BOARD MEMBERS
- 20 REPRESENT.
- DR. HENDERSON: THAT'S CORRECT.
- 22 CHAIRMAN KLEIN: I DON'T THINK THAT IS AN ISSUE
- 23 THAT HAS BEEN DEALT WITH. IT IS AN ISSUE THAT DR. PIZZO
- 24 WOULD LIKE TO ADDRESS.
- DR. PIZZO: THANK YOU, BOB. THAT WAS LIKE THE

- 1 HOT POTATO. BUT I THINK THAT WHAT I WAS GOING TO SAY IS
- 2 I THINK THE GREATER CONCERN FOR RESTRICTION REALLY IS THE
- 3 SEARCH FIRM'S INABILITY TO GO BACK TO INDIVIDUALS THAT
- 4 THEY MAY HAVE PLACED AT CERTAIN INSTITUTIONS. SO THAT IS
- 5 THE REASON I SAID IT EARLIER, THAT WE NEED TO HAVE AN

- 8 IT'S HARD FOR ME TO IMAGINE, GIVEN THE BREADTH
- 9 OF THE ICOC, THAT THERE WILL NOT BE CANDIDATES COMING
- 10 FROM SOME OF OUR OWN INSTITUTIONS. WE HAVE LIKELY
- 11 TERRIFIC PEOPLE AT THESE INSTITUTIONS. WE SURELY DON'T
- 12 WANT TO PRECLUDE THAT POSSIBILITY. I THINK WHAT HAPPENS
- 13 IS, WHEN IT COMES TO MAKING THE SELECTION, THERE NEEDS TO
- 14 BE THE OBVIOUS RECUSAL FROM THE WHOLE INSTITUTION IN
- 15 TERMS OF VOTING ON THAT CANDIDATE.
- 16 BUT I WOULD CERTAINLY HOPE THAT THERE WILL BE
- 17 INDIVIDUALS REPRESENTED FROM THE VARIOUS SCHOOLS,
- 18 WHOMEVER THEY MIGHT BE, OR OTHER RELATED ASSOCIATIONS
- 19 THAT WE ARE DEALING WITH AS PART OF THE ICOC LEADERSHIP.
- 20 DR. HENDERSON: HENDERSON AT USC. THE
- 21 INDIVIDUAL WHO MENTIONED THAT QUESTION IS NODDING
- 22 AFFIRMATIVELY TO YOUR SUGGESTION ABOUT THE RECUSAL.
- 23 CHAIRMAN KLEIN: THANK YOU. JUST SO THAT IT'S
- VERY CLEAR FOR THE PUBLIC AND THE PRESS, IT MAY BE
- 25 APPROPRIATE, ALTHOUGH THAT IS HIGHLY LOGICAL, FOR OUR

- 1 SEARCH COMMITTEE TO ADOPT A RECOMMENDATION THAT THE
- 2 RECUSAL WOULD OCCUR.
- 3 IS THERE ANYONE WHO WOULD LIKE TO MAKE A FORMAL
- 4 PROPOSAL TO THAT EFFECT?
- 5 DR. HENDERSON: HENDERSON AT USC. I PROPOSE
- 6 THAT WE ADOPT THAT AS ONGOING PROCEDURE, THAT IF A PERSON
- 7 FROM AN INSTITUTION OF A BOARD MEMBER IS BEING
- 8 CONSIDERED, THAT THAT BOARD MEMBER WOULD RECUSE
- 9 THEMSELVES FROM THE VOTING PROCESS.

- 5 APPOINTMENT AT AN INSTITUTION, BUT ARE NOT REPRESENTING
- 6 THE INSTITUTION AND ARE NOT AT THE EXECUTIVE LEVEL AT THE
- 7 INSTITUTION. IS THAT A CORRECT STATEMENT?
- 8 DR. PRECIADO: YES.
- 9 CHAIRMAN KLEIN: SO THE QUESTION IS IF SOMEONE
- 10 HOLDS A PART-TIME, LET'S SAY, CLINICAL APPOINTMENT OF ONE
- 11 DAY A WEEK AT AN INSTITUTION, SHOULD THAT BE GROUNDS FOR
- 12 RECUSAL IN THE DEFINITION OF THE RELATIONSHIP? I THINK
- 13 THAT'S OPEN FOR DISCUSSION.
- 14 DR. HENDERSON: HENDERSON AGAIN. I THINK IN
- 15 ORDER TO KEEP THINGS AS STRICT AS POSSIBLE, THAT WE
- 16 SHOULD PROBABLY EXCLUDE ANYONE WITH AN ASSOCIATION WITH
- 17 THE INSTITUTION INVOLVED.
- DR. PIZZO: I HAVE ACTUALLY THE SAME REACTION.
- 19 I MEAN I'M VERY SENSITIVE TO THE COUNTER PROPOSAL THAT
- 20 CAME FORWARD. BUT BECAUSE THIS COULD BE OPEN TO NUANCE
- 21 AND INTERPRETATION, I THINK IT'S BEST IF WE KEEP A VERY
- 22 TIGHT FIREWALL.
- MS. LANSING: LANSING HERE. WE HAVE ACTUALLY
- 24 FROM PUBLIC COMMENT SOMEBODY WHO'S SAYING THAT ACTUALLY
- 25 YOU ALMOST HAVE TO RECUSE YOURSELF FROM THIS DISCUSSION

- 1 AS WELL IF YOU ARE A MEMBER OF THE INSTITUTION. SO IT
- 2 GETS VERY COMPLICATED, BUT I THINK WHAT WE'RE ALL SAYING
- 3 IS -- THIS CAME FROM PUBLIC COMMENT -- I THINK WHAT WE'RE
- 4 ALL SAYING IS THAT WE WANT TO MAINTAIN THE HIGHEST
- 5 ETHICAL STANDARDS POSSIBLE SO THAT IF IN ANY WAY YOU'RE
- 6 ASSOCIATED WITH ANY OF THOSE INSTITUTIONS, IT'S JUST SAFE
- 7 TO RECUSE YOURSELF FROM THE DISCUSSION.
- 8 DR. PRECIADO: OKAY. SO THEN I WOULD LIKE THAT
- 9 TO BE INCLUDED IN THE PROPOSAL.
- 10 CHAIRMAN KLEIN: SO DR. PRECIADO IS ASKING THAT
- 11 THE PROPOSAL EXPLICITLY STATE THAT IF YOU HAVE ANY
- 12 FINANCIAL RELATIONSHIP OR ASSOCIATION OF A FORMAL NATURE
- 13 WITH THE INSTITUTION IN AN EMPLOYMENT RELATIONSHIP.
- DR. HENDERSON: MY MOTION IS SO AMENDED.
- 15 CHAIRMAN KLEIN: OKAY. THE FRIENDLY AMENDMENT
- 16 HAS BEEN TAKEN.
- 17 DR. KESSLER: POINT OF CLARIFICATION. I ASSUME
- 18 YOU WERE TALKING ABOUT CURRENT AFFILIATION.
- 19 CHAIRMAN KLEIN: AND INCLUDES VOLUNTARY
- 20 APPOINTMENTS TO A POSITION.
- DR. PIZZO: NO. NO. VOLUNTEER, THEY ARE NOT
- 22 PAID, THERE'S NO COMPENSATION. SO A PART-TIME CLINICAL
- 23 FACULTY MEMBER HAS AN ASSOCIATION BY WAY OF AN ACADEMIC
- 24 APPOINTMENT, BUT RECEIVES NO COMPENSATION FOR THAT
- 25 ACTIVITY.

- DR. PRECIADO: (INAUDIBLE) HAS TO COMPLY WITH X
- 2 NUMBERS OF HOURS PER ACADEMIC YEAR TO MAINTAIN THAT
- 3 CLINICAL APPOINTMENT.
- 4 CHAIRMAN KLEIN: OKAY. THIS IS AN EDUCATION
- 5 PROCESS FOR ME BECAUSE I'M NOT FAMILIAR WITH THIS. A
- 6 VOLUNTEER CLINICAL APPOINTMENT WOULD ALSO BE COVERED.
- 7 OKAY.
- 8 DR. BRYANT: ANOTHER QUESTION. WHAT ABOUT
- 9 MEMBERS OF BOARDS AT THAT INSTITUTION THAT MIGHT ON THE
- 10 ICOC?
- DR. HENDERSON: IT'S THE SAME. THEY SHOULD
- 12 RECUSE THEMSELVES.
- MS. LANSING: ABSOLUTELY.
- DR. KESSLER: ONE OTHER POINT OF CLARIFICATION.
- 15 I ASSUME WE'RE TALKING ABOUT CURRENT AFFILIATION, IF A
- 16 PERSON HAS BEEN IN THE PAST.
- 17 CHAIRMAN KLEIN: I THINK WE HAVE TO TALK ABOUT
- 18 CURRENT AFFILIATIONS BECAUSE FACULTY MEMBER MIGHT MOVE
- 19 BETWEEN UNIVERSITIES. THEY COULD HAVE BEEN AT THREE OR
- 20 FOUR IN THEIR LIFETIME.
- MS. LANSING: OTHERWISE YOU WON'T HAVE ANYBODY
- 22 ABLE TO VOTE ON ANYTHING.
- 23 CHAIRMAN KLEIN: OKAY. I THINK THE MOTION IS
- 24 UNDERSTOOD. ANY PUBLIC COMMENT ON THIS? WE HAVE PUBLIC
- 25 COMMENT FROM STANFORD?

- DR. POSNER: PHIL POSNER FROM OAK RIDGE, AND
- 2 IT'S A QUESTION OF CLARIFICATION. WOULD THEY RECUSE
- 3 THEMSELVES FROM VOTING ON THAT ONE INDIVIDUAL OR FROM
- 4 VOTING ON THE INDIVIDUAL THAT WAS APPLYING? BECAUSE IF
- 5 THEY HAVE AN ISSUE WITH ONE INDIVIDUAL, THERE IS THE
- 6 POSSIBILITY, TO USE THE PHRASE, "SANDBAG" THE INDIVIDUALS
- 7 WHEN VOTING. SO I THINK THE MOTION SHOULD CLARIFY IF
- 8 THEY'RE RECUSING FROM THE ENTIRE PROCESS THAT ONE
- 9 INDIVIDUAL.
- 10 MS. KING: IF WE AT THE UCLA SIDE COULD ASK DR.
- 11 POSNER JUST TO REPEAT THE FINAL PART OF THAT COMMENT,
- 12 PLEASE, THAT WOULD BE GREAT.
- 13 CHAIRMAN KLEIN: YEAH. DR. POSNER, COULD YOU
- 14 JUST APPROACH HERE.
- DR. POSNER: THE QUESTION WAS WHETHER THEY

- 11 CHAIRMAN KLEIN: DR. BLACK IS ABSENT. DR.
- 12 BRYANT.
- DR. BRYANT: YES.
- 14 CHAIRMAN KLEIN: MIKE GOLDBERG.
- MR. GOLDBERG: YES.
- 16 CHAIRMAN KLEIN: DR. KESSLER.
- 17 DR. KESSLER: YES.
- 18 CHAIRMAN KLEIN: BOB KLEIN IS YES. SHERRY
- 19 LANSING.
- MS. LANSING: YES.
- CHAIRMAN KLEIN: DR. MURPHY IS ABSENT; IS THAT
- 22 RIGHT? TINA NOVA.
- DR. NOVA: YES.
- 24 CHAIRMAN KLEIN: AND DR. PIZZO.
- DR. PIZZO: YES.

- 1 CHAIRMAN KLEIN: AND JOAN SAMUELSON IS ABSENT.
- 2 ALL RIGHT. WITH THAT BEING THE LAST ITEM
- 3 BEFORE WE CONVENE THE CLOSED SESSION, I BELIEVE WE NEED
- 4 TO MOVE TO CLOSED SESSION. AND SO WOULD THE COMMITTEE
- 5 MEMBERS PLEASE ADJOURN FOR THE -- OR WOULD THE PUBLIC, AS
- 6 IS APPROPRIATE AT EACH SITE, ADJOURN TO ANOTHER ROOM?

- 19 AND OTHER SIMILAR GROUPS THE FACT THAT WE ARE LOOKING FOR
- 20 AN ACTING PRESIDENT. AGAIN, THESE MEDICAL GROUPS WOULD
- 21 BE INVITED TO NOMINATE SOMEONE WITH OUTSTANDING
- 22 SCIENTIFIC CREDENTIALS WHO COULD BE A PHYSICIAN/SCIENTIST

- 6 THAT OF SCHEDULE. THERE IS A COMMENT, PUBLIC COMMENT,

- 8 DR. POSNER: THIS IS DR. POSNER FROM OAK RIDGE.
- 9 AND THE QUESTION IS WILL WHOEVER THE INTERIM PRESIDENT BE
