- 10 WEEK. THE CANDIDATE HAS ACTUALLY ACCEPTED CONTINGENT
- 11 ON ICOC APPROVAL, SO WE'LL BE DEALING WITH THAT LATER
- 12 THIS WEEK. AND I HOPE WE WILL HAVE A FACILITIES
- 13 OFFICER BY THE END OF THE WEEK.
- 14 FINALLY, WE HAVE ACTIVATED A SEARCH FOR CHIEF
- 15 LEGAL OFFICER AND ARE CURRENTLY INTERVIEWING SEVERAL
- 16 CANDIDATES FOR THIS POSITION, AND MY HOPE IS THAT WE'LL
- 17 BE ABLE TO MOVE FAIRLY QUICKLY ON THAT AS WELL.
- 18 THE NEXT ITEM I WANTED TO DISCUSS WAS THE
- 19 CIRM SPACE POLICY. AS YOU RECALL AT THE JUNE ICOC
- 20 MEETING, CIRM WAS DIRECTED TO DEVELOP A FORMAL PLAN FOR
- 21 INTERNAL SPACE MANAGEMENT AND OFFICE ASSIGNMENT THAT'S
- 22 BASED ON OUR PERSONNEL CLASSIFICATION SCHEME AND SALARY
- 23 STRUCTURE. WE HAVE DONE SO, AND I PRESENT IT HERE.
- 24 IT'S IN THE MATERIAL THAT YOU HAD GIVEN OUT TO YOU, AND
- 25 I DON'T KNOW HOW TO DESCRIBE WHAT PAGE IT'S ON, BUT

- 1 IT'S CALLED -- IT'S ITEM NO. 4 A, INTERNAL SPACE.
- 2 CHAIRPERSON LANSING: IT'S RIGHT BEHIND YOUR
- 3 NO. 4 TAB.
- 4 DR. HALL: RIGHT. AND THE BASIC ARRANGEMENT
- 5 OF THIS IS THAT WE HAVE THREE TYPES OF OFFICES, THOSE
- 6 WITH WINDOWS, THOSE THAT ARE INTERNAL, AND THOSE THAT
- 7 ARE OPEN, AND THAT ASSIGNMENT TO THEM IS LINKED TO
- 8 POSITION. IN SOME CASES THE NUMBER OF PEOPLE AT A
- 9 PARTICULAR LEVEL EXCEEDS THE NUMBER OF OFFICES OF A
- 10 PARTICULAR TYPE, AND IN THOSE CASES, THE PRESIDENT WILL
- 11 MAKE THE ASSIGNMENT IN CONSULTATION WITH THE RELEVANT
- 12 SUPERVISOR. AND THE OBJECT, OF COURSE, WILL BE TO KEEP
- 13 CONSISTENCY AND FAIRNESS AND ALSO TO TRY TO GROUP BY
- 14 FUNCTION WHERE POSSIBLE.
- WE HAVE ALREADY BEGUN TO IMPLEMENT THIS PLAN
- 16 WITH SEVERAL CHANGES IN OFFICE ASSIGNMENT AS A RESULT
- 17 AND OTHERS WHO WILL BE MADE IN THE NEXT WEEK OR SO.
- 18 NOW LET ME BRIEFLY INTRODUCE THE OTHER ITEMS
- 19 THAT WILL BE CONSIDERED IN THE REST OF THE MEETING. AS
- 20 YOU MAY KNOW, WE'VE HAD A VERY RIGOROUS AND DEMANDING
- 21 REVIEW OF OUR OPERATIONS BY THE STATE AUDIT OFFICE. IN
- 22 THE COURSE OF THE REVIEW -- AND LET ME SAY THIS HAS
- 23 GONE ON FOR SOME WEEKS, AND I'LL SAY A LITTLE BIT MORE
- 24 ABOUT IT ON THURSDAY -- BUT IT HAS BEEN -- WE HAVE PUT
- 25 A TREMENDOUS AMOUNT OF TIME AND EFFORT INTO MEETING THE

- 1 REQUESTS FOR INFORMATION OF THE AUDITORS.
- 2 IN THE COURSE OF THE REVIEW, THE AUDITORS
- 3 BROUGHT TO OUR ATTENTION SEVERAL WAYS IN WHICH OUR
- 4 POLICIES COULD BE IMPROVED TO HELP BRING THEM BETTER IN
- 5 LINE WITH PROPOSITION 71. THESE SUGGESTIONS WERE
- 6 ACTUALLY HELPFUL TO US. AND RATHER THAN WAIT FOR THE
- 7 FORMAL REPORT, WE HAVE DECIDED TO GO AHEAD AND
- 8 IMPLEMENT THE CHANGES IN POLICIES THAT AROSE OUT OF
- 9 THESE DISCUSSIONS. THESE POLICIES CONCERN HOW WE DO
- 10 OUR CONTRACTING AND THE POLICIES FOR CIRM AND WORKING
- 11 GROUP TRAVEL. AND IN ADDITION, IN THE COURSE OF THIS
- 12 DISCUSSION, WE WILL ASK THE GOVERNANCE SUBCOMMITTEE TO
- 13 RECOMMEND A CHANGE IN DELEGATION OF AUTHORITY FOR THE
- 14 TRAVEL POLICIES.
- 15 WE HAVE NOT YET PRESENTED TO YOU THE AMENDED
- 16 BUDGET FOR 2006-2007 THAT REFLECTS THE CHANGES AS A
- 17 RESULT OF THE GOVERNOR'S LOAN TO US. WITH LORI'S
- 18 RECENTLY JOINING US, WE HAVE BEEN ABLE TO GO AHEAD AND
- 19 DEVELOP THAT BUDGET, AND SHE WILL BE PRESENTING THAT
- 20 TODAY. SO WITH THAT BRIEF INTRODUCTION, I TURN IT BACK
- TO YOU, SHERRY, AS CHAIR, AND WE CAN MOVE ON TO OTHER
- 22 ITEMS ON THE AGENDA.
- 23 CHAIRPERSON LANSING: THANK YOU, ZACH. AND
- 24 AGAIN, THANK YOU FOR THE INCREDIBLE JOB YOU DID ON THE

- 5 SECTION 125290.3, THE INSTITUTE SHALL, EXCEPT WHERE
- OTHERWISE PROVIDED, BE GOVERNED BY THE COMPETITIVE
- 7 BIDDING REQUIREMENTS APPLICABLE TO UNIVERSITY OF
- 8 CALIFORNIA. OUR CURRENT POLICIES AND PROCEDURES FOR
- 9 CONTRACTING AT TIMES HAVE BEEN AMBIGUOUS AND OMIT A FEW
- 10 OF THE REQUIRED PROCEDURES AS DEFINED IN THE UNIVERSITY
- 11 OF CALIFORNIA BUSINESS AND FINANCE BULLETIN 34.
- 12 SO WE ARE SUGGESTING A FEW MAJOR CHANGES TO
- 13 OUR POLICIES. AND THEY INCLUDE, FIRST, AS IDENTIFIED
- 14 UNDER THE DESCRIPTION OF THIS ITEM, THE THRESHOLDS FOR
- 15 SOLICITATION. THE CURRENT POLICY READS THAT CONTRACTS
- 16 WITH INDEPENDENT CONTRACTORS OR CONSULTANTS ARE NOT
- 17 REQUIRED TO BE COMPETITIVELY BID. WE ARE SUGGESTING
- 18 THAT WE MOVE TO THE PROPOSED POLICY AS IDENTIFIED ON
- 19 PAGE 10, THE FOLLOWING REQUIREMENTS: THAT ANY CONTRACT
- 20 LESS THAN \$15,000, THE RESPONSIBLE ADMINISTRATIVE
- 21 OFFICIAL SHALL DETERMINE THAT PAYMENT IS REASONABLE FOR
- THE SERVICES TO BE PERFORMED.
- 23 ON YOUR ITEM YOU WILL SEE THAT I HAVE NOTED
- 24 WHAT WE'RE USING AS A DEFINITION OF REASONABLE PAYMENT.

- 1 AVAILABLE, BUT IS THE ONE WHICH OFFERS THE HIGHEST
- 2 VALUE TO CIRM.
- THEN ANYTHING OVER \$15,000 WILL NEED TO BE
- 4 COMPETITIVELY BID AS DEFINED IN BUSINESS AND FINANCE
- 5 PUBLICATION 34 FOR THE UNIVERSITY OF CALIFORNIA. WE
- 6 HAVE VERY CLEARLY SET FORTH A GRADATION OF WHAT WOULD
- 7 BE CONSIDERED A COMPETITIVE BID. SO ANYTHING BETWEEN
- 8 15 AND \$50,000, WE COULD SEEK A VERBAL BID SO THAT WE
- 9 WOULD HAVE THREE OR MORE VERBAL BIDS BASED ON THE SAME
- 10 SCOPE OF WORK. ANYTHING ABOVE \$50,000 WILL BE WRITTEN
- 11 COMPETITIVE BID PROCESS.
- 12 SECOND, WE'RE SEEKING A CHANGE TO THE
- 13 APPROVAL LEVELS FOR CONTRACTS AND INDEPENDENT
- 14 CONSULTING SERVICES. OUR CURRENT POLICY AS ADOPTED AS
- 15 OF JULY 5TH, 2005, STATES THAT THE ICOC SHALL HAVE
- 16 (DISTORTED TRANSMISSION) \$250,000. THE GOVERNANCE
- 17 SUBCOMMITTEE WOULD BE THE APPROVAL AUTHORITY FOR
- 18 ANYTHING BETWEEN A HUNDRED THOUSAND AND 250,000, AND
- 19 THE PRESIDENT CAN APPROVE INDEPENDENT CONSULTING
- 20 CONTRACTS UP TO \$100,000. CERTAINLY THIS IS DIFFERENT
- 21 THAN INTERAGENCY AGREEMENTS, WHICH THE PRESIDENT HAS
- 22 THE AUTHORITY FOR THE INITIAL CONTRACT AS WELL AS ANY
- 23 FILING AMENDMENTS OR EXTENSIONS.
- WE ARE PROPOSING THE CHANGES FOUND ON PAGE 11
- 25 WHICH WILL INCREASE THE DELEGATION OF AUTHORITY TO THE

- 1 PRESIDENT UP TO \$250,000. THE GOVERNANCE SUBCOMMITTEE
- 2 WOULD HAVE BETWEEN \$250,000 AND \$500,000. THE ICOC
- 3 WOULD APPROVE ANY CONTRACT ABOVE \$500,000. AND THE
- 4 INTERAGENCY AGREEMENTS REMAIN THE SAME.
- THE THIRD CHANGE THAT WE ARE PROPOSING IS THE
- 6 REPORTING REQUIREMENTS. CURRENTLY THE GOVERNANCE
- 7 SUBCOMMITTEE AS WELL AS THE ICOC IS GIVEN AN UPDATE AT
- 8 EVERY MEETING ON THE CURRENT CONTRACTS AND THEIR STATUS
- 9 AND ANY CHANGES THAT HAVE BEEN MADE. WE ARE PROPOSING
- 10 THAT THE GOVERNANCE COMMITTEE RECEIVE QUARTERLY REPORTS
- 11 ON THIS AND THAT THE ICOC RECEIVE AN ANNUAL REPORT.
- 12 AND THEN THE OTHER CHANGE IS THE TITLE
- 13 CHANGED BECAUSE THIS IS CERTAINLY JUST POLICY AND THAT
- 14 WE WILL HAVE OUR OWN INTERNAL CIRM PROCEDURE MANUAL.
- 15 SO WITH THAT, THE ONLY ADDITION THAT I WOULD
- 16 LIKE TO ADD BEFORE I OPEN IT UP FOR DISCUSSION IS I DO
- 17 WANT TO BRING YOUR ATTENTION TO PAGE 6 OF THIS ITEM.
- 18 AND THE DEFINITION OF RESPONSIBLE ADMINISTRATIVE
- 19 OFFICIAL. I'M SEEKING THIS RECOMMENDATION AND
- 20 APPROVAL. WE'RE ASKING THAT THE PRESIDENT OR THE CFAO
- 21 IS THE DESIGNATE BY THE ICOC FOR THE PURPOSE OF
- 22 APPROVING ANY INDEPENDENT CONSULTING AGREEMENT. SO, IN
- 23 FACT, WHAT WOULD HAPPEN IS THAT THE DELEGATED BODY
- 24 APPROVED THE CONSULTING AGREEMENT, THEN THE RESPONSIBLE

- MR. SERRANO-SEWELL: LORI. A VERY THOROUGH
- 25 REPORT. THANK YOU. SOMEONE IN THE UC SYSTEM OR ANY

- 1 STATE AGENCY THAT HAS COMPARABLE AUTHORITY TO ZACH'S
- 2 POSITION, THAT IS, SOMEONE WHO IS A PRESIDENT AND CHIEF
- 3 EXECUTIVE OFFICER OF THE STATE AGENCY OF THIS SIZE, AND
- 4 I KNOW THAT THERE'S -- WE'RE ALWAYS SEARCHING FOR
- 5 ANALOGIES AND OTHER LIKE AGENCIES. I'VE ALWAYS BEEN OF
- 6 THE OPINION WHEN IT CAME TO SETTING SALARIES AND OTHER
- 7 ITEMS, OTHER POLICY ITEMS, THAT THERE WERE, IN FACT,
- 8 OTHER AGENCIES THAT WE CAN LOOK AT. AND SO I WOULD ASK
- 9 IN THIS INSTANCE, SOMEONE THAT HAS ZACH'S COMPARABLE
- 10 SET OF RESPONSIBILITIES, IF WE CAN FIND --
- MS. HOFFMAN: I CAN GIVE YOU AN EXAMPLE.
- MR. SERRANO-SEWELL: -- SOMEBODY THAT HAS THIS
- 13 LEVEL OF AUTHORITY IN TERMS OF EXECUTING CONTRACTS
- 14 WITHOUT A TRUSTEE APPROVAL.
- MS. HOFFMAN: WELL, CERTAINLY I WILL FIRST
- 16 ANSWER FOR THE UNIVERSITY OF CALIFORNIA, AND THEN I
- 17 WILL TURN TO THE FINANCE OFFICER, MARCIA DAVIES, AND
- 18 ASK HER TO SPEAK TO THE RULES FROM STATE AGENCIES.
- 19 IN TERMS OF THE UNIVERSITY OF CALIFORNIA,
- 20 CERTAINLY CHANCELLOR HAS THE DELEGATED AUTHORITY FOR

- 2 OF GROUNDS AND BUILDINGS, IN CONCURRENCE WITH THE
- 3 PRESIDENT, HAS APPROVAL BETWEEN 10 AND 20 MILLION, AND
- 4 ANYTHING OVER \$20 MILLION IS APPROVED BY THE BOARD, BY
- 5 THE REGENTS.
- 6 MS. DAVIES: THIS IS MARCY. I'M THE
- 7 (UNINTELLIGIBLE). MY EXPERIENCE AS THE FINANCE OFFICER
- 8 FOR THE BOARD OF EQUALIZATION AND THE EXECUTIVE
- 9 DIRECTOR, WHICH WOULD BE COMPARABLE TO OUR PRESIDENT,
- 10 HAD AUTHORITY UP TO A MILLION DOLLARS. FOR ANY
- 11 CONTRACT AFTER THAT, ANYTHING WENT TO THE BOARD.
- 12 IN SMALLER AGENCIES SOMETIMES IT COMES DOWN
- 13 TO GENERALLY ANYWHERE FROM A HALF A MILLION TO A
- 14 MILLION IS WHAT AN EXECUTIVE DIRECTOR WOULD HAVE
- 15 AUTHORITY FOR.
- MR. SERRANO-SEWELL: OKAY.
- 17 CHAIRPERSON LANSING: OKAY. STANFORD?
- DR. PIZZO: NO COMMENTS.
- 19 CHAIRPERSON LANSING: ANYTHING -- WE'LL NOW
- 20 GO FOR PUBLIC COMMENT. SO I'LL START IN LOS ANGELES.
- MR. SIMPSON: JOHN SIMPSON, FOUNDATION FOR
- 22 TAXPAYER AND CONSUMER RIGHTS. FIRST, VERY QUICKLY,
- 23 EVERYONE HAS BEEN DOING SUCH A WONDERFUL JOB OF GETTING
- THESE DOCUMENTS UP AND AVAILABLE, WE WERE VERY
- 25 DISAPPOINTED TODAY HOWEVER. YOU SEEM TO HAVE BROKEN

- 1 YOUR PAST GOOD PRACTICE. THESE WERE ONLY AVAILABLE
- 2 TODAY. NOW, THAT MAY HAVE BEEN SIMPLY BECAUSE OF THE
- 3 SPLENDID WORK DONE LAST WEEK AND WE UNDERSTAND IT. BUT
- 4 I, FOR THE RECORD, WANT TO JUST NOTE THAT IT'S TOUGH TO
- 5 UNDERSTAND WHAT'S AT STAKE WHEN THE DOCUMENTS AREN'T
- 6 AVAILABLE.
- 7 READING QUICKLY THROUGH THIS, YOU MADE
- 8 REFERENCE --
- DR. HALL: JOHN, MAY I JUST ANSWER QUICKLY.
- 10 WE APPRECIATE THAT COMMENT, AND WE WILL -- AS YOU KNOW,
- 11 WE REALLY TRY TO DO OUR BEST. THE TWO ISSUES WERE THAT
- 12 WE HAD THIS BACK-BREAKING EVENT LAST WEEK, WHICH TOOK
- 13 MOST PEOPLE OUT. THE OTHER IS LORI IS NEW AND HAS BEEN
- 14 DOING HER BEST TO GET UP TO SPEED AND HAS BEEN DOING A
- 15 FANTASTIC JOB, BUT STILL IN ALL, SHE HAS STARTED FROM
- 16 GROUND ZERO ON THIS. AND SO WE HAVE BEEN WORKING VERY

- 24 AS CLOSE TO OUR GOVERNANCE COMMITTEE SO THAT IT GIVES
- 25 YOU A LITTLE BIT OF BREATHING ROOM, DO YOU KNOW, IN THE

- 1 FUTURE.
- 2 MR. SIMPSON: ON THE SUBSTANCE OF THIS, YOU
- 3 START OFF WITH REFERENCE TO OUR AUGUST 5TH ICOC
- 4 MEETING. IN FACT, THERE WAS NO SUCH MEETING. I
- 5 BELIEVE IT WAS AUGUST 2D. AND THEN THERE'S REFERENCE
- 6 ALSO TO A GOVERNANCE SUBCOMMITTEE MEETING ON JULY 29TH,
- 7 AND I KNOW THERE WASN'T ONE AT ALL. NO GOVERNANCE
- 8 COMMITTEE MEETING SINCE, I BELIEVE, MAY.
- 9 THEN ON THE CONTRACTING POINT, SPELLING THAT
- 10 OUT, THAT TO ME IS A WONDERFUL IMPROVEMENT AND SPELLS
- 11 THINGS OUT EXPLICITLY. AND THE NOTION OF REASONABLE
- 12 PAYMENT IS VERY GOOD. I MEAN THAT, I THINK, COULD
- 13 FORESEE A SITUATION WHERE SAY SOMEBODY LIKE BETH DRAIN
- 14 MIGHT NOT HAVE THE LOWEST BID, BUT (INTERFERENCE IN
- 15 TRANSMISSION) COULD CONTINUE TO BE A PROVIDER.
- 16 I THINK THAT THE LEVELS ARE PERFECTLY FINE.
- 17 THE (INTERFERENCE), BUT I WONDER WHETHER IT WOULD NOT
- 18 BE MORE APPROPRIATE TO KEEP REPORTING TO EACH
- 19 GOVERNANCE COMMITTEE THAT MEETS. I WOULD SUSPECT THAT
- 20 WOULD BE IN THE NEIGHBORHOOD OF SIX TIMES A YEAR.
- 21 THAT'S NOT THAT MUCH DIFFERENT THAN QUARTERLY, AND IT
- 22 IS A VALUABLE THING FOR PEOPLE TO SEE AS IT UNFOLDS, I
- 23 WOULD THINK.
- 24 SO I WOULD BE VERY MUCH IN SUPPORT OF THE
- 25 FIRST AND THE SECOND PROPOSALS HERE, BUT I HAVE

- 1 QUESTIONS ABOUT THE ADVISABILITY OF THE THIRD IN
- 2 CHANGING YOUR REPORTING REQUIREMENTS. THANK YOU.
- 3 DR. HALL: COULD I COMMENT ON THAT?
- 4 CHAIRPERSON LANSING: YES.
- 5 DR. HALL: FIRST OF ALL, JOHN, THESE ARE 2005
- 6 DATES AT THE BEGINNING. IT'S AUGUST 5TH, 2005.

- 9 DR. HALL: YES.
- 10 MR. SERRANO-SEWELL: -- THERE WAS SOME
- 11 GENERAL DISCUSSION ABOUT HAVING A WORKSHOP OR SYMPOSIUM
- 12 OR SOMETHING ALONG THE WORKING GROUP LEVEL TO DO ITS
- 13 DUE DILIGENCE AND HAVING A GREATER UNDERSTANDING OF
- 14 WHAT IT NEEDS TO DO. IN PART, WE WERE SORT OF -- WE
- 15 COULDN'T COME TO ANY FIRM CONCLUSIONS BECAUSE LORI
- 16 HADN'T OFFICIALLY COME ON BOARD YET, AND I DON'T KNOW
- 17 WHERE WE WERE WITH HAVING A LIAISON OFFICER AS FAR
- 18 DOWNSTREAM AS WE ARE NOW. DOES THIS LINE ITEM INCLUDE
- 19 A POSSIBLE SYMPOSIUM OR WORKSHOP AROUND THE LINES OF
- 20 THE SCIENTIFIC SYMPOSIUM THAT WE HAD IN SAN FRANCISCO?
- 21 I'M NOT SUGGESTING THAT WE NEED A TWO AND A HALF DAY
- 22 BECAUSE I KNOW IT'S A LOT OF STAFF WORK, BUT I THINK

- 17 LAST WEEK. AT ANY RATE, LET'S DISCUSS IT FURTHER WITH
- 18 RUSTY AND WITH THE WORKING GROUP, AND THEN WE WILL BE

- 4 MR. KLEIN: RIGHT. SO YOU WENT THROUGH THE
- 5 DISCUSSION WE HAD EARLIER TODAY --
- 6 MS. HOFFMAN: YES.
- 7 MR. KLEIN: -- ON THIS ITEM?
- 8 MS. HOFFMAN: YES, I DID.
- 9 MR. KLEIN: GREAT. OKAY. THANK YOU VERY
- 10 MUCH.

- 3 GOVERNING TRAVEL FOR CIRM STAFF AND WORKING GROUP
- 4 MEMBERS. THAT POLICY IS FOUND ON ATTACHMENT 1.
- 5 WE ARE ALSO SEEKING YOUR CONCURRENCE AND A
- 6 RECOMMENDATION TO THE ICOC FOR THE DELEGATION OF
- 7 AUTHORITY FOR THESE POLICIES.
- 8 SO THE BACKGROUND FOR BOTH THESE ITEMS ARE
- 9 SIMILAR. AND AS YOU CAN SEE FROM THE TWO AND A HALF
- 10 PAGES, THAT, IN FACT, THE ICOC, AS WELL AS THE
- 11 GOVERNANCE SUBCOMMITTEE, HAS SPENT AN INORDINATE AMOUNT
- 12 OF TIME ON TRAVEL POLICY. AND CERTAINLY IN HEALTH AND
- 13 SAFETY CODE SECTION 125290.45(B)(2), IT ALLOWS FOR ICO
- 14 MEMBERS TO BE REIMBURSED FOR THE REASONABLE AND
- 15 NECESSARY TRAVEL AND OTHER EXPENSES INCURRED IN THE
- 16 PERFORMANCE OF THE MEMBER'S DUTIES. SO I WANTED TO SAY
- 17 HERE THAT THESE PROPOSED TRAVEL POLICIES ARE NOT FOR
- 18 ADOPTION FOR ICOC MEMBERS. THE STAFF IS RECOMMENDING
- 19 THAT THESE PROPOSED POLICIES BE FOR CIRM STAFF AND
- 20 WORKING GROUP MEMBERS. IT'S NOT PROPOSED THAT THE ICOC
- 21 MEMBERS WOULD WANT TO APPROVE THIS OR NOT.
- 22 SO HAVING SAID THAT, I DO WANT TO SAY THAT
- 23 THE RATIONALE FOR USING UC POLICY IN EVERY CASE WHERE
- 24 APPLICABLE I BELIEVE IS STRAIGHTFORWARD AND CONSISTENT
- 25 AND CERTAINLY WILL BE JUSTIFIABLE IN ANY AUDIT.

- 1 SO WE ARE PROPOSING THE CHANGES TO OUR
- POLICY, AND THEY ARE, AGAIN, FAIRLY CONSISTENT, BUT
- 3 JUST HAVE CLARIFIED AMBIGUITIES THAT EXISTED IN THE
- 4 PREVIOUS POLICY. FOR EXAMPLE, THERE IS A SECTION ABOUT
- 5 AIR TRAVEL, AND WE HAVE CLARIFIED HERE THAT STATE RATES
- 6 NEED TO BE EXHAUSTED FIRST BEFORE WE WOULD SEEK ANY
- 7 COACH REFUNDABLE TICKETS. AND THAT ONLY IN THE CASE OF
- 8 AN EXCEPTION CAN A STAFF OR WORKING GROUP MEMBER FLY
- 9 BUSINESS CLASS.
- 10 WE ALSO HAVE CLARIFIED SOME AMBIGUITIES
- 11 AROUND PER DIEMS, MEALS COST, AS WELL AS WE'VE
- 12 ADOPTED -- WE ARE PROPOSING A POLICY THAT ALLOWS FOR
- 13 SURFACE TRAVEL IN LIEU OF AIR TRAVEL; HOWEVER, THESE
- 14 COSTS SHALL NOT EXCEED THE COST OF AIRFARE BASED ON
- 15 STATE RATE OR THE REGULAR COACH FARE. SO IN EVERY
- 16 CASE, IF THIS POLICY IS APPROVED AND THEN RECOMMENDED
- 17 TO THE ICOC FOR APPROVAL, IN EVERY CASE CIRM STAFF AS
- 18 WELL AS WORKING GROUP MEMBERS WOULD ALWAYS SEEK THE
- 19 LEAST POSSIBLE FORM -- LEAST POSSIBLE COST OF FORM OF
- 20 TRAVEL.
- 21 AND WITH THAT, I'LL OPEN THIS UP FOR
- 22 QUESTIONS.

- 6 MIGHT BE TREATED DIFFERENTLY.
- 7 CHAIRPERSON LANSING: WELL, LET'S ASSUME THAT
- 8 UNLESS THERE'S A REASON IT WILL BE PART OF IT; AND IF
- 9 THERE'S A REASON, YOU'LL COME BACK TO US AND TELL US.
- DR. HALL: SURE.
- 11 CHAIRPERSON LANSING: IN L.A., JOHN?
- MR. SIMPSON: JUST A QUESTION TO CLARIFY. IN
- 13 READING THROUGH ALL OF THIS, IT LOOKED TO ME AS THOUGH

- 6 KNOW WHY. SO --
- 7 DR. HALL: THAT'S THE OLD POLICY.
- 8 MS. HOFFMAN: THAT'S THE OLD POLICY.
- 9 MR. KLEIN: I UNDERSTAND. I'M JUST SAYING IN
- 10 THE NEW POLICY LET'S JUST MAKE THAT TRANSITION. I'M
- 11 JUST REFERRING TO THAT.
- MS. HOFFMAN: RIGHT. BUT, YOU KNOW, IN THE
- 13 NEW POLICY, WE DON'T -- WE DON'T IDENTIFY ANY SPECIFIC

- 16 USE COACH REFUNDABLE.
- 17 MR. KLEIN: OKAY. WELL, THE OLD POLICY STILL
- 18 AFFECTS ICOC MEMBERS, AND SO WE NEED TO PICK UP ORANGE
- 19 COUNTY AIRPORT FOR ICOC MEMBERS. BUT WITH THAT
- 20 COMMENT, WE CAN GO FORWARD.
- 21 CHAIRPERSON LANSING: OKAY. I DON'T THINK
- 22 IT'S A BIG DEAL, BUT I HEAR WHAT YOU'RE SAYING. WE ALL
- 23 HEAR WHAT YOU'RE SAYING. I THINK WHAT THEY'RE SAYING
- 24 IS THEY'RE NOT IDENTIFYING ANY AIRPORT AND THEY'RE
- 25 MAKING IT A BROADER POLICY. BUT NEVERTHELESS, WE STAND

- 1 NOTICED THAT WE SHOULD INCLUDE ORANGE COUNTY.
- 2 LORI, WILL YOU PLEASE LEAD US THROUGH AGENDA
- 3 ITEM 8, WHICH IS THE CONSIDERATION OF THE GOVERNANCE
- 4 SUBCOMMITTEE MISSION STATEMENT AND STANDING ORDERS.
- 5 MS. HOFFMAN: YES. SO WHAT THIS WILL DO IS
- 6 WITH THE DELEGATION OF AUTHORITY FOR THE PROPOSED
- 7 POLICY AND REGULATIONS GOVERNING TRAVEL FOR CIRM STAFF
- 8 AND WORKING GROUP MEMBERS, WHEN PRESENTED TO THE ICOC
- 9 ON THURSDAY AND, IF APPROVED, WHAT WE WILL DO IS GO
- 10 BACK AND REVISIT THE MISSION STATEMENT, ALSO PROVIDE
- 11 FOR THE ICOC AT THEIR FEBRUARY MEETING STANDING ORDERS
- 12 THAT INCORPORATE THE MISSION STATEMENT AS WELL AS THE
- 13 NEW DELEGATION OF AUTHORITY FOR TRAVEL, AND THEN SUBMIT
- 14 IT TO THE ICOC FOR APPROVAL.
- 15 SO THIS PARTICULAR ITEM IS IN THERE ONLY FOR
- 16 THE GOVERNANCE SUBCOMMITTEE TO REVIEW THE MISSION
- 17 STATEMENT; AND IF THERE ARE ANY ISSUES WITH IT, WE
- 18 WOULD LIKE TO INCORPORATE THAT INTO THE NEW STANDING
- 19 ORDERS THAT WE PROPOSE TO BRING FORWARD TO THE ICOC IN
- 20 FEBRUARY.
- 21 CHAIRPERSON LANSING: I THINK -- SO BASICALLY

- 7 USE CHAIRPERSON.
- DR. POMEROY: OKAY. SO WE CAN JUST AMEND IT

- 16 CHAIRPERSON LANSING: STANFORD?

- 18 CHAIRPERSON LANSING: IN L.A.?
- MR. SIMPSON: NO.
- 20 CHAIRPERSON LANSING: I DON'T THINK WE HAVE A
- 21 MOTION OR ANYTHING, SO WE DON'T NEED A ROLL CALL VOTE,
- 22 DO WE? THIS IS JUST AN INFORMATION ITEM.
- MS. DUROSS: CORRECT.
- 24 CHAIRPERSON LANSING: OKAY. THEN WE MOVE ON
- TO AGENDA ITEM 9. AND AGAIN, LORI, I'M GOING TO ASK

- 1 YOU TO INTRODUCE THIS TO US, WHICH IS THE CONSIDERATION
- OF ADMINISTRATIVE SUPPORT FOR THE PATIENT ADVOCATES.
- 3 AND THERE'S NO DOCUMENT FOR THIS AGENDA, BUT THIS IS
- 4 REALLY SOMETHING THAT WE NEED TO DISCUSS FOR FUTURE
- 5 MEETINGS.
- 6 MS. HOFFMAN: WELL, THIS WAS DISCUSSED AT
- 7 YOUR LAST GOVERNANCE SUBCOMMITTEE MEETING. AND AS YOU
- 8 CAN SEE AND WE TALKED ABOUT EARLIER, THE CHAIRPERSON OF
- 9 THE BOARD HAS PLACED THIS ON THE AGENDA. AND I KNOW
- 10 THAT THERE IS OTHER COMMENTS THAT POSSIBLY WE WOULD
- 11 LIKE TO MAKE, BUT PERHAPS, FIRST, I WOULD ASK THAT BOB
- 12 KLEIN COMMENT ON THIS.
- 13 MR. KLEIN: CERTAINLY. FOR THE LAST YEAR
- 14 WE'VE DISCUSSED SUPPORT FOR THE PATIENT ADVOCATES ON
- 15 THE BOARD WHO DON'T HAVE AN INSTITUTIONAL POSITION
- 16 WHERE THEY CAN GET SUPPORT WITHIN THE MISSION OF THE
- 17 INSTITUTION FOR WHICH THEY ARE A MEMBER. SO, FOR
- 18 EXAMPLE, WHETHER IT'S JOAN SAMUELSON OR DAVID
- 19 SERRANO-SEWELL OR JEFF SHEEHY OR ANY OF THE OTHER
- 20 PATIENT ADVOCATES THAT ARE IN AN ENVIRONMENT WHERE THEY
- 21 AS AN INDIVIDUAL HAVE NO INSTITUTIONAL SUPPORT, THE
- 22 BURDEN ON THE PATIENT ADVOCATES IS THE MOST INTENSE
- 23 BURDEN OF ANY OF THE MEMBERS OF THE BOARD. IN ADDITION
- 24 TO THE BOARD MEETINGS AND SUBCOMMITTEE MEETINGS, THEY
- 25 HAVE GENERALLY TWO OR MOST OF THEM HAVE THREE WORKING

- 1 GROUPS THAT THEY'RE ON.
- THIS IS GOING TO BE A PARTICULARLY INTENSE
- 3 EFFORT TO MAKE SURE THEY CAN GET THROUGH MATERIALS, DO
- 4 THEIR RESEARCH, HAVE THEIR ADMINISTRATIVE AND LOGISTIC
- 5 NEEDS MET, AS WELL AS HAVING A SUPPORTING RESEARCH
- 6 NEEDS MET FOR THEM TO FULFILL THEIR MEMBERSHIP IN THE
- 7 BOARD, THE SUBCOMMITTEES, AND THE WORKING GROUPS.
- 8 IN THE DISCUSSION OVER THE LAST YEAR ON
- 9 SEVERAL OCCASIONS, THE DISCUSSION WAS THAT WHEN WE, IN
- 10 FACT, HAD SUFFICIENT FUNDS, THAT WE WOULD SET ASIDE
- 11 ADMINISTRATIVE SUPPORT. NOW, IT HAS BEEN SUGGESTED TO
- 12 ME THAT THAT CAN BE MET BY A TEMP SERVICE, WHETHER IT'S
- 13 FOR JOAN SAMUELSON OR FOR ANY OTHER MEMBER OF THE
- 14 BOARD. I THINK THAT THAT DOES NOT, IN FACT, MEET
- 15 NEITHER THE INTENT NOR SUBSTANTIVELY THE NEEDS OF THE
- 16 PATIENT ADVOCATES ON THIS BOARD.
- 17 TEMP SERVICES, AS ANY OF US KNOW WHO HAVE
- 18 BEEN IN BUSINESS AND HAVE CONTRACTED WITH TEMP
- 19 SERVICES, ARE HIGHLY INCONSISTENT AS TO THE QUALITY.
- 20 AND IF YOU GET SOMEBODY OF HIGH QUALITY, IT'S GENERALLY
- 21 TEMPORARY WHILE THEY'RE LOOKING FOR A PERMANENT JOB.
- 22 SO THERE'S A LOT OF VOLATILITY, AND THERE'S A LOT OF
- 23 RETRAINING CONSTANTLY THAT GOES ON.
- 24 ADDITIONALLY, THE LEVEL OF CONFIDENTIALITY IS
- 25 HIGHLY QUESTIONABLE WITH SOMEONE FROM A TEMP SERVICE.

- 1 IT MAY BE VERY HIGH; IT MAY BE VERY LOW. AND FINALLY,
- THE LEVEL OF CONFLICTS AND THE ABILITY TO CHECK
- 3 CONFLICTS AND MAKE SURE THAT WE'VE PROPERLY CLEARED
- 4 THEM IS NOT READILY APPARENT. YOU BARELY KNOW THE
- 5 PERSON. IT'S VERY DIFFICULT AS THOSE TEMPS TURN OVER
- 6 TO KEEP UP WITH THAT -- WITH SEVERAL DIFFERENT TEMPS IN
- 7 DIFFERENT AREAS.
- 8 THE ALTERNATIVE THAT HAS BEEN DISCUSSED AND
- 9 WHICH ORIGINALLY HAD BEEN PROPOSED FOR LAST YEAR IS
- 10 THAT WHEN WE HAVE THE FUNDS, WE GIVE AN ALLOWANCE, A
- 11 FIXED ALLOWANCE. WHAT'S BEEN DISCUSSED IN THE LAST
- 12 COUPLE OF MONTHS IS UP TO \$1500 ON MONTH TO BE USED TO
- 13 PAY SOMEONE WHO WOULD BE HIRED AS A PART-TIME, LESS
- 14 THAN 20 HOURS A WEEK, ASSISTANT. IT WOULD BE ON A
- 15 STANDARD CONTRACT DEVELOPED BY OUR OUTSIDE LAW FIRM.
- 16 JAMES HARRISON WOULD DEVELOP A STANDARD INDEPENDENT
- 17 CONSULTANT CONTRACT. THEY WOULD ESSENTIALLY HAVE TO
- 18 SIGN A CONFIDENTIALITY AGREEMENT. THEY WOULD BE
- 19 CLEARED FOR CONFLICTS OF INTEREST, AND THEY WOULD BE
- 20 RECRUITED UNDER AN OFFERING BY OUR HUMAN RESOURCES
- 21 DEPARTMENT THAT WOULD NARROW IT DOWN TO FOUR OR FIVE
- 22 CANDIDATES, AND THEN THE INDIVIDUAL PATIENT ADVOCATE
- 23 WOULD REVIEW THAT PERSON.
- OFTENTIMES, FOR EXAMPLE, A GRADUATE STUDENT
- 25 MAYBE IN PUBLIC POLICY OR PUBLIC HEALTH OR SOME OTHER

- 1 RELATED PUBLIC POLICY AREA AT A UNIVERSITY MIGHT VERY
- 2 MUCH LIKE TO HAVE THIS KIND OF A POSITION AND HOLD IT
- 3 FOR AN EXTENDED PERIOD OF TIME, A YEAR OR TWO YEARS.
- 4 IF SOMEONE IS A VICE CHAIR OF A COMMITTEE, WHICH ONLY
- 5 AT THIS POINT IS DAVID SERRANO-SEWELL OR JOAN, THE
- 6 PROPOSAL WAS IT WOULD BE UP TO \$2,000 A MONTH BECAUSE
- 7 THERE COULD BE VERY INTENSE WORK, AND THE QUALITY OF
- 8 THE PERSON HANDLING THIS, TO REALLY BE ABLE TO MANAGE
- 9 THIS WORKLOAD, MAY NEED TO BE SIGNIFICANTLY HIGHER, BUT
- 10 THESE ARE UP TO AMOUNTS.
- 11 SO IN ORDER TO HAVE THE QUALITY OF THE PERSON
- 12 CONTROLLED, THE CONFIDENTIALITY CONTROLLED, THE
- 13 CONFLICTS CONTROLLED, AND PREDICTABLE AND RELIABLE
- 14 PEOPLE THAT YOU DON'T HAVE TO CONSTANTLY RETRAIN
- 15 SUGGESTED THAT WE NOT USE A TEMP SERVICE BECAUSE I
- 16 DON'T THINK -- I THINK THEY CAN BE MORE WORK THAN HELP.
- 17 AND SUBSTANTIVELY, I THINK THAT'S THE ONLY WAY YOU'RE
- 18 GOING TO GET THE QUALITY OF SUPPORT FOR THESE
- 19 INDIVIDUALS TO FULFILL THEIR FUNCTION.
- 20 CHAIRPERSON LANSING: BOB, I THINK YOU
- 21 PRESENTED IT VERY GOOD. WHAT I'D LIKE TO DO, SINCE I
- THINK THIS IS A VERY IMPORTANT ITEM, WHAT I'D LIKE TO
- DO IS GO AROUND AND GET THE BOARD COMMENTS AND
- 24 QUESTIONS, AND THEN TURN TO THE PUBLIC. AND I MYSELF
- 25 HAVE SOME QUESTIONS, BUT I'M GOING TO GO LAST. SO LET

- 1 ME GO BACKWARDS. WE JUST DID STANFORD, I ASSUME.
- 2 DAVID IN SAN FRANCISCO?
- 3 MR. SERRANO-SEWELL: THANKS, SHERRY. AND
- 4 THANK YOU, BOB, FOR BRINGING UP THIS ISSUE. IT HAS
- 5 BEEN PERCOLATING REALLY SINCE OUR FIRST MEETING OF THE
- 6 ICOC. AND A LOT OF PROPOSALS HAVE BEEN FLOATING
- 7 AROUND.
- FIRST OF ALL, WE'RE TALKING ABOUT THE PATIENT
- 9 ADVOCATE MEMBERS. THERE'S ONLY TEN. AND REALLY
- 10 THERE'S ONLY EIGHT THAT SERVE ON THE WORKING GROUP. OS
- 11 STEWARD AND LEON THAL HAVE DECIDED THAT, FOR WHATEVER
- 12 REASON, THEY'RE NOT SERVING ON THE WORKING GROUPS,
- 13 THEREBY, IN MY OPINION, INCREASING THE WORKLOAD OF THE
- 14 EIGHT REMAINING WORKING GROUP MEMBERS. AND ALL OF THEM
- 15 ARE SERVING REALLY WELL. IT'S A LOT OF TIME AND
- 16 EFFORT.
- 17 I LOOKED AT THE CALENDAR, PROJECTED CALENDAR,
- 18 FOR '07, FOR THIS NEXT CALENDAR YEAR, AND THERE'S
- 19 SOMETHING LIKE 20 TO 30 MEETINGS. I WAS STRICKEN WITH
- 20 THAT, BUT THAT WAS JUST SORT OF BASED ON THE '06
- 21 CALENDAR AND WHAT I THOUGHT THE '07 CALENDAR MIGHT LOOK
- 22 LIKE, ASSUMING ON THE GRANTS WORKING GROUP AND THE
- 23 FACILITIES WORKING GROUP. AND I KNOW THAT THERE'S SOME
- 24 ICOC MEMBERS THAT SERVE ON ALL THREE. SHERRY, I THINK
- 25 YOU SERVE ON ALL THREE WORKING GROUPS.

- 1 SO I THINK THE NEED -- SO WE'RE REALLY
- 2 TALKING ABOUT EIGHT PEOPLE, RIGHT. AND I THINK YOU CAN
- 3 NARROW THAT LIST A LITTLE BIT SMALLER. BOB, YOU
- 4 MENTIONED ME, YOU MENTIONED JOAN, JEFF, ALSO FRANCISCO,
- 5 YOU KNOW, I DON'T THINK HAS THAT KIND OF INSTITUTIONAL
- 6 SUPPORT.
- 7 MR. KLEIN: RIGHT. AND JANET WRIGHT DOESN'T
- 8 HAVE AN INSTITUTIONAL SUPPORT.
- 9 MR. SERRANO-SEWELL: SO, YOU KNOW, THERE IS
- 10 DEFINITELY A NEED THERE, AND IT'S GOT TO BE ADDRESSED.
- 11 WHETHER THIS IS THE BEST WAY TO GO ABOUT IT, AGAIN, I
- 12 THINK EACH ICOC MEMBER -- AND, BOB, YOU MAY HAVE
- 13 ALREADY DONE THIS, AND I KNOW FRANCISCO IS ONE OF THE
- 14 PEOPLE THAT PROPOSED THE STIPEND, WHICH YOU BASICALLY
- 15 PROPOSED. BUT I MEAN I THINK EACH -- I DON'T THINK
- 16 TAILORED FOR EACH ICOC MEMBER, THAT MIGHT BE TOO
- 17 CUMBERSOME, TOO MUCH WORK. AGAIN, YOU KNOW, I DON'T
- 18 KNOW IF I'D WANT TO BE RESPONSIBLE FOR DEALING WITH THE
- 19 STAFF PERSON. IT MIGHT BE JUST TOO DETAILED FOR ME.
- I KNOW THAT THERE ARE INSTANCES IN WHICH I DO
- 21 NEED HELP, WHETHER IT'S REVIEWING THE DOCUMENTS, WHICH
- 22 I, YOU KNOW, DO, WHETHER IT'S ASKING GENERAL QUESTIONS,
- WHETHER IT'S FEELING AS THOUGH I HAVE THE REAL
- 24 COMMITMENT AND INSTITUTIONAL SUPPORT FROM THE CIRM
- 25 LEADERSHIP. AND I THINK WE NEED TO EMBODY IT IN SOME

- 1 WAY.
- 2 SO THOSE ARE THE ONLY COMMENTS I HAVE RIGHT
- 3 NOW, SHERRY. I MEAN I'M REALLY INTERESTED IN KNOWING
- 4 WHAT SORT OF THE NON, IF YOU WILL, PATIENT ADVOCATES
- 5 MEMBERS THINK. WHERE ARE THEIR HEADS? WHAT DO THEY
- 6 THINK IS APPROPRIATE? AND CERTAINLY I DON'T WANT TO DO
- 7 IT LIKE, YOU KNOW, WE'RE GETTING MORE, THEY'RE GETTING
- 8 LESS. I DON'T WANT TO QUOTE THAT KIND OF SITUATION,
- 9 BUT IT IS JUST A LOT OF WORK. THERE'S NO WAY OF
- 10 GETTING AROUND IT. IT'S AN INORDINATE AMOUNT OF WORK
- 11 AT TIMES. I THINK EVERYBODY HAS REALLY STEPPED UP TO

- 15 JOLLA?
- 16 DR. MURPHY: THIS IS A TOUGH ONE. I MEAN I
- 17 HEAR DAVID, AND I ABSOLUTELY SYMPATHIZE WITH THE
- 18 CHALLENGES THAT HE AND THE OTHERS FACE. I GUESS
- 19 I'M -- BUT I GUESS I'M CONCERNED A LITTLE BIT ABOUT THE
- 20 NOTION THAT WE ARE ALL VOLUNTEERS ON THIS. AND THAT AS

- 1 FRAMEWORK OF WHAT I AS SOMEONE WITH INSTITUTIONAL
- 2 SUPPORT USES THAT INSTITUTIONAL SUPPORT FOR. AND
- 3 BASICALLY WHAT I USE IT FOR IS WHEN THE STUFF COMES
- 4 ACROSS ON THE E-MAIL, MY ASSISTANT PRINTS IT OUT AND
- 5 THEN PUTS IT ON MY DESK. SHE IS ALSO INVOLVED IN
- 6 SCHEDULING AND MAKING SURE MY SCHEDULE FITS THE ICOC
- 7 SCHEDULE AND ALL OF THESE MEETINGS THAT WE HAVE. BUT
- 8 THERE'S NOT MUCH ELSE THAT SHE DOES TO HELP ME FULFILL
- 9 MY RESPONSIBILITIES TO THIS.
- 10 SO I REALLY -- I'M NOT OPPOSED TO IT AT ALL,
- 11 SHERRY AND DAVID, BUT I'M STRUGGLING WITH IT. AND I
- 12 GUESS I COULD BENEFIT FROM THE -- FROM SOME MORE
- 13 CONVERSATION FROM OUR COLLEAGUES ON THE PHONE.
- MR. KLEIN: SHERRY, IF I CAN POINT OUT TO DR.
- 15 MURPHY FOR A MOMENT, THAT THE PATIENT ADVOCATES, AS
- 16 DAVID SUGGESTED, HAVE THIS COMPLETELY DIFFERENT LAYER
- 17 OF BURDEN. IN OTHER WORDS, JUST IN THE GRANT REVIEW
- 18 SESSION, THERE'S 230 APPLICATIONS FOR THE SEED MONEY,
- 19 THERE'S 78 APPLICATIONS FOR THE COMPREHENSIVE, THERE'S
- 20 THEN A WHOLE ADDITIONAL LAYER FOR THE SHARED LABS. AND
- 21 FACILITIES DURING THAT TIME PERIOD IS GOING TO BE
- 22 DEVELOPING EXTENSIVE APPLICATIONS, DEFINITIONS, AND
- 23 REVIEW PROCEDURES FOR MAJOR FACILITIES AS AN OVERLAY IN
- 24 ADDITION TO ANY OTHER RFP'S THAT COME THROUGH IN THAT
- 25 TIME PERIOD.

- 1 SO THE LEVEL OF PAPERWORK AND DOCUMENTS THAT
- 2 FLOW TO THESE MEMBERS IS SUBSTANTIALLY GREATER THAN THE
- 3 VERY HEAVY LEVEL THAT ALREADY FLOWS TO THE BOARD
- 4 MEMBERS IN THEIR FUNCTION ON THE BOARD AND THE
- 5 COMMITTEES.
- DR. MURPHY: I THINK THAT'S A VERY GOOD
- 7 POINT, BOB.
- 8 CHAIRPERSON LANSING: LET ME -- I THINK I
- 9 HAVE AN IDEA, BUT LET ME GO ON. IRVINE?
- 10 DR. STEWARD: I ACTUALLY WOULD MAYBE EVEN GO
- 11 SLIGHTLY IN THE OPPOSITE DIRECTION. I'M A BIT
- 12 CONCERNED ABOUT THE MANAGEMENT OF ALL OF THIS BEING
- 13 THROUGH CIRM. I UNDERSTAND THE RATIONALE FOR THAT, BUT
- 14 I THINK IT'S IMPORTANT THAT THE PATIENT ADVOCATES BE
- ABLE TO ARRANGE THESE THINGS, FOR ASSISTANCE IN THE WAY
- 16 THAT WORKS BEST FOR THEM. BY THE WAY, JUST FOR THE
- 17 RECORD, THE REASON THAT LEON AND I ARE NOT ON THESE IS
- 18 THAT WE'RE, IN ADDITION TO BEING PATIENT ADVOCATES,
- 19 ALSO UNIVERSITY OF CALIFORNIA EMPLOYEES.
- 20 AND SO I WONDER IF IT IS NECESSARY TO HAVE
- 21 THAT EMPLOYMENT PROCESS ENTIRELY COORDINATED BY CIRM.
- 22 THAT'S MY ONLY QUESTION. OTHER THAN THAT, I COMPLETELY
- 23 APPRECIATE THE ENORMOUS EXTRA WORKLOAD THAT THE OTHER
- 24 PATIENT ADVOCATES HAVE AND STRONGLY SUPPORT THEIR
- 25 HAVING THIS KIND OF ASSISTANCE.

- 1 CHAIRPERSON LANSING: SACRAMENTO?
- DR. POMEROY: FIRST OF ALL, I'M A STRONG
- 3 SUPPORTER OF THE PATIENT ADVOCATES THAT SERVE ON THE
- 4 SUBCOMMITTEES AND WORKING GROUPS HAVING ASSISTANCE. I
- 5 GUESS THE CHALLENGE IS IN THE BEST WAY TO ORGANIZE
- 6 THIS. THIS IS A LOT OF MONEY. I MEAN WE'RE TALKING
- 7 ABOUT \$200,000 A YEAR IF YOU MULTIPLY THINGS OUT. AND
- 8 SO I WAS THINKING THAT THERE'S A PERCEPTION PROBLEM
- 9 WITH THE FACT THAT WE MIGHT BE HIRING, QUOTE, PRIVATE
- 10 SECRETARIES FOR EACH OF THESE PEOPLE.
- 11 SO I'M GOING TO TALK ABOUT THE OTHER END OF
- 12 THE SPECTRUM, WHICH IS THAT I WONDER IF IT WOULD BE
- 13 MORE COST-EFFECTIVE TO HIRE TWO ADDITIONAL FULL-TIME
- 14 PEOPLE AT CIRM WHO WOULD BE AVAILABLE TO THE PATIENT
- 15 ADVOCATES TO PROVIDE THIS SUPPORT. THE REASON I JUST
- 16 BRING UP THIS OTHER OPTION IS DO WE NEED TO HAVE SIX OR
- 17 EIGHT PEOPLE FIGURING OUT WHICH MATERIALS NEED TO BE
- 18 DISTRIBUTED, OR DO WE WANT TO HAVE ONE PERSON FIGURING
- 19 IT OUT FOR SIX TO EIGHT PEOPLE? SO I'M STRONGLY IN
- 20 SUPPORT OF THIS CONCEPT. I THINK IT'S ABSOLUTELY
- 21 ESSENTIAL GIVEN THE INCREDIBLE CONTRIBUTION THAT THE
- 22 PATIENT ADVOCATES MAKE, AND I THINK WE'VE ASKED THEM
- 23 UNFAIRLY TO REALLY KICK IN A LOT OF THIS SECRETARIAL
- 24 SUPPORT. I JUST WANT TO TALK A BIT MORE ABOUT WHAT'S
- 25 THE BEST ORGANIZATIONAL STRUCTURE TO DELIVER THAT

- 1 SERVICE TO OUR PATIENT ADVOCATES.
- 2 MR. KLEIN: CLAIRE, THIS IS BOB. THERE USED
- 3 TO BE PEOPLE ON THE CHAIRMAN'S STAFF TO DEAL WITH
- 4 SUPPORT FOR THE PATIENT ADVOCATES. BUT IN THE
- 5 REDUCTION IN COST AND PERSONNEL, THOSE PEOPLE HAVE BEEN
- 6 ELIMINATED. SO WE NO LONGER HAVE THE ADDITIONAL
- 7 SUPPORT. NOW, THERE ARE, TO THE EXTENT WE HAVE FILL-IN
- 8 TIME BETWEEN VARIOUS, YOU KNOW, CRITICAL PATH ITEMS
- 9 LIKE BAN PURCHASES OR LITIGATION OR NUMEROUS OTHER
- 10 TASKS, THERE IS TIME WHERE INDIVIDUALS LIKE MELISSA
- 11 KING DOES LOGISTICS WORK FOR PATIENT ADVOCATES WHENEVER
- 12 POSSIBLE. THE PROBLEM IS THAT WITH THE NEW SCHEDULE
- 13 THAT'S COMING OUT AND WITH THE LEVEL OF SUPPORT THEY
- 14 NEED, INCLUDING, I THINK, THE ABILITY TO HAVE RESEARCH
- 15 SUPPORT WHEN NECESSARY TO REALLY FULLY DO THEIR JOB,
- 16 IT'S JUST GOING TO BECOME OVERWHELMING.
- 17 AND THE THOUGHT IS THAT THE ACTUAL NUMBER OF
- 18 PEOPLE THAT WILL NEED THIS ARE ABOUT HALF THE TOTAL, SO
- 19 IT GETS DOWN TO ABOUT A \$100,000 NUMBER.
- 20 DR. POMEROY: I CERTAINLY AGREE THAT THIS
- 21 SHOULD NOT BE DONE AS AN ADD-ON TO ANYONE'S JOB. BUT,
- 22 YOU KNOW, I JUST WANT TO THINK THROUGH THE FACT THAT,
- 23 YOU KNOW, 20 HOURS A WEEK IS A LOT OF TIME AND IT'S A
- 24 LOT OF MONEY, AND I WANT TO MAKE SURE WE'VE LOOKED AT
- 25 ALL THE MODELS AND MAKE SURE THEY MEET THE ADVOCATES'

- 1 NEEDS.
- MR. KLEIN: ABSOLUTELY. AND THAT'S A
- 3 MAXIMUM. THAT'S NOT -- THIS IS ONLY REIMBURSED UP TO
- 4 THAT AMOUNT.
- DR. HALL: COULD I MAKE A COMMENT ON THE --
- 6 CHAIRPERSON LANSING: YOU'RE NEXT. CARLSBAD
- 7 WAS NEXT. LET ME JUST KEEP TRYING TO DO THIS IN ORDER.
- 8 I KNOW THERE'S NO ONE THERE, SO YOU'RE NEXT.
- 9 DR. HALL: I JUST WANTED TO ANSWER
- 10 SPECIFICALLY CLAIRE'S POINT. LET ME SAY, FIRST OF ALL,
- 11 I THINK THIS IS -- THIS IS A REALLY IMPORTANT ISSUE.
- 12 WE WILL BE DOING, JUST FOR THE GRANTS REVIEW WORKING
- 13 GROUP, WE WILL BE DOING SIX TO 12 OF THESE A YEAR. AND
- 14 WE CAN ROTATE OUR SCIENTISTS, BUT THERE IS NO PROVISION
- 15 FOR PATIENT ADVOCATES. SO THE SAME PEOPLE WHO ARE
- 16 BEING CALLED ON ALSO TO BE ON THE FACILITIES WORKING
- 17 GROUP AND ALSO TO BE ON THE STANDARDS WORKING GROUP
- 18 HAVE TO ATTEND ICOC MEETINGS, THESE SAME PEOPLE ARE
- 19 THERE FOR EVERY REVIEW. SO THAT IS A TREMENDOUS BURDEN
- 20 AND WORKLOAD.
- 21 AND IT SEEMS TO ME THAT THE HELP NEEDS TO BE
- ON-SITE; THAT IS, WHO NEEDS TO ORGANIZE PAPERS AND
- 23 DOWNLOAD E-MAILS AND WORK OUT SCHEDULES AND DO THINGS
- 24 IS A PERSON IN HEALDSBURG OR A PERSON IN CHICO OR A
- 25 PERSON IN SACRAMENTO FOR FRANCISCO, NOT SOMEBODY HERE.

- 1 IT'S VERY DIFFICULT TO DO THAT. AND SO OUR IDEA WAS
- 2 THAT THE SENSIBLE WAY TO DO THIS WAS TO GET A SERVICE
- 3 THERE, EVEN TO THINK ABOUT US INTERVIEWING PEOPLE IN
- 4 HEALDSBURG. AND TRYING TO ARRANGE AND SUPERVISE THEM,
- 5 OR CHICO OR WHEREVER IT IS, BECOMES VERY, VERY
- 6 DIFFICULT. AND SO THE IDEA OF CONTRACTING WITH
- 7 SERVICES TO PROVIDE TEMPORARY HELP, AND THIS AMOUNTS TO
- 8 ESSENTIALLY A HALF-TIME JOB, SO THIS IS A REASONABLY
- 9 SUBSTANTIAL JOB. AND I THINK IT WOULD BE POSSIBLE TO
- 10 GET PEOPLE TO DO IT LONG-TERM. WE'VE HAD VERY ABLE
- 11 PEOPLE HERE AS TEMP HELP. AND I ALSO THINK THAT IT

- 24 I THINK, THE BIGGEST ISSUE.
- 25 I THINK THE OTHER ISSUE IS THAT AS WE OVERSEE

- 1 OUR -- LOOK AT OUR CIRM NEEDS WHEN WE GET GEARED UP, I
- THINK WE'RE GOING TO NEED EVERY POSSIBLE FTE WE CAN
- 3 HERE FOR JUST THE SCIENTIFIC ACTIVITIES AND THE OTHER
- 4 ACTIVITIES OF THE INSTITUTE. AND WHERE WE CAN CONTRACT
- 5 THINGS OUT, I THINK WE'RE GOING TO HAVE TO USE THAT AS
- 6 MUCH AS POSSIBLE, AND IT SEEMS TO ME THAT THIS IS A
- 7 GOOD PLACE AND WAY TO DO IT.
- 8 I THINK ONE ISSUE IS THE ISSUE OF WHETHER
- 9 WHAT'S NEEDED IS CLERICAL SUPPORT TO HELP WITH THE
- 10 MECHANICS OF ALL THIS VERSUS SOMETHING ELSE, WHICH
- 11 BECOMES A SORT OF DEPUTY OR HIGH LEVEL PERSON WHO I'M
- 12 NOT QUITE SURE WHAT AS A GRADUATE STUDENT DEVELOPS
- 13 POLICY PAPERS OR MAKES ANALYSES, DOES THOSE SORTS OF
- 14 THINGS. THAT, IT SEEMS TO ME, IS A DIFFERENT ISSUE,
- 15 BUT I THINK THE ISSUE OF PROVIDING CLERICAL SUPPORT FOR

- DR. POMEROY: SO THIS IS CLAIRE. JUST FOLLOW
- 22 UP. ZACH, BOTH YOU AND BOB MAKE SOME VERY CONVINCING
- 23 ARGUMENTS FOR ME. I TAKE IT THAT YOU HAVE TALKED TO
- 24 THE PATIENT ADVOCATES, AND THIS IS WHAT THEY WOULD
- 25 PREFER. HAVE WE DONE A SURVEY OF ALL OF THEM? DOES IT

- 1 WORK FOR THEM?
- DR. HALL: I THINK WE HAVE NOT CARRIED OUT
- 3 ANY FORMAL SURVEY ON THIS PART. WE'D BE HAPPY TO DO
- 4 THAT IF YOU WOULD LIKE.
- DR. POMEROY: SOUNDS LIKE --
- 6 DR. HALL: -- INDIVIDUAL NEEDS OF EACH PERSON.
- 7 CHAIRPERSON LANSING: I THINK --
- 8 MR. KLEIN: SHERRY. SHERRY.
- 9 CHAIRPERSON LANSING: YES.
- 10 MR. KLEIN: GO AHEAD. NO, PLEASE.
- 11 CHAIRPERSON LANSING: I WAS JUST GOING TO
- 12 KIND OF SUM UP. SO YOU WANT --
- DR. HENDERSON: BRIAN HENDERSON HERE AT KECK.
- 14 CAN I JUST --
- 15 CHAIRPERSON LANSING: SURE.
- DR. HENDERSON: -- HAVE A SHOT AT A COMMENT
- 17 BEFORE YOU SUM UP?
- 18 CHAIRPERSON LANSING: YES. EVERYONE SHOULD
- 19 TALK.
- DR. NOVA: TINA AS WELL AFTER BRIAN.
- DR. HENDERSON: YEAH. I CERTAINLY UNDERSTAND
- 22 THE NEED. I'M CONCERNED THAT THIS BE AS TIGHT A
- 23 PROCESS AS POSSIBLE TO PROTECT THE PATIENT ADVOCATES
- 24 BECAUSE THIS IS A -- YOU KNOW, THIS IS A POTENTIAL HOT
- 25 BUTTON IF THE WRONG PERSON JUST HAPPENS TO GET IN A

- 1 POSITION OF WHERE THEY HAVE ACCESS TO CONFIDENTIAL
- 2 MATERIAL THAT'S OTHERWISE, YOU KNOW, WITHIN A CLOSED
- 3 TIGHTER LOOP. SO HOWEVER WE DO THIS, WE'VE GOT TO
- 4 PROTECT THE ADVOCATES. AND I, FOR ONE, TOO AM NOT
- 5 EXCITED ABOUT THE IDEA OF OTHERWISE GRADUATE STUDENTS
- OR PEOPLE WHO MIGHT MAKE OTHER USE OF THE INFORMATION,
- 7 BUT WOULD PREFER TO KEEP IT AT A MORE CLERICAL LEVEL
- 8 UNTIL WE SEE A REAL NEED FOR SOMETHING THAT MAY BE MORE
- 9 DIFFICULT FOR US TO CONTROL.
- 10 SO I COULD SEE CLERICAL SUPPORT THAT SOMEHOW
- 11 WHERE THE EMPLOYMENT IS ARRANGED OR REVIEWED OR SOMEHOW
- 12 CONTROLLED BY THE PRESIDENT'S OFFICE, BUT WHERE IT'S
- 13 LOCAL AND AVAILABLE UP TO THE AMOUNTS YOU SORT OF
- 14 MENTIONED, BUT TO TRY TO KEEP IT AS SIMPLE AND AS WELL
- 15 DEFINED AS POSSIBLE AS WE GET STARTED, AND THEN SEE
- 16 WHAT OTHER NEEDS EVOLVE OVER TIME AND HOW WE MIGHT
- 17 ADDRESS THOSE WHEN THEY COME UP.
- 18 CHAIRPERSON LANSING: ALL RIGHT. TINA, YOU
- 19 WANTED TO GO, AND THEN I'LL GO LAST, I GUESS.
- 20 DR. NOVA: I DEFINITELY AGREE WITH ALL THE
- 21 COMMENTS THAT HAVE BEEN MADE. I THINK IT'S BEEN
- 22 SUMMARIZED WELL BY EVERYONE, JUST FINDING A MECHANISM,
- AND I CERTAINLY SUPPORT IT A HUNDRED PERCENT,
- 24 ESPECIALLY FOR PEOPLE LIKE JOAN THAT HAVE SOME PHYSICAL
- 25 ISSUES ON TOP OF EVERYTHING ELSE SHE HAS TO DO.

- 1 ONE THING THAT HAPPENED IN THE PREPARATION OF
- 2 THIS PHONE CALL THAT WAS SAID IN THE PREP CALL WAS THAT
- 3 SOME PEOPLE WANTED THIS PERSON TO BE TECHNICAL AND
- 4 TO -- THAT DIDN'T COME UP IN THIS CALL, BUT IT CAME UP
- 5 IN A PRECALL -- THIS PERSON TO BE TECHNICAL AND HELP
- 6 THE PATIENT ADVOCATES OUT SCIENTIFICALLY. AND I JUST
- 7 WANTED TO SAY THAT THAT'S SOMETHING I TOTALLY DISAGREE
- 8 WITH BECAUSE THAT HAS TO BE KEPT AT THE COMMITTEE LEVEL

- 17 MR. SERRANO-SEWELL: AND THEN YOU CAN DO YOUR
- 18 SUMMARY. THAT IS, EVERYONE HAS GOT A DIFFERENT IDEA
- 19 ABOUT WHAT'S THEIR ROLE. AND RICHARD MURPHY'S FIRST
- 20 COMMENT, THAT THIS IS A VOLUNTEER EFFORT, IS TOTALLY
- 21 IMPORTANT BECAUSE THROUGH ALL THE GRIEF AND HEADACHE
- THAT COMES ALONG WITH THIS JOB, I SIGNED UP FOR IT. I
- 23 WAS THE ONE KNOCKING ON THE LIEUTENANT GOVERNOR'S
- 24 OFFICE SAYING APPOINT ME, APPOINT ME. SO, YOU KNOW,
- 25 YOU HAVE TO TAKE IT IN THAT LIGHT, IN MY OPINION.

- 1 AND SO I THINK CLAIRE HAS GOT AN INTERESTING
- 2 IDEA IN THAT WE OUGHT TO LOOK AT OTHER MODELS. I THINK
- 3 HAVING THE BUCK STOP AT THE PRESIDENT'S OFFICE IN TERMS
- 4 OF STAFFING AND RESPONSIBILITIES AND DELEGATION OF
- 5 AUTHORITY, THAT ALL OUGHT TO EMANATE FROM THE
- 6 PRESIDENT'S OFFICE BECAUSE IF WE DO HAVE A STAFF
- 7 PERSON, WHICH IS WHAT I'M LEANING TOWARD NOW, NOT A
- 8 TEMPORARY PERSON, NOT A TEMP PERSON, BUT SOMEBODY ON
- 9 STAFF WHO'S RESPONSIBLE FOR, ONCE WE OUTLINE WHAT THESE
- 10 RESPONSIBILITIES WILL BE FOR, I THINK THAT'S IMPORTANT.
- 11 AND IT SENDS A STRONG SIGNAL TO THE PUBLIC THAT WE CARE
- 12 ABOUT THE WORK THAT HAPPENS AND WE WANT THE PATIENT
- 13 ADVOCATES TO BE SUPPORTED.
- 14 NO ONE IS GOING TO GO ON RECORD AND SAY WE
- 15 DON'T WANT THE PATIENTS TO BE SUPPORTED BECAUSE THAT'S
- 16 JUST BAD POLITICS. BUT THERE IS A NEED. AND, SHERRY,
- 17 WHAT DO YOU THINK?
- 18 CHAIRPERSON LANSING: I WAS SAVING MY
- 19 COMMENTS FOR LAST, AND THEN I'LL GO TO THE PUBLIC
- 20 BECAUSE I KNOW JOHN SIMPSON WANTS TO SPEAK.
- 21 FIRST, LET ME SAY FOR THE RECORD THAT I AM
- 22 EXTRAORDINARILY SYMPATHETIC TO THE NEEDS OF THE HEALTH
- 23 OF THE PATIENT ADVOCATES. I FEEL THAT, IN ADDITION TO
- 24 THE INCREDIBLE BURDEN OF WORK THAT THEY HAVE, AS TINA
- 25 SAID, SOME ARE ALSO SUFFERING FROM PHYSICAL

- 1 DIFFICULTIES, WHICH MAKES IT EVEN MORE STRESSFUL AND
- 2 DIFFICULT TO DO THEIR JOB. I THINK THAT THE PATIENT
- 3 ADVOCATES, I EXCLUDE MYSELF FROM THIS, HAVE BEEN
- 4 EXTRAORDINARY. AND I AM ALL FOR THIS; HOWEVER, I WANT
- 5 TO TELL YOU WHAT I'M WORRIED ABOUT.
- 6 PERCEPTION IS REALITY UNFORTUNATELY, AND I
- 7 DON'T WANT IT TO LOOK LIKE IN ANY WAY THE PATIENT
- 8 ADVOCATES ARE TRYING TO GET THINGS THAT OTHER PEOPLE
- 9 AREN'T GETTING. AND SO FOR ME THE VERY, VERY FIRST
- 10 THING WE HAVE TO DO, WHICH I DO NOT THINK WE'VE DONE,
- 11 IS ACTUALLY DEFINE WHAT THE PATIENT ADVOCATES WANT.
- 12 MAYBE THERE HAVE BEEN INFORMAL CONVERSATIONS. I
- 13 HAVEN'T BEEN PART OF THEM, AND I'M A PATIENT ADVOCATE.
- MR. SERRANO-SEWELL: NOR HAVE I.
- 15 CHAIRPERSON LANSING: OKAY. SO THERE YOU GO.
- 16 SO I THINK THAT, YOU KNOW, WE NEED TO ASSIGN, YOU KNOW,
- 17 WHETHER IT'S ZACH, WHETHER IT'S BOB, WHETHER IT'S
- 18 CLAIRE, MAYBE IT SHOULD BE JUST A KIND OF OBJECTIVE
- 19 PERSON, TO REALLY GO AROUND AND TALK BECAUSE I ALSO
- 20 THINK THAT THE NUMBER WILL BE SMALLER THAN WE
- 21 ANTICIPATE. I DON'T THINK IT IS, AS BOB SAID, FOR ALL
- 22 EIGHT PEOPLE. I THINK THAT SOME PEOPLE ARE FORTUNATE
- 23 ENOUGH TO HAVE SUPPORT STAFF EVEN THOUGH THEY'RE NOT
- 24 PART OF AN INSTITUTION.
- 25 SO I'D LIKE TO KNOW, A, WHAT IT IS THAT

- 1 EVERYBODY THINKS THEY NEED, DEFINE THE JOB FIRST, FIND
- 2 OUT HOW MANY PEOPLE ACTUALLY WANT IT, AND THEN SEE WHAT
- 3 KIND OF MODELS WE'RE TALKING ABOUT. IF SOMEONE WAS
- 4 SAYING YOU HAVE TO MAKE A DECISION TODAY, I WOULD SAY
- 5 HIRE ONE STAFF PERSON FOR ALL THE PATIENT ADVOCATES WHO
- 6 IS RESPONSIBLE. AND MY FEELING IS THAT WOULD GO A LONG
- 7 WAY TO HELPING US. YOU KNOW, WE ALL WORK PRETTY WELL
- 8 TOGETHER, AND THERE'S NO REASON WHY THOSE OF US THAT
- 9 ARE ON THE SCIENTIFIC GRANT COMMITTEE CAN'T SAY, OKAY,
- 10 THIS IS WHEN WE'RE HAVING OUR MEETING WITH THE STAFF
- 11 PERSON. I'M NOT READY TO SAY THAT YET BECAUSE I DON'T
- 12 FEEL I HAVE ENOUGH INFORMATION.
- 13 MR. KLEIN: SHERRY, THIS IS BOB. I WOULD
- 14 AGREE WITH YOU. I'VE TALKED TO, I THINK, THE FOUR OR
- 15 FIVE THAT THIS WOULD ADDRESS, AND I CAN GET YOU A
- 16 SUMMARY FROM -- I THINK THE COMMITTEE NEEDS TO GET AT
- 17 ITS NEXT MEETING A SUMMARY OF WHAT THEY NEED BECAUSE
- 18 THAT'S WHY IT'S UP TO 20 HOURS BECAUSE WITH SOME PEOPLE
- 19 IT'S FOUR HOURS AND SOME PEOPLE IT'S 20 AND SOME PEOPLE
- 20 IT'S IN BETWEEN. THEY HAVE DIFFERENTIAL NEEDS. SO WE
- 21 CAN CERTAINLY GET THAT PUT DOWN AS A SUMMARY.
- 22 CHAIRPERSON LANSING: I THINK IT'S MORE THAN
- 23 THAT, BOB, IF I MIGHT SAY SO. I MEAN BECAUSE I
- 24 THINK -- THE ONLY PERSON I'VE TALKED TO A LITTLE BIT
- 25 ABOUT THIS IS JOAN, BUT IT'S BEEN VERY LITTLE, TO BE

- 1 HONEST WITH YOU, AND A LITTLE BIT TO JEFF, VERY LITTLE.
- 2 AND I THINK, YOU KNOW, WHETHER THE PATIENT ADVOCATES
- 3 KIND OF SIT DOWN THEMSELVES AND REALLY REALISTICALLY
- 4 TALK ABOUT IT, WHETHER SOMEBODY, YOU KNOW, THAT'S
- 5 OUTSIDE OF THE OFFICE KIND OF DOES A SUMMARY AND COMES
- 6 BACK, AND THEN I THINK, YOU KNOW, A LOT OF IT IS HOW
- 7 MUCH IS IT GOING TO COST BECAUSE WE'RE VERY MINDFUL.
- 8 YOU KNOW, IF, IN FACT, IT WAS \$200,000, I HAVE TO SAY
- 9 THAT WOULD BE AN ENORMOUS NUMBER THAT WOULD BE A RED
- 10 FLAG THAT WOULD JUST MAKE THE PATIENT ADVOCATES
- 11 INADVERTENTLY LOOK BAD. SO THEN I WOULD SAY, "WELL,
- 12 WAIT A MINUTE. LET'S FIGURE THIS OUT." DO YOU KNOW?
- 13 SO I WOULD LIKE SUGGESTIONS AS TO HOW WE GET
- 14 INPUT FROM ALL THE PATIENT ADVOCATES, HOW WE ACTUALLY
- 15 FIND HOW MANY PEOPLE WANT IT, HOW MANY PEOPLE ARE GOING
- 16 TO USE IT, AND WHAT WE REALLY THINK. MY INITIAL
- 17 TENDENCY IS TO THINK WE NEED A STAFF -- MAYBE WE CAN
- 18 GET IT FUNDED FROM OUTSIDE. I MEAN THAT'S ANOTHER
- 19 THING, DEPENDING ON HOW MUCH IT IS. SO I JUST DON'T
- 20 HAVE ENOUGH INFORMATION TODAY, AND I DON'T WANT THIS TO
- 21 DRAG ON BECAUSE I THINK THE SENSE OF THE GOVERNANCE
- 22 COMMITTEE IS WE WANT TO DO SOMETHING, BUT WE DON'T YET
- 23 HAVE ENOUGH INFORMATION TO KNOW WHAT TO DO.
- MR. SERRANO-SEWELL: SHERRY, LET ME ADD THAT
- 25 I WOULD AT THIS POINT RECOMMEND THAT WE ASK THE

- 1 PRESIDENT, OUR CHIEF EXECUTIVE, ZACH HALL, TO LOOK INTO
- 2 THIS AND COME BACK WITH SOMETHING EITHER TO YOU OR TINA
- 3 AND SORT OF TAKE IT FROM THERE. BUT IN TERMS OF DOING
- 4 THE DUE DILIGENCE AND GATHERING THE INFORMATION, I'D
- 5 LIKE ZACH TO DO THAT. ZACH IS ACCOUNTABLE TO THIS
- 6 GOVERNANCE WORKING GROUP, AND HE'S ALSO ACCOUNTABLE AS
- 7 AN ADMIRABLE EMPLOYEE AT THE INSTITUTE. SO I WANT TO
- 8 BE VERY CLEAR THAT I THINK IT'S A RESPONSIBILITY
- 9 THAT -- TASK THAT ZACH SHOULD TAKE UP.
- 10 DR. HALL: I'D BE HAPPY TO DO THAT, DAVID, IF
- 11 THE COMMITTEE WISHES ME TO.
- 12 CHAIRPERSON LANSING: IS THERE ANY -- I'M
- 13 VERY COMFORTABLE WITH THAT. IS THERE ANYBODY -- IT
- 14 SHOULDN'T BE A PATIENT ADVOCATE. THAT'S ALL I KNOW.
- 15 SO THE QUESTION IS IS THERE ANY OTHER -- ANYBODY ELSE
- 16 THAT ANYBODY WANTS TO DO IT, YOU KNOW, WHATEVER?
- 17 DR. HENDERSON: NO. I THINK THAT'S
- 18 APPROPRIATE.
- 19 CHAIRPERSON LANSING: THEN I DON'T NEED A
- 20 VOTE, BUT LET ME JUST SEE IF I CAN -- I'M GOING TO GO
- 21 BACK TO THE PUBLIC FOR ONE SECOND. BUT THE SENSE OF
- 22 OUR COMMITTEE, THEN, LET ME JUST SAY IT, AND THEN I
- 23 WANT THE PUBLIC COMMENT. THE SENSE OF OUR COMMITTEE IS
- 24 THAT WE WISH TO DO SOMETHING TO HELP THE PATIENT
- 25 ADVOCATES, BUT WE NEED TO HAVE MORE INFORMATION ON

- 1 EXACTLY WHAT IT IS, THE DEFINITION OF WHAT WE'RE ASKING
- 2 FOR, WHO'S GOING TO BE USING IT, WHAT IT'S GOING TO BE
- 3 DOING, AND HOW MUCH IT'S GOING TO COST. AND THEN WE
- 4 WILL DISCUSS IT SOME MORE AT ANOTHER GOVERNANCE
- 5 COMMITTEE MEETING BEFORE WE BRING IT TO THE BOARD.
- THAT'S WHAT I'M SAYING. SO NOW LET ME TURN
- 7 TO THE PUBLIC AS WELL AS ANYBODY WHO'S A BOARD MEMBER
- 8 WHO WISHES TO TALK. AND JOHN HAS BEEN VERY PATIENT
- 9 WAITING IN L.A., SO, JOHN, I'LL START WITH YOU.
- 10 MR. SIMPSON: VERY QUICKLY. IT MAKES PERFECT
- 11 SENSE TO ME. I WOULD JUST THROW OUT ONE OTHER THOUGHT,
- 12 AND THAT IS THE FOLLOWING. IT MAY BE THAT PART --
- 13 EVERYONE WANTS THE PATIENT ADVOCATES TO GET THE SUPPORT
- 14 THEY NEED. PART OF THE PROBLEM MAY BE THAT THERE ARE
- 15 SO FEW PATIENT ADVOCATES AND SO MANY MEETINGS THAT THEY
- 16 ARE INVOLVED IN, THAT SORT OF SECRETARIAL SUPPORT IS
- 17 NOT WHAT'S NECESSARY. WHAT MAY BE THAT IS REALLY
- 18 NEEDED IS THE ABILITY FOR THEM, LIKE SOME OF THE
- 19 INSTITUTIONAL REPRESENTATIVES, TO BE ABLE TO APPOINT A
- 20 DESIGNEE TO GO TO A MEETING WHEN THEY CANNOT ATTEND.
- 21 AND IT MAY BE THAT THAT IS REALLY WHAT IS AT THE HEART
- 22 OF IT HERE. AND EVEN WITH APPROPRIATE ASSISTANCE, THEY
- 23 STILL WOULD BE OVERWHELMED WITH THEIR COMMITMENT. IT
- 24 MAY BE THAT A LOOK AT THE BYLAWS THAT WOULD PROVIDE FOR
- 25 A DESIGNEE TO SERVE AT CERTAIN TIMES WOULD SOLVE A LOT

- 1 OF THIS SOMETIMES. THANK YOU.
- 2 MR. KLEIN: JOHN, THIS IS BOB KLEIN. JAMES
- 3 HARRISON HAS LOOKED AT THIS AS WELL AS SOME OF THE
- 4 OTHER ATTORNEYS THAT WORKED WITH ME IN DRAFTING THE
- 5 INITIATIVE. AND THERE'S STATE LAW PROBLEMS WITH
- 6 INDIVIDUALS HAVING A SUBSTITUTE OR REPLACEMENT EXCEPT
- 7 WHERE THEY HAVE AN EXPERT ROLE AS IN PEER REVIEW. BUT
- 8 JAMES HARRISON, I THINK, COULD BE HELPFUL IN DOING A
- 9 MEMO THAT ADDRESSES THIS. IT'S POSSIBLE THAT IN
- 10 LEGISLATIVE ENHANCEMENTS THAT WE CAN ADDRESS THIS, BUT
- 11 I THINK WE NEED JAMES HARRISON TO DO -- TO SUMMARIZE
- 12 THE PRIOR DISCUSSIONS I'VE HAD WITH HIM, SHERRY, AND
- 13 I'M HAPPY TO TALK TO JAMES ABOUT GETTING THAT DONE.
- 14 CHAIRPERSON LANSING: CAN YOU GET IT TO JOHN?
- 15 I'D LIKE TO SEE IT TOO BECAUSE THIS IS SOMETHING THAT
- 16 I'VE ASKED ABOUT. AND I KNOW ALL THE REASONS WE CAN'T,
- 17 BUT WHY DON'T YOU JUST SEND IT TO ALL OF US ON THIS
- 18 GOVERNANCE COMMITTEE SO WE CAN LOOK AT IT AS WELL.
- 19 MR. KLEIN: OKAY.
- 20 MR. SIMPSON: YOU'RE AT THE POINT, THOUGH,
- 21 WHERE WOULD YOU'RE CLOSE TO BEING ABLE TO HAVE
- 22 LEGISLATIVE AMENDMENTS --
- 23 CHAIRPERSON LANSING: YEAH, YOU'RE RIGHT.
- 24 MR. SIMPSON: -- WHICH MAY PROVIDE AN AVENUE
- 25 THAT WOULD BE APPROPRIATE.

- 1 CHAIRPERSON LANSING: THIS IS SOMETHING, YOU
- 2 KNOW, ZACH, WHEN YOU DO YOUR COMMITTEE, YOU SHOULD LOOK
- 3 INTO THIS ACTUALLY.
- 4 DR. MURPHY: SHERRY, JUST FOR THE RECORD, I
- JUST WANT TO SAY TO DAVID. DAVID, WITH THE TREMENDOUS
- 6 BURDENS THAT YOU GUYS HAVE, YOU AND THE OTHER PATIENT
- 7 ADVOCATES, IT'S REALLY IMPRESSIVE TO ME THAT YOUR FIRST
- 8 THOUGHT IS WHAT WORKS BEST FOR CIRM AND HOW DO WE
- 9 HANDLE THIS IN AN APPROPRIATE WAY. I JUST WANT TO SAY
- 10 IT'S A PRIVILEGE BEING ON THE COMMITTEE WITH YOU. YOU
- 11 REALLY DO HAVE THE LONG VIEW. THANK YOU.
- 12 CHAIRPERSON LANSING: I DITTO THAT, DAVID.
- 13 IT'S TRUE.
- 14 MR. SERRANO-SEWELL: THANK YOU. THANK YOU.
- 15 CHAIRPERSON LANSING: AND, AGAIN, BECAUSE I'M
- 16 A PATIENT ADVOCATE, BUT TO MY OTHER PATIENT ADVOCATES I
- 17 FEEL THE SAME WAY.
- 18 LET ME GO AROUND. ARE THERE ANY OTHER PUBLIC
- 19 COMMENTS? I DON'T THINK THERE IS ANYBODY ELSE IN THE
- 20 PUBLIC THERE.
- MS. DUROSS: NO. NOT AT CIRM.
- 22 CHAIRPERSON LANSING: ANYPLACE ELSE? I DON'T
- THINK THERE'S ANYBODY ELSE THERE? ARE THERE ANY OTHER
- 24 COMMENTS?
- MR. SERRANO-SEWELL: SHERRY, THIS IS DAVID.

- 1 ONE LAST THING. IF -- YOU CAN SAY YES OR NO. THAT IS,
- WHAT YOU PROPOSE, I WANT TO MAKE ONE SLIGHT SUGGESTION.
- 3 AND THAT IS, THIS COMING BACK TO THE GOVERNANCE
- 4 COMMITTEE, THAT WE DELEGATE TO YOU AND TINA, AS THE
- 5 LEADERSHIP OF THIS COMMITTEE, TO SORT OF WORK OUT THE
- 6 DETAILS WITH ZACH, AND THEN HAVE ZACH MAKE A FORMAL
- 7 PRESENTATION AT THE APPROPRIATE FULL ICOC MEETING. I
- 8 JUST WANT US TO GET ONE SUBCOMMITTEE MEETING, IF THAT'S
- 9 POSSIBLE. IF YOU DON'T THINK THAT'S A GOOD IDEA, THAT
- 10 IT OUGHT TO COME BACK --
- 11 CHAIRPERSON LANSING: I THINK --
- MR. SERRANO-SEWELL: -- PROPOSE, THEN FINE.
- 13 THROUGH TINA, YOU GUYS CAN DO IT.
- 14 CHAIRPERSON LANSING: I THINK THIS IS SUCH A
- 15 HOT-BUTTON ISSUE, THAT WHAT I DON'T WANT TO HAVE
- 16 HAPPEN, I'LL BE HONEST WITH YOU, IS TO HAVE A WHOLE BIG
- 17 DISCUSSION IN PUBLIC ABOUT IT. I'D LIKE TO HAVE THIS
- 18 GOVERNANCE COMMITTEE REALLY WANT IT AND HAVE A
- 19 PROPOSAL. AND THEN WHEN WE GO IN, YOU KNOW, TO THE
- WHOLE BOARD, WE REALLY ARE GOING IN UNIFIED RATHER THAN
- 21 THREE OF US.
- MR. KLEIN: SHERRY, THIS IS IN PUBLIC, BUT
- 23 WHAT YOU'RE SAYING IS IN TERMS OF HAVING -- USING UP A
- 24 LOT OF OUR PUBLIC HEARING IN A WHOLE BOARD DISCUSSION.
- 25 CHAIRPERSON LANSING: YES. I MEAN THIS

- 1 IS -- IN OTHER WORDS, THIS IS WHERE WE THRASH OUT. I
- 2 KNOW THIS IS IN PUBLIC. BUT I MEAN THIS IS WHERE WE
- 3 THRASH OUT EVERYTHING, AND I WOULD HATE TO GO BEFORE
- 4 THE FULL BOARD AND HAVE EVERYTHING BE -- I LIKE IT WHEN
- 5 WE DO IT IN THIS COMMITTEE, DAVID, UNLESS YOU HAVE A
- 6 PROBLEM WITH IT.
- 7 MR. SERRANO-SEWELL: I DON'T.
- 8 MR. KLEIN: I THINK THAT'S A GOOD IDEA,
- 9 DAVID, BECAUSE AT THE BOARD LEVEL, WE DON'T HAVE ENOUGH
- 10 TIME FOR AS THOROUGH A DISCUSSION AS WE CAN DO HERE.
- 11 CHAIRPERSON LANSING: YOU SAID IT BETTER THAN
- 12 I DID, BOB. THANK YOU.
- DR. STEWARD: THIS IS OS. THERE'S JUST ONE
- 14 ISSUE, I GUESS, I'M A LITTLE CONCERNED ABOUT. I THINK
- 15 WE'VE HEARD A CRY FOR HELP HERE. AND JUST BY WAY OF
- 16 THE TIMING, IF WE PUT IT OFF TO THE NEXT GOVERNANCE
- 17 COMMITTEE AND THEN THE NEXT BOARD MEETING AFTER THAT,
- 18 THERE'S A SEVERE DELAY, AND THAT DELAY IS HAPPENING
- 19 DURING A PERIOD WHERE THERE IS A LOT GOING ON.
- 20 CHAIRPERSON LANSING: WELL, I WAS NOT
- 21 SUGGESTING THAT WE PUT IT OFF TO THE NEXT GOVERNANCE
- 22 COMMITTEE. I WAS ACTUALLY GOING TO END IT BY SAYING
- 23 THAT I HOPE THAT IN THE FIRST WEEK OR SECOND WEEK IN
- 24 JANUARY WE COULD HAVE ANOTHER GOVERNANCE COMMITTEE JUST
- 25 TO ADDRESS THIS. AND THEN OUR NEXT BOARD MEETING IS --

- 1 DR. HENDERSON: FEBRUARY.
- 2 CHAIRPERSON LANSING: WELL, THERE'S NO
- 3 JANUARY MEETING.
- 4 MR. KLEIN: SHERRY, ON AN INTERIM BASIS, I
- 5 THINK ZACH HAS IMPLEMENTED USING A TEMP SERVICE. AND
- 6 SO TO THE EXTENT WE CAN DO THAT. IN ADDITION, KATE
- 7 SHREVE, WHO IS STILL AROUND THROUGH DECEMBER; IS THAT
- 8 RIGHT, ZACH?
- 9 DR. HALL: NO. SHE SAID THE 15TH, BOB.
- 10 MR. KLEIN: BUT IN TERMS OF MY UNDERSTANDING
- 11 IS THAT YOU'RE PREPARED TO HAVE A TEMP SERVICE --
- 12 CHAIRPERSON LANSING: ABSOLUTELY.
- MR. KLEIN: -- ON AN INTERIM BASIS.
- 14 CHAIRPERSON LANSING: ABSOLUTELY.
- 15 DR. HALL: WE HAVE ALREADY CONTACTED A
- 16 SERVICE IN HEALDSBURG, AND WE HAVE TOLD JOAN THAT WE
- 17 WOULD PROVIDE HELP FOR HER BEFORE THE NEXT GRANTS
- 18 WORKING GROUP MEETING AND BEFORE THE ICOC MEETING. SO
- 19 WE WILL GO AHEAD AND TRY TO IMPLEMENT THAT.
- 20 MR. KLEIN: BUT THAT WOULD APPLY TO JEFF
- 21 SHEEHY OR OTHER MEMBERS OF THE PATIENT ADVOCATES AS
- WELL; IS THAT RIGHT?
- 23 DR. HALL: WE COULD DO THAT IF YOU WOULD LIKE
- 24 US TO.
- 25 CHAIRPERSON LANSING: I THINK WE SHOULD. IT

- 1 CAN'T BE THAT MUCH FOR A TEMP SERVICE FOR THE NEXT
- 2 EIGHT WEEKS, IF WE NEED IT. YOU KNOW, WE'LL SEE.
- 3 DR. HALL: OKAY. ALL RIGHT. I WILL --
- 4 CHAIRPERSON LANSING: YOU FEEL IT'S GETTING
- 5 OUT OF HAND --
- DR. HALL: WE WILL COME UP WITH SOME INTERIM
- 7 PLAN, AND THEN WE WILL GO AHEAD AND GATHER INFORMATION
- 8 AND COME BACK WITH A MORE FULLY DEVELOPED PLAN FOR YOU.
- 9 CHAIRPERSON LANSING: WE CAN -- ON TEN DAYS
- 10 NOTICE, WE WON'T WAIT FOR THE NEXT GOVERNANCE. WE'LL
- 11 JUST HAVE A MEETING ON THIS SPECIFIC ISSUE. SO
- 12 SOMETIME, LET'S JUST SAY, YOU KNOW, I'M MAKING THIS UP,
- 13 YOU KNOW, AFTER THE HOLIDAYS, NO LATER THAN THE MIDDLE
- 14 OF JANUARY. THAT'S A GOAL.
- DR. HALL: WE HAVE A REVIEW MEETING 8 TO 10,
- 16 JANUARY 8 TO 10 IS THAT BIG REVIEW MEETING, SO MAYBE A
- 17 LITTLE BIT AFTER THAT WE CAN HAVE THAT INFORMATION AND
- 18 HAVE A PLAN FOR YOU.
- 19 CHAIRPERSON LANSING: GREAT. DAVID, I THINK
- 20 IT'S VERY IMPORTANT THAT YOU, WHO HAVE BEEN INCREDIBLY
- 21 BURDENED, AND JOAN, THAT WE GIVE JOAN THE MESSAGE AS
- WELL AS JEFF, THAT WE INTEND TO DO SOMETHING ABOUT IT.
- 23 AND WE WANT TO ACT QUICKLY, AND WE'RE EXTREMELY MINDFUL
- OF YOUR INCREDIBLE PUBLIC SERVICE, AND THAT WE WILL BE
- 25 ADDRESSING IT, HOPEFULLY, BY THE MIDDLE OF JANUARY.
