12	SO THE OUTCOME AND THE RECOMMENDATIONS
13	FROM THE GRANTS WORKING GROUP ARE AS FOLLOWS: THERE
14	WERE TWO APPLICATIONS, ONE TRAN AND ONE DISC, THAT
15	FELL INTO THE RECOMMENDED FOR FUNDING RANGE. AND SO
16	THE TOTAL APPLICANT REQUESTS FOR THOSE TWO
17	APPLICATIONS IS ABOUT 500,000. AND THE FUNDS
18	AVAILABLE OR REMAINING IN THE PROGRAM ARE ABOUT 2.5
19	MILLION.
20	SO THE NEXT SLIDE PLEASE. THE FIRST
21	APPLICATION THAT WAS RECOMMENDED IS TRAN1-11975. SO
22	THIS AN APPLICATION THAT RECEIVED A SCORE OF 85.
23	AND SO THE GOAL OF THIS APPLICATION IS TO TEST A
24	SMALL MOLECULE DRUG CANDIDATE, WHICH IS BERZOSERTIB.
25	AND SO THIS SMALL MOLECULE THAT HAS THE POTENTIAL TO

1	BLOCK A CRITICAL STEP IN VIRAL REPLICATION AND
2	POTENTIALLY BLOCK VIRAL GROWTH AND ULTIMATELY IN
3	THIS WAY PROTECTING LUNG PROGENITOR CELLS. AND SO
4	THAT'S THE TRAN1 PROJECT.
5	THERE'S A DISCOVERY PROJECT, 11838. AND
6	SO THAT ONE IS DEVELOPING QUITE A UNIQUE VACCINE
7	BIOLOGIC. THE GOAL OF THIS ONE IS TO CREATE AN
8	ARTIFICIAL ANTIGEN PRESENTING CELL. SO THIS IS A
9	BIOMATERIAL PLATFORM ESSENTIALLY, AND IT HAS SEVERAL

12	THE CENTER FOR THE STUDY OF LATINO HEALTH AND
13	CULTURE, THAT DID A STRATIFICATION BY RACE,
14	ETHNICITY, AND AGE FOR PEOPLE OVER THE AGE OF 65.
15	NON-HISPANIC WHITES DEATH RATE WAS 10.4, FOR
16	HISPANIC IT WAS 18.6, FOR BLACK NON-HISPANIC IT WAS
17	31.3, AND FOR ASIAN NON-HISPANIC 16.4.
18	FOR THOSE BETWEEN THE AGES OF 50 AND 64,
19	FOR WHITE NON-HISPANIC IT WAS 1.4 AND FOR HISPANICS
